**RESOLUTION:** Authorize a Criminal Justice System Study and transfer \$78,185 from the General Contingency Fund to the Professional Services Account of the Sheriff's 2010 Budget to Pay for the Study

11 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

12 **WHEREAS**, the Winnebago County Jail was built and went into operation in  
13 2003 with maximum a capacity of 347 inmates; and

14 **WHEREAS**, in 2007 Sheriff Brooks began discussions with the County Board  
15 about future jail bed needs; and

16 **WHEREAS**, the possibility of a regional jail involving Calumet County,  
17 Outagamie County and Winnebago County was discussed but failed to gather support  
18 from all three counties; and

19 **WHEREAS**, the Winnebago County Board Chairman approved the forming of the  
20 Criminal Justice Study Committee to select a qualified consultant to review the current  
21 Winnebago County Criminal Justice System; and

22 **WHEREAS**, the Criminal Justice Study Committee unanimously recommends  
23 that Kimme & Associates conducts the study at the cost of \$97,290; and

24 **WHEREAS**, the Sheriff's Office currently has \$19,105 budgeted that was  
25 earmarked for the Regional Jail study that never materialized.

26 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of  
27 Supervisors that it hereby appropriates \$78,185 from the general contingency fund to  
28 the professional services account of the Sheriff Office 2010 budget for the purpose of  
29 funding a criminal justice system study.

1 **Fiscal note:** This will reduce the general contingency fund balance to \$94,915.  
2 The contingency fund began the year with a balance of \$200,000.
