3                           **RESOLUTION:** Authorize the District Attorney's Office  
4   to Accept a Safe Streets Misdemeanor  
5   Drug Diversion Program Grant of  
6   \$80,000 and Apply Funds Plus \$50,000  
7   of Fee Revenue to Various Expense  
8   Accounts of District Attorney's Office  
9   and Human Services Department's  
10    2010 Budgets to Carry Out the  
11    Programs Objectives

14   **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

15           **WHEREAS,** the District Attorneys office has been awarded a Safe Streets  
16   Misdemeanor Drug Diversion grant of \$80,000 to carry out a drug diversion program;  
17   and

18           **WHEREAS,** the program is expected to generate \$50,000 in fee revenues; and

19           **WHEREAS,** a Wisconsin Drug Threat Assessment performed in 2002 revealed  
20   that there is an increased availability and use of drugs in Wisconsin; and

21           **WHEREAS,** the drug arrest rate is higher in Wisconsin than the national average;  
22   and

23           **WHEREAS,** Winnebago County has seen an influx of drug-related activity over  
24   the past 7 years; and

25           **WHEREAS,** a recent report from the Lake Winnebago Area Metropolitan  
26   Enforcement Group (MEG) has demonstrated an increase in drug-related activity; and

27           **WHEREAS,** the District Attorney's office will be contracting with the Human  
28   Services Department to assist in carrying out the objectives of the Safe Streets  
29   Program.

30           **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of  
31   Supervisors that it hereby authorizes the District Attorney's Office to accept an \$80,000

1 Safe Streets Misdemeanor Drug Diversion Grant, and appropriates the funds along with  
2 expected fee revenues of \$50,000 to expense accounts in the District Attorney and  
3 Human Services 2010 budgets to carry out the programs objectives (see attached  
4 budget transfer form for line items affected).

5 ***Fiscal note:*** This resolution is cost neutral. Program expenses will be  
6 covered by the grant and fee revenues generated.
