3 **RESOLUTION: Authorize the Child Support Agency to**  
4 **accent grant funds of \$48,105 and**  
5 **appropriate the funds to equipment**

9 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

11 **WHEREAS**, the Wisconsin State Bureau of Child Support has been granted funding  
12 through the American Recovery and Reinvestment Act of 2009 (ARRA) and have proportioned  
13 part of those funds to Winnebago County.  
14

15 **WHEREAS**, the Winnebago County Child Support Department has been allotted  
16 \$48,105 of this funding to upgrade and replace office furnishings and automation equipment;  
17 and

19 **WHEREAS**, the first portion of the funding in the amount of \$25,085 will be used for  
20 imaging, scanning, and filing systems software for files contained within the agency; and  
21

22 **WHEREAS**, the second portion of the funding in the amount of \$23,020 will be used for  
23 the replacement of office chairs, printers, and a shredder; and  
24

25 **WHEREAS**, it would be in the best interests of the citizens of Winnebago County that  
26 the Winnebago County Child Support Department accept and use these funds as described  
27 above.

29 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of  
30 Supervisors that it hereby authorizes the Winnebago County Child Support Agency to accept  
31 grant funds of \$48,105 from the State of Wisconsin and appropriate the funds to expenses as  
32 described above and as outlined on the attached budget transfer form.
