2 **RESOLUTION: Adopt a Public Participation Plan for the**
3 **Preparation, Review, and Adoption of a**
4 **Farmland Preservation Plan for**
5 **Winnebago County**

8 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**
9

10 **WHEREAS**, Winnebago County is involved in developing a County-wide farmland preservation
11 plan pursuant to the requirements of Chapter 91, Wis Stats; and
12

13 **WHEREAS**, such plan is to be included in Winnebago County’s comprehensive plan, which was
14 adopted on March 21, 2006; and
15

16 **WHEREAS**, the procedures under § 66.1001(4), Wis Stats, must be followed in the adoption of a
17 comprehensive plan or subsequent amendments thereto; and
18

19 **WHEREAS**, a provision in § 66.1001 (4), Wis Stats, requires the governing body of a local
20 governmental unit (town, city, village, county) to adopt written procedures (“public participation plan”) that
21 are designed to foster public participation, including open discussion, communication programs,
22 information services, and public meetings for which advance notice has been provided, in every stage of
23 the preparation of a comprehensive plan; and

25 **WHEREAS**, the Winnebago County Board of Supervisors adopted a public participation plan on
26 September 23, 2003, that was used in the preparation of the County-wide comprehensive plan; and
27

28 **WHEREAS**, the Winnebago County Planning and Zoning Committee has recommended the
29 adoption of a subsequent public participation plan that specifically relates to the preparation, review, and
30 adoption of a farmland preservation plan for Winnebago County; and
31

32 **WHEREAS**, such plan is entitled “Public Participation Plan for the Preparation, Review, and
33 Adoption of a Farmland Preservation Plan for Winnebago County” and is attached hereto and
34 incorporated herein by reference.

36 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors that, in
37 accordance with § 66.1001(4), Wis Stats, it hereby adopts the public participation plan entitled “Public
38 Participation Plan for the Preparation, Review, and Adoption of a Farmland Preservation Plan for
39 Winnebago County,” attached hereto, and incorporated herein by reference.
