### WINNEBAGO COUNTY BOARD ADJOURNED SESSION TUESDAY, MAY 18, 2010

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

The following Supervisors were present: Konetzke, Barker, Eisen, Ramos, Miller, Roh, Smith, Widener, Hamblin, Albrecht, Gabert, Swanson, Thompson, Lennon, Reynolds, Hall, Wingren, Jacobson, Norton, Warnke, Robl, Eichman, Neubauer, Kline, Locke, Hegg, Finch, Sievert, Farrey, Diakoff, Brennand, Egan, Ellis, Rengstorf and Reinert.

Motion by Supervisor Robl and seconded to adopt tonight's amended agenda. Supervisor Kline withdrew Resolution Nos. 47-52010, 48-52010 & 49-52010. CARRIED BY VOICE VOTE (Supervisor Hall voted nay).

### **PUBLIC HEARING**

Sarah Sitzman, attorney for Frederick G. Van Handel, spoke in support of Resolution No. 25-52010, "Cancel Certificates – Town of Rushford, Winnebago County, Wisconsin."

### COMMUNICATION, PETITIONS, ETC.

Notice of Claim from Melissa Campshire for damage to her vehicle caused by an accident with a county employee's vehicle was referred to the Personnel & Finance Committee.

Petition for amendment from Gary & Mary Van Linn, Town of Neenah, for zoning change for tax parcel no. 010-0092-11 from R-1 to R-2 for a single family residence was referred to the Planning & Zoning Committee.

Petition for Zoning Amendment from Shannon Zambrano, Town of Menasha, for zoning change for tax parcel no. 008-0456-01-02 from R-1 to R-2 for a residential home was referred to the Planning & Zoning Committee.

### REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Finch reported that in commemoration of the filming of the movie "Public Enemy" in various parts of Winnebago County and specifically on the WIOUWASH Trail, there will be a dedication ceremony on May 27 at 10:45 a.m. in the Town of Clayton.

Supervisor Norton reported on his attendance at the Wisconsin Counties Human Services Association Spring Conference entitled, "Positive Partnerships for Progress". At one of the general sessions, Charles Zunger from the Pennsylvania Child and Youth Administration Association, asked that everyone encourage their federal legislators to restore the 2009 Partnership Act/HR 332 which established a national commission on intergovernmental cooperation. Supervisor Norton also noted that WCA attorney Andrew Phillip spoke at the conference about the importance of counties expanding their collaboration beyond nursing homes and family care services to areas such as highways and jails.

Supervisor Barker reported on her attendance at the Lake Winnebago Land & Water Conservation Association Spring meeting and a presentation given by Nelson & Paade, Inc. on "greenhouse integrated soilless systems". Representatives from Nelson & Paade, a Waushara County business, explained how a greenhouse integrated soilless system combines raising fish and plants into one system by raising the fish in the lower level of the system and plants in the upper level. Supervisor Barker reported that Mr. Pat Dixon of Shoreline Landscaping discussed storm water runoff management at the meeting as well.

Supervisor Barker reported that the Glacier Land Resource and Conservation Development Committee will be putting together workshops on alternatives to oil and solar panel promotion at the Outagamie County Airport.

Supervisor Eisen reported on his attendance at the UW Extension's workshop on local government officials in DePere on May 12. He stated it was an excellent program and presented information on, "county government structure and process, open meetings laws, budgetary concerns, ethics and conflicts of interest..." Supervisor Eisen reported that county levy rate limits was also explained and discussed.

Supervisor Rengstorf asked that the Board read the brochure on their desk from Critter's Sports. He explained that it's from Douglas Nelson, co-owner of Critter's Sports, and gives the Board some additional information about the business that benefited from a loan they received from the county's Industrial Development Board.

Supervisor Kline reported that the Legislative Committee will be meeting on Monday, May 24 at 8:30 a.m. at the James P. Coughlin Center.

Motion by Supervisor Widener and seconded to approve the proceedings from the April 20 & 27, 2010 County Board meetings. CARRIED BY VOICE VOTE.

#### **COUNTY EXECUTIVE'S REPORT**

County Executive Harris explained that he was distributing copies of Page 27 from the 2010 County Budget to show the Board how the county's total spending had decreased last year while the tax levy had increased. He was giving them this information because of reactions he had from Board members after his report at the April 27, 2010 meeting.

Executive Harris made the following points about Sheriff Brooks' jail study report at the May 4 County Board meeting;

- If the legal capacity for inmates at the jail is exceeded, the county would need to house those inmates in another county. The cost to do that would be substantial and would cost the county up to \$68 per inmate per day. Medical and transportation expenses also would be incurred for these inmates
- Building/renovating costs are not the only thing that needs to be considered when determining the best option.
   Staffing costs must also be taken into consideration.

Executive Harris then discussed county-owned private roads. He explained that before the county had an ordinance regulating this issue, some subdivisions were built with private roads that weren't up to town or county standards. These roads are now in need of expensive maintenance. Executive Harris explained that the county needs to set a policy on how to bring these roads up to town standards so the towns can take over responsibility for them.

Executive Harris stated that because the current landfill is coming to the end of its use, the Solid Waste Management Board will be withdrawing the money that they have in the county's Industrial Development Board loan fund. He explained that this fund helps to retain and grow employment in Winnebago County. The balance in the account is \$1.5 Million, with \$1.2 Million loaned out. Because of the importance of this fund, Executive Harris is hoping that some portion of the county's reserves will be moved to this revolving loan fund to make up for the loss of Solid Waste Management Board monies.

Executive Harris expressed his support of Resolution No. 39-52010, "Appropriate \$90,000 for Design Work to Renovate Space for the Engineering Facility at UW Fox Valley Located at 1655 University Drive". Executive Harris explained the importance of the engineering program at UW Fox Valley and how it helps to keep graduates here in Winnebago County strengthening our workforce.

#### **COUNTY EXECUTIVE'S APPOINTMENTS**

Motion by Supervisor Widener and seconded to approve the following County Executive's appointments:

**Advocap Board of Directors:** Executive Harris asked for approval of his appointment of Supervisors Travis Swanson and Marissa Reynolds and his re-appointments of Supervisors Tom Widener and Mike Norton to the Advocap Board of Directors. Supervisor Swanson will replace James Koziczkowski, whose term expired on April 20, 2010. Supervisor Reynolds will replace Amy Gearhart whose term would have expired on April 19, 2011. Supervisors Swanson, Widener and Norton's terms will expire on April 17, 2012.

**Affirmative Action Commission:** Executive Harris asked for approval of his appointment of Supervisor Bill Roh to the Affirmative Action Commission. Mr. Roh will complete the term of Tena Riste, which will expire on April 19,2011.

**East Wisconsin Counties Railroad Consortium:** Executive Harris asked for approval of his re-appointments of Supervisors Stan Kline and Jef Hall to the East Wisconsin Counties Railroad Consortium. These are two-year terms that will expire on April 17, 2012.

**East Central Wisconsin Regional Planning Commission:** Executive Harris asked for approval of his appointments of Mayor Paul Esslinger, City of Oshkosh, 215 Church Avenue, Oshkosh, to the East Central Wisconsin Regional Planning Commission. Mayor Esslinger will replace Frank Tower, whose term as Oshkosh Mayor has expired.

**FoxComm Fiscal Advisory Board:** Executive Harris asked for approval of his appointments of Patty Francour, Information Systems Director; Supervisor Patrick Brennand and Sheriff Michael Brooks to the FoxComm Fiscal Advisory Board.

**Board of Health:** Executive Harris asked for approval of his appointment of Supervisor Kenneth Neubauer and his reappointment of Supervisors Thomas Egan, Thomas Ellis, Joanne Sievert and Shiloh Ramos to the Board of Health. Supervisor Neubauer will replace James Koziczkowski whose term has expired. These are two-year terms that will expire on April 17, 2012.

**Winnebago County Housing Authority:** Executive Harris asked for approval of his re-appointment of Karen Keller, 560 West Linwood Avenue, Oshkosh, to the Winnebago County Housing Authority. This is a five-year term that will expire on April 21, 2015.

**Human Services Board:** Executive Harris asked for approval of his appointment and re-appointments of James Koziczkowski and Supervisors Hall, Rengstorf and Finch to the Human Services Board. Mr. Koziczkowski will replace Mr. Hall as the citizen appointment. Mr. Koziczkowski's term will expire on December 31, 2012. Supervisor Hall will replace Mr. Koziczkowski as the County Board appointee and his term will expire on December 31, 2011. Supervisor Rengstorf's term will expire on December 31, 2012. Supervisor Finch will replace Donald Griesbach, who resigned from the Board. Supervisor Finch's term will expire on December 31, 2012.

**Industrial Development Board:** Executive Harris asked for approval of his re-appointments of Supervisors Ken Robl, Kathleen Lennon and Tim Hamblin to the Industrial Development Board. These are two-year terms that will expire on April 17, 2012.

**Lakeland Long Term Care District Board:** Executive Harris asked for approval of his reappointment to the Lakeland Long Term Care District Board. This is a three-year term that will expire on April 30, 2013.

**Local Emergency Planning Commission:** Executive Harris asked for approval of his appointments of Tobin Johnson, COO, Utica Energy, LLC, 4995 State Road 91, Oshkosh; Janell Tatro, Utica Energy, LLC, 4995 State Road 91, Oshkosh; and Supervisor Larry Smith to the Local Emergency Planning Commission. Mr. Johnson will replace Steve Clements and Ms. Tatro replaces Dave Oakley as an Alternate. Their terms will expire on December 31, 2011. Supervisor Smith is being re-appointed for a two-year term that will expire on April 17, 2012.

**Solid Waste Management Board:** Executive Harris asked for approval of his re-appointments of Supervisors Ken Robl and David Albrecht and Roger Jaeger to the Solid Waste Management Board. These are three-year terms that will expire on April 16, 2013.

**Tri-County Recreation Association Board of Directors:** Executive Harris asked for approval of his appointment of Supervisor Guy Hegg and his re-appointment of Supervisor Susan Locke to the Tri-County Recreation Association Board of Directors. Supervisor Hegg replaces Tena Riste whose term has expired. These are two-year terms that will expire on April 17, 2012.

Chairman Albrecht reported that he has been told by a constituent that sometimes its hard for people to hear what people are saying at the Board meeting, so we all need to be sure to speak into our microphones.

### **COUNTY BOARD CHAIRMAN'S APPOINTMENTS**

**Criminal Justice Study Committee:** Chairman Albrecht asked for approval of his appointments of Supervisors Harvey Rengstorf, Chuck Farrey, Paul Eisen and himself to the Criminal Justice Study Committee.

**East Central International Trade, Business and Economic Development Council (ITBEC) Board:** Chairman Albrecht asked for approval of his appointment of Supervisor Stan Kline to the ITBEC Board.

Business Committee of the International Trade, Business and Economic Development Council (ITBEC) Board: Chairman Albrecht asked for approval of his appointment of Supervisor Bill Roh to the Business Committee of the ITBEC Board.

Motion by Supervisor Finch and seconded to approve the Chairman's appointments. CARRIED BY VOICE VOTE.

## RUNWAY BROOM AIRPORT CAPITAL PROJECT PRESENTATION – PETER MOLL, MANAGER, WITTMAN REGIONAL AIRPORT

Peter Moll, Wittman Regional Airport Manager, presented information to the Board that describes the runway broom that the airport would like to acquire in 2010. He stated that the current runway broom vehicle that they are using, "has been put together with a number of surplus parts" and the broom was never balanced correctly. The chassis is a 1986 Oshkosh P Series truck that they got from the county Highway Department. The broom and the drive engine are from a former airport vehicle. Mr. Moll explained that there is now a problem with the fuel injection system on the broom's drive engine that will cost at least \$10,000.

Mr. Moll stated that they have budgeted \$650,000 for a new runway broom. However, a Wisconsin Department of Transportation Bureau of Aeronautics program will fund 80% of the project so the county will only spend approximately \$130,000. Mr. Moll explained that to participate in this program, the state will be sending out the Requests for Proposal (RFPs), collect bids and award the project to the lowest bidder.

Mr. Moll explained that the runway broom is used after the runways are plowed and removes any residual snow left by airplanes and snow removal equipment. Using the broom to get down to clear pavement reduces the amount of sand they need to spread on the runway. Mr. Moll explained that sand can cause sever damage to aircraft engines, so using less sand is very important.

Mr. Moll took questions from the Board.

### HEALTH INSURANCE TRENDS - JAN STAGE, ASSOCIATED FINANCIAL GROUP

Karon Kraft, Winnebago County Human Resources Director, introduced Mr. Jan Stage, Vice President, Senior Benefits Consultant of Associated Financial Group to the Board. She explained that Mr. Stage was invited to tonight's meeting in response to requests from a number of supervisors who asked for an annual update on the county's health insurance situation. Ms. Kraft stated that Mr. Stage is the county's contracted health insurance consultant.

Mr. Stage explained the timeline for dealing with the county's health insurance. He stated that the county's health insurance will renew on October 1. They are in the process of requesting renewal information from the county's two current carriers and bids from competing carriers. They anticipate having this information by mid-June.

Mr. Stage then explained the following information that he distributed to the Board:

- The anticipated increase in health care costs as projected by Mercer Health & Benefits, LLC and Hewitt Health Value Initiative is 5.9% to 6%. Mr. Stage explained that these two companies contact employers, not health insurance companies, to see what they anticipate their health care costs to increase. When the health insurance companies are contacted to see what they anticipate the increase to be, they are saying approximately 12%. Mr. Stage explained that the difference between the employers' projection and the insurance companies' projection indicates that employers are looking at making plan changes to keep these increases lower. These changes will include increased deductibles, change to co-pays, etc.
- Mr. Stage presented information on the county's cost of health insurance since 2004. He explained that changes to the county's plans—mostly in the prescription drug area—has caused some of the fluctuation.
  - The average percent of change on the total premiums on all health plans for active employees from 2004-2010 – 7.16%
- Mr. Stage explained that the county's employees have three insurance options:
  - o Plan 1 \$0 deductible
  - o Plan 2 \$200 deductible
  - o Plan 3 \$1,000 deductible
  - Mr. Stage stated that if all the employees would go to Plan 2, the county would save approximately \$1.5 Million
- Mr. Stage reported on new state and federal mandates that will impact health insurance costs:
  - Coverage for the treatment of autism state mandate
  - Coverage for cochlear implants and hearing aids for children under 18 state mandate
  - Enhanced benefits for mental health and addiction federal mandate
  - o Coverage for dependent children until they reach the age of 27 state and federal mandates
  - Estimated load that will be included with these mandates will be 2 to 3 per cent
- Mr. Stage went through the options that are available to the county and their pros and cons:
  - United Health Care UMR (current county provider)
    - Providers are Aurora and Theda Care
    - Best in class discounts
    - Quality service provider
    - Dual carrier option offered as a choice with Network Health Plan
    - Not a good single source option at this time because it does not have a contract with Affinity, which includes Mercy Medical Center

- Network Health Plan (current county provider)
  - Provider is Affinity and Mercy Medical Center
  - Best in class discounts
  - Excellent service provider
  - Dual carrier option offered as a choice with United Health Care.
- Wisconsin Counties Assocation
  - UMR administers their plan
  - Providers are Aurora and Theda Care
  - Best in class discounts
  - Doesn't offer duel carrier option
  - Wouldn't be a replacement for county's UMR plan
- Wisconsin State Program
  - Too expensive
- WPS
  - No best in class discount
  - Not a good option for the county at this time
- o Anthem
  - Not a current provider, but if pricing is competitive, they could be a good option for the county.
  - Providers are Aurora, Theda Care and Affinity
  - Good option for the county to have a single source provider
- o Humana
  - They do not have best in class discount
  - Historically, their bid has come in too high to be an option for the county

Mr. Stage explained that the long-term costs associated with the county's current two options—fully insured (Network) and self funding (UMR)—are similar. However, the cash flow risk is immediate with the UMR plan because claims come in and they must be paid. However, there is a stop gap insurance plan to protect the county from very large claims under the UMR plan.

Mr. Stage then took questions from the Board.

### **RESOLUTIONS AND ORDINANCES**

### ORDINANCE NO. 19-42010: Amend Chapter 7 of the General Code of Winnebago County (Traffic Code)

WHEREAS, the Winnebago County Highway Committee has recommended a variety of amendments to Chapter 7 of the General Code of Winnebago County; and

WHEREAS, said amendments would clarify the existing ordinance as well as raise permit fees so as to reflect actual costs of operation of the Winnebago County Highway Department.

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows: That the following Sections of Chapter 7 of the General Code of Winnebago County be amended to read as follows:

### 7.10 UTILITY PERMITS UPON WINNEBAGO COUNTY TRUNK HIGHWAYS.

- (7) Permit required to install or reinstall or reconstruct utility ...
- (b) Applications for permits to install, reinstall or reconstruct utilities shall be applied for at the Winnebago County Highway Commission, 901 W. County Road Y, Oshkosh, WI, upon forms to be provided by the Winnebago County Highway Commission.
  - (c) Fees for utility permits shall be as follows:

Boring Fee	\$100	0.00
Open Cut Fee	\$500	0.00
Permit to Close Road (per day)	\$300	0.00
Trenching parallel to right-of-way (per lineal foot)	\$	.10

- 1. Definitions:
- a) <u>Boring</u> Where a circular hole is drilled under the road without disturbing the road surface.
- b) Open Cut the cutting of a trench or an opening across a road surface.
- c) <u>Plowing</u> The threading of an electrical or telecommunications line into the soil by the use of a mechanical device specifically designed for that purpose with minimal disturbance to the soil surface.
- (d) Permits shall be issued only in the name of the owner of the property upon which utility installation or reinstallation is to occur.

### Section 7.11 PERMIT FOR OPERATION OF OVERSIZE VEHICLES UPON COUNTY TRUNK.

- (6) <u>Definitions</u> (a) Oversized Vehicle means any vehicle which is over-wide, over-high, over-long or over-weight in contravention of Sections 348.05, 348.06, 348.07 or 348.15, Wisconsin Statutes.
- (b) A fee of \$100.00 shall be assessed by the Highway Commission to those making application for the issuance of a permit for the operation of an overweight, over-height, over-width or over-length vehicle upon Winnebago County Highways.
- (8) <u>DENIAL OF APPLICATION. ...</u>
- (a) When operation of such a vehicle is likely to interfere with the safety of those persons utilizing Winnebago County Trunk Highways. ...
- 7.14 <u>DRIVEWAY ACCESS TO COUNTY TRUNK HIGHWAYS.</u> (1) This Ordinance is adopted pursuant to the authority granted under Sections 59.03 and 66.07(2), Wisconsin Statutes and shall apply to all designated and undesignated County Trunk highways in Winnebago County.
  - (7) PERMIT REQUIRED TO CONSTRUCT OR RECONSTRUCT DRIVEWAY. ....
- (h) A non-refundable charge shall be assessed by the Commission to those making application for the issuance of a permit for the construction or reconstruction of an entrance or departure upon a Winnebago County Trunk Highway. Said fee shall cover the cost of administration and inspection. A charge shall also be assessed for the removal of an illegally placed access. Fees shall be determined using the following schedule:

### RESOLUTION NO. 25-52010: Cancel Tax Certificates – Town of Rushford, Winnebago County, Wisconsin

WHEREAS, sec 75.105(2), Wisconsin Stats., authorizes the governing body of a County to cancel, if desired, all or a portion of the unpaid real estate property taxes for which a tax certificate has been issued, plus interest and penalties on those taxes, if all of the conditions of the attached agreement are met; and

WHEREAS, Frederick G. VanHandel has acquired the real property located in the Town of Rushford, Winnebago County, Wisconsin, which together consists of three parcels on State Rd 116 (parcel numbers 022-0963, 022-0964 & 022-0972); and

WHEREAS, Frederick G. VanHandel has agreed to undertake the remedial action and restore the environment at the property consistent with the requirements of all applicable state and federal laws; and

WHEREAS, Frederick G. VanHandel agrees to maintain and monitor the property as required under DNR rules and any contract entered into under those rules; and

WHEREAS, there are delinquent real estate taxes of \$7,378.89 for the years 1999 through 2009, plus special assessments owed in the amount of \$15.00, and interest of \$4,950.93 (interest figure through May 31, 2010); and

WHEREAS, Frederick G. VanHandel has agreed to pay all future property taxes beginning with the tax year 2010 when due.

# RESOLUTION NO. 44-52010: Authority to Execute 2010-2011 Labor Agreement with Winnebago County Courthouse Employees' Association

BE IT RESOLVED, by the Winnebago County Board of Supervisors, that the County Executive and the County Clerk be, and they hereby are, authorized to execute a two-year Collective Bargaining Agreement on behalf of Winnebago County with the Winnebago County Courthouse Employees' Association, for the years 2010 and 2011, effective January 1, 2010, which Agreement will provide the following major changes from the previous Agreement:

### 1) WAGES

Effective August 1, 2010, a 1.4% across-the-board increase Effective January 1, 2011, a 1.5% across-the-board increase

### 2) ARTICLE XXII – GROUP HEALTH INSURANCE

Effective for the October 1, 2010 premium the County will contribute 85% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Insurance Plan toward each employee's monthly health insurance premium. If an employee and their spouse complete an annual Health-Risk assessment on or before September 1 of each year, the County will contribute 90% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Insurance Plan toward each employee's monthly health insurance premium. The County agrees to maintain the current benefit levels for the duration of the agreement; but reserves the right to change the Group Health Plans as long as benefit levels are maintained.

The County agreed to offer a voluntary employee-paid short-term disability insurance policy and enhanced dental policy at no cost to the County.

### 3) ARTICLE XXI SICK LEAVE

SLIP (Sick Leave Incentive Program) terminates as of December 31, 2009.

#### 1) WAGES

Effective June 1, 2010, a 1.4% across-the-board increase Effective January 1, 2011, a 1.5% across-the-board increase

### 4) ARTICLE XXII – GROUP HEALTH INSURANCE

Effective for the October 1, 2010 premium the County will contribute 85% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Insurance Plan toward each employee's monthly health insurance premium. If an employee and their spouse complete an annual Health-Risk assessment on or before September 1 of each year, the County will contribute 90% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Insurance Plan toward each employee's monthly health insurance premium. The County agrees to maintain the current benefit levels for the duration of the agreement; but reserves the right to change the Group Health Plans as long as benefit levels are maintained.

The County agreed to offer a voluntary, employee-paid short-term disability insurance policy and enhanced dental policy at no cost to the County.

### 5) ARTICLE XXI SICK LEAVE

SLIP (Sick Leave Incentive Program) terminates as of December 31, 2009.

In addition to the foregoing, the new agreement provides for modifications to Management Rights and allows an additional 4 hours of floating holiday time in 2010 and 8 hours in 2011.
