INTER-AGENCY AGREEMENTS AND CONFIDENTIALITY STATEMENTS REMINDER: Belinda reminded members to complete their respective inter agency agreements and confidentiality statements if they have not done so previously.

FOLLOW UP FROM LAST MEETING: Doug Bisbee from Community for Hope reviewed efforts by Community for Hope to prevent, intervene and postvent suicides. He reviewed the Yellow Ribbon Program and the ACT program (Acknowledge, Care, Tell) which is implemented in the schools. States the passive approach works well with girls and younger children. They are also working on (QPR) Gatekeeper Training to train the public about the signs, what questions to ask, how to intervene and refer for people considering suicide. They are also working on means restriction including access to guns and trigger locks. He also reviewed the survivor and grief support. Community for Hope has packets that are handed out to family members and survivors. States more pediatricians are asking mental health questions as part of their visits with patients.

Mary Wiatrowski reviewed that juvenile intake workers utilize two assessments which include a mental health piece and referrals.
