1. <u>Call to Order</u>: The meeting was called to order at 1:31PM

2. <u>Consent Agenda Items</u>: Brennand/Francour moved approval of the March 16, 2010 agenda and approval of the Minutes from March 2, 2010. <u>Motion passed unanimously</u>.

3. Voice and Data Radio Project –Consultant RFP Recommendation – Review and take action
