The Grant which Hacker applied for from US Figure Skating was awarded to the arena, it was one of 12 grants awarded across the United States each for \$2,000.00. The grant money will go toward the purchase of 20 new pair of skates for use in the basic skills lessons and public skating. The grant will also help in funding a 10% discount to any new skater who registers for the basic skills program at the Big Brothers/Big Sisters Event and the Skate for Your School Events. The funds will also help with the promotion of the Skate for Your School nights that Hacker intends to host throughout this season.
