New Business: February CVSO Report detailed by Robert. Office has been significantly helped by our PT file manager. Also another PT person that works for Advocap helps in this area. Pending file count is the lowest it has been in 2 years. Robert very pleased with this. Explained that if a case gets into appeal status, it can stay in this pending status for at least a year.
