Joe believes that this is a direct route to bring our message to the people. He also brought up the idea of printing some sort of generic poster for VSO's to promote their events. Robert will take this idea to Council of Veterans Organization meeting next month to see if they would utilize if office had printed.

CVSO June report distributed – alot of activities lately. New work study started this week. Robert spoke on the number of new files created – this person has never walked in the door before. We had 53 brand new people last month. This does not even consider the veterans that come in for follow-up on their current benefits. Robert spoke on the VA's mission to reduce the backlog. Explained the Ready to Rate Claim philosophy. In theory, it will shorten the claims process significantly. Because of this, we will be more proactive in securing all the supporting documents. We have to get up to speed on this process. It should reduce processing time to 60 days.

CVSO Annual Meeting – September 10 – Robert asked if any commissioner would want to go and give presentation on how our commission does business. Judy will call to see who will go when registration comes.
