### WINNEBAGO COUNTY BOARD MEETING TUESDAY, JANUARY 18, 2011

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

Motion by Supervisor Robl and seconded to adopt the amended agenda with the change of order of the Resolutions so that Resolution No. 340-12012 will be acted on prior to Resolution No. 338-12012. CARRIED BY VOICE VOTE.

### REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Kline reported that the Legislative Committee will be meeting on Monday, January 23. Supervisor Brennand stated that the two Farmland Preservation items that are on tonight's agenda—11/15/2011 Report No. 001 & Amendatory Ordinance #11/01/11 and Ordinance No. 309-12011—will be withdrawn again and postponed until another meeting. He explained that they have received an extension from Ben Brancel, Wisconsin Secretary of Agriculture, for the certification of the county's current farmland preservation program so this matter isn't as urgent as it was last December. However, once Secretary Brancel makes a decision on the county's future land use maps, this matter will come back to the Board for approval.

Supervisor Egan distributed copies of the Winnebago County Fair's year-end financial statement. He explained that the fair did not make a profit this year. Weather was a factor, as was the high cost of various budgeted items. Some of those high costs were: insurance, \$6,000+; buildings and grounds maintenance, \$13,300; sanitation, \$7,000+. Supervisor Egan asked that if anyone has any questions about the report, that they give him a call.

Motion by Supervisor Robl and seconded to approve the proceedings from the December 20, 2011 Winnebago County Board meeting. CARRIED VOICE VOTE.

### **COUNTY EXECUTIVE'S REPORT**

Executive Harris introduced Morgan Hinkley to the Board. Ms. Hinkley is the new Park View Health Center Director. She comes to the county with a lot of experience in nursing home management from Minnesota. The Board welcomed Ms. Hinkley with a round of applause.

Executive Harris asked that the Board approve the following Resolutions:

- "No. 330-12012: Authorize Park View Health Center to Transfer \$21,167 from the Professional Services Account to the Building Improvements Account of the 2011 Budget to Cover the Cost of Installing Sprinklers in the Outside Canopies". Executive Harris explained that sprinkling outside canopies is now a state and federal requirement.
- "No. 331-12012: Appropriate an Additional \$345,000 to the Project to Demolish the Old Park View Health Center Buildings and Fund with General Obligation Debt to be Issued later in 2012". Executive Harris

- explained that while they were demolishing the old Rehabilitation Pavilion, additional asbestos was found in the walls which is causing significant additional cost and time delays.
- "No. 334-12012: Authorizing the Borrowing of Approximately \$3,920,000 and Providing for the Issuance and Sale of Taxable General Obligation Refunding Bonds Therefor". Executive Harris explained that this isn't new debt, but would be retiring old debt and saving the county approximately \$290,000 in interest.
- No. 338-12012: Approve Two (2) New Full-Time Wisconsin Well Woman Program Case Specialists Positions
  for the Winnebago County Public Health Department, Effective January 19, 2012." Executive Harris explained
  that the funding for these two positions will now come directly from the State of Wisconsin to the county
  instead of the county receiving these services through Planned Parenthood employees. He stressed the
  importance of maintaining these positions and the impact they have on women's health.

WHEREAS, there are sufficient funds in the Professional Services Account of the 2011 Budget to cover the cost of installing the sprinklers in the outside canopies.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes Park View Health Center to transfer \$21,167 from its Professional Services Account of the 2011 Budget to the Building Improvements Account of the 2011 Budget to cover the cost of installing sprinklers in the outside canopies at Park View Health Center.

## RESOLUTION NO. 331-12012: Appropriate an Additional \$345,000 to the Project to Demolish the Old Park View Health Center Buildings and Fund with General Obligation Debt to be Issued Later in 2012

WHEREAS, the old Park View Health Center facility was scheduled to be razed upon completion of the new facility; and

WHEREAS, the first step in the demolition project is to hire a vendor to remove asbestos from the old facility and properly dispose of it; and

WHEREAS, after completion of the asbestos removal, a second vendor was hired and has been working to raze the old facility buildings; and

WHEREAS, during the demolition process, additional asbestos was discovered that was not detected by the previous vendor because of its location; and

WHEREAS, discovery of this additional asbestos has resulted in project delays and will require additional funds to cover the cost of the delays and to remove and properly dispose of the additional asbestos; and

WHEREAS, it has been estimated that it will cost an additional \$345,000 to complete the project.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$345,000 to the project to raze the old Park View Health Center facility.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the funds to pay for said project shall be transferred from Winnebago County's General Fund to the Capital Project to raze the old Park View Health Center's buildings with the General Fund being reimbursed from a subsequent bond issue.

WHEREAS, these purchases included weapons racks, which are needed, and courtroom security wands, which would enhance courtroom security; and

WHEREAS, the Winnebago County Board of Supervisors believes these purchases would be beneficial; and WHEREAS, the grant agency approved these purchases; and

WHEREAS, the funds need to be moved from labor accounts to small equipment accounts to make the purchases, and this type of transfer of funds requires County Board approval.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of \$10,400 from the Sheriff's Department's 2011 Labor and Small Equipment Accounts to its 2011 Small Equipment Account for the purpose of purchasing weapons racks and courtroom security wands (9) to enhance courtroom security.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the funds will be carried over to 2012 since approval and the purchases could not have occurred prior to the end of 2011.

## RESOLUTION NO. 334-12012: Authorizing the Borrowing of Approximately \$3,920,000; and Providing for the Issuance and Sale of Taxable General Obligation Refunding Bonds Therefore

WHEREAS, the County Board of Supervisors of Winnebago County, Wisconsin (the "County") hereby finds and determines that it is necessary, desirable and in the best interest of the County to raise funds for the purpose of refunding obligations of the County, including interest on them, specifically, the Taxable General Obligation Refunding Bonds, dated March 1, 2003, maturing in the years 2014 through 2019 and the Taxable General Obligation Refunding Bonds, dated April 15, 2004, maturing in the years 2015 through 2020 (collectively, the "Refunded Obligations") (the "Refunding"), and there are insufficient funds on hand to pay said costs;

WHEREAS, the County Board of Supervisors deems it to be necessary, desirable and in the best interest of the County to refund the Refunded Obligations for the purpose of achieving debt service cost savings;

WHEREAS, counties are authorized by the provisions of Section 67.04 of the Wisconsin Statutes to borrow money and to issue general obligation refunding bonds for the purpose of refinancing their outstanding obligations;

WHEREAS, the County Board of Supervisors of the County hereby finds and determines that general obligation refunding bonds in an aggregate amount of approximately \$3,920,000 should be issued, and it is now necessary and desirable to authorize their issuance and sale: and

WHEREAS, due to certain provisions contained in the Internal Revenue Code of 1986, as amended, it is necessary to issue such bonds on a taxable rather than tax-exempt basis.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that:

Section 1. Authorization of the Bonds. For the purpose of paying costs of the Refunding, there shall be borrowed pursuant to Section 67.04 of the Wisconsin Statutes, a principal sum of approximately THREE MILLION NINE HUNDRED TWENTY THOUSAND DOLLARS (\$3,920,000) from a purchaser or purchasers to be determined by competitive sale (the "Purchaser").

Section 2. Sale of the Bonds. To evidence such indebtedness, the Chairperson and County Clerk are hereby authorized, empowered and directed to make, execute, issue and sell to the Purchaser for, on behalf of and in the name of the County, taxable general obligation refunding bonds aggregating a principal amount of approximately THREE MILLION NINE HUNDRED TWENTY THOUSAND DOLLARS (\$3,920,000) (the "Bonds"). There be and there hereby is levied on all the taxable property in the County a direct, annual tax in such years and in such amounts as are sufficient to pay when due the principal and interest on the Bonds.

Section 3. Notice of Sale. The County Finance Director, in consultation with Robert W. Baird & Co. Incorporated ("Baird"), is hereby authorized and directed to cause notice of the sale of the Bonds to be disseminated at such times and in such manner as the Finance Director may determine.

<u>Section 4. Official Notice of Sale</u>. The County Finance Director, in consultation with Baird, shall also cause an Official Notice of Sale to be prepared and distributed and may prepare or cause to be prepared and distributed an Official Statement or other form of offering circular.

<u>Section 5. Award of the Bonds</u>. Following receipt of bids for the Bonds, the County Board of Supervisors shall consider taking further action to provide the details of the Bonds and to award the Bonds to the lowest responsible bidder or bidders therefore.

Section 6. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the County Board of Supervisors or any parts thereof in conflict with the provisions hereof shall be, and the same are, hereby rescinded insofar as the same may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.

## RESOLUTION NO. 335-12012: Authorizing the Borrowing of Approximately \$9,225,000; and Providing for the Issuance and Sale of General Obligation Refunding Bonds Therefore

WHEREAS, the County Board of Supervisors of Winnebago County, Wisconsin (the "County") hereby finds and determines that it is necessary, desirable and in the best interest of the County to raise funds for the purpose of refunding obligations of the County, including interest on them, specifically, the General Obligation Promissory Notes, dated December 1, 2003, maturing in the year 2013, the General Obligation Promissory Notes, dated October 15, 2005, maturing in the years 2013 through 2015 and the General Obligation Promissory Notes, dated September 5, 2006, maturing in the years 2014 through 2016 (collectively, the "Refunded Obligations") (the "Refunding"), and there are insufficient funds on hand to pay said costs; and

WHEREAS, the County Board of Supervisors deems it to be necessary, desirable and in the best interest of the County to refund the Refunded Obligations for the purpose of achieving debt service cost savings; and

WHEREAS, counties are authorized by the provisions of Section 67.04 of the Wisconsin Statutes to borrow money and to issue general obligation refunding bonds for the purpose of refinancing their outstanding obligations; and

WHEREAS, the County Board of Supervisors of the County hereby finds and determines that general obligation refunding bonds in an aggregate amount of approximately \$9,225,000 should be issued, and it is now necessary and desirable to authorize their issuance and sale.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that:

Section 1. Authorization of the Bonds. For the purpose of paying costs of the Refunding, there shall be borrowed pursuant to Section 67.04 of the Wisconsin Statutes, a principal sum of approximately NINE MILLION TWO HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$9,225,000) from a purchaser or purchasers to be determined by competitive sale (the "Purchaser").

Section 2. Sale of the Bonds. To evidence such indebtedness, the Chairperson and County Clerk are hereby authorized, empowered and directed to make, execute, issue and sell to the Purchaser for, on behalf of and in the name of the County, general obligation refunding bonds aggregating a principal amount of approximately NINE MILLION TWO HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$9,225,000) (the "Bonds"). There be and there hereby is levied on all the taxable property in the County a direct, annual tax in such years and in such amounts as are sufficient to pay when due the principal and interest on the Bonds.

<u>Section 3. Notice of Sale.</u> The County Finance Director, in consultation with Robert W. Baird & Co. Incorporated ("Baird"), is hereby authorized and directed to cause notice of the sale of the Bonds to be disseminated at such times and in such manner as the Finance Director may determine.

Section 4. Official Notice of Sale. The County Finance Director, in consultation with Baird, shall also cause an Official Notice of Sale to be prepared and distributed and may prepare or cause to be prepared and distributed an Official Statement or other form of offering circular.

<u>Section 5. Award of the Bonds</u>. Following receipt of bids for the Bonds, the County Board of Supervisors shall consider taking further action to provide the details of the Bonds and to award the Bonds to the lowest responsible bidder or bidders therefore.

Section 6. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the County Board of Supervisors or any parts thereof in conflict with the provisions hereof shall be, and the same are, hereby rescinded insofar as the same may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.
