INTRODUCTIONS: Team members introduced themselves and welcomed new member Stacey Davis.

APPROVAL OF JUNE 27, 2011 MINUTES: Motion by Mary Jo Turner to approve minutes. Seconded by Barry Busby. Motion carried with no opposition.

REPORT ON PARENTS ARE THE KEY PROGRAM: Teresa reviewed the progress of the Parents are the Key Program. The program is being managed through Winnebago County Health Department and Re:Th!nk. The brochure and the contract between the parents and teen driver were distributed to members. The goal is to have the contract distributed to all 10th grade families. When the contract is completed and a brief on-line survey is completed, the family will be put in a drawing for a \$100 gas card. The contracts and brochures were distributed at Lifestart with a good response from parents. They will also be distributed at Parent-Teacher Conferences at all the Winnebago County Schools. It was suggested for them to be available at Athletic Code Meetings.

Jinnifir asked if an original copy of the brochure and contract could be e-mailed to her for distribution at PARTY at the PAC. Teresa will discuss with Re:Th!nk and let her know.

PARTY at the PAC will be held on February 13 and 14, 2012. A discussion followed concerning sophomores attending PARTY at the PAC instead of freshman.

Jinnifir requested additional volunteers for the driving simulator at the county fairs.

Natalie Gehringer requested data to evaluate if the prevention education programs are helping in lowering the incidence of vehicle crashes in teens. Teresa will try to get the data from the WISH system.

SUICIDE PREVENTION RECOMMENDATION: Teresa reviewed that Kathleen Endres, Stacey Davis, Belinda DeGoey and herself will make up the sub-committee to develop a suicide prevention recommendation for Winnebago County. Outagamie County suicide prevention recommendations will be used as a template for the Winnebago County recommendation. She opened up the committee to any other members interested in the initiative.
