All have been male aged 15-16. Winnebago County is higher than the state average in regards to overall suicide rate. The Youth Risk Behavior Survey from 2009-2010 high school and middle school students portions about suicide were reviewed and show significant concerns. Survey is administered to all students in high school and middle school.

Teresa will send out a Meeting Wizard to set up the first sub-committee meeting to establish recommendations on prevention of suicide. Any team members interested are encouraged to attend. Outagamie County suicide prevention recommendations will be used as a template for the Winnebago County recommendation.
