SUICIDE PREVENTION SUB-COMMITTEE UPDATE: The suicide prevention sub-committee has met and drafted updated recommendations. The sub-committee is asking all members of the CDRT to review the recommendations and answer the questionnaire. Please return the questionnaire to Teresa by August 14 either by e-mail or fax. Teresa handed out the draft recommendations and questionnaire to those in attendance and Belinda will send electronic copies to those not in attendance today.

AUGUST MEETING PLANNING: Suicide/Mental Health Data in Youth from Youth Risk Behavior Survey (YRBS) is very concerning. To enable us to understand how we can effectively work together to serve our youth with mental health needs and prevent youth suicides, it will be helpful to understand the following: How does Public School Liaison Officers and Winnebago

County Crisis Intervention manage youth with acute mental health needs. Therefore, at the August 18th meeting Doug Brey from Winnebago County Crisis Intervention and the Pat Pedersen, Neenah School Liaison Officer will present on how the schools and Crisis Intervention manage youth with mental health needs. The plan is to invite school liaison officers, school counselors and anyone else with an interest to the meeting.
