- I. Motion, second and approval for the April 30<sup>th</sup> meeting minutes.
- I. Winnebago County IS Report: Foxcomm P1 training; Installation of P1 went good. July 9, 10 and 11 will be testing GPS on mobile. Once everything works, it will be given to local entities for installation. Updating IT departments on P1 updates. For those agencies with Offender Trac, the new Offender Trac will be upgraded to the new server shortly.
- II. FoxComm Report: They are having problems with data conversion. Calumet County is having issues that they need Motorola to fix. Drop dead date is July 18. Mobile training for Law is scheduled for July 30 & 31, Fire August 1. Go live date is set for October 7 for Calumet County, October 14 for Winnebago County and October 21 for Outagamie County. CAD training is August 19-25.

For GPS to work on your MDC you will need a trimble with antennae, cell cards will not work for the GPS function. Badger Stop – They are trying to make sure that it will work.
