<u>UPDATE LEC ABSORPTION CHILLER PROJECT:</u> Done with project. Chiller is up and running, but the cold weather came too quickly in order to test it properly. Ready to go for next year.

<u>UPDATE OF HEARING LOOP INSTALLATION:</u> Mike can purchase hearing loop systems for Oshkosh Human Services and Neenah Human Services for approximately \$500.00 each. There should be enough money left in this year's budget to purchase the two hearing loops. Then next year he can do a budget adjustment to purchase the others. The hearing loop systems come with two microphones and you can purchase additional microphones for \$29.00 each. Mike's staff should be able to install the systems. Mike is going to purchase one hearing loop and set it up for testing before buying additional. Tom recommends buying additional microphones.
