4. Communications

Paul Eisen presented K-9 articles from the Northwestern and Post Crescent and an article regarding the Courthouse security. Bill Wingren stated he has received phone call recognition from citizens stating their happiness with the go ahead on the security at the Courthouse.

Jail population was discussed and on the day of the meeting it was listed at 257. Sheriff Matz discussed the "Good Choices" program that we promote with criminal activity for suspects who may not have a previous criminal history. Suspects pay \$50 to go online and take a course and test regarding their actions versus going to jail on criminal charges.

5. Approve Budget Transfer – Sheriff – John Matz

Sheriff John Matz presented a budget transfer in the amount of \$2,150.00 from the K-9 funds to purchase K-9 fund raising items. A stuffed K-9 from Adams County was presented as an example. The fund raising items would be available for purchase at Community Events, Schools and D.A.R.E. Brat Fry's and other community programs. K-9's would be sold at \$15 per piece.

Motion to approve a budget transfer of \$2,150.00 was made by Bill Roh, seconded by Tom Ellis. All in favor, motion carried 5-0.

6. Sheriff's Report

Sheriff Matz presented an Officer Recognition phone call received from a citizen in the Town of Algoma whose home was burglarized. She complimented the officers and detectives for their kindness and thoroughness while investigating the burglary.

Sheriff Matz presented a COPS Meeting report from a Winneconne Town Hall stating the appreciation from a Town Chairperson for the increase in the addition of 2 deputies, which were added in 2014. Thanking the Winnebago County Sheriff's Office for the additional patrols for security and speed enforcement in the Town of Winneconne.

Sheriff Matz presented a news article from the Oshkosh Northwestern in regards to a case in which the Winnebago County Sheriff's Office Detectives busted a man on child porn charges. Detective Mike Sewall presented the child porn program to the committee at the March 9th meeting.

Sheriff Matz advised the committee that the week of April 13th was National Telecommunicators Week and presented them with pins to help recognize those individuals.
