Sheriff Matz discussed the Bearcat Grant and answered committee members questions and concerns in regards to the new Bearcat.

Sheriff Matz discussed the \$1,500 grant for the Teen Safe Driver Program that will be presented soon.

Sheriff Matz advised there is a book called "Stop Teaching Our Kids to Kill" by Dave Grossman that discusses the impact video games can have on kids.

Sheriff Matz informed the committee that Inmate Johnson is suing Winnebago County Sheriff's Office for her time and treatment in our facility. He informed them that we are counter suing her for the \$23,000 in overtime we had used for guarding her at the hospital as well as additional labor costs.

Bill Wingren asked the Sheriff about the intentions of the Huber Building. Sheriff Matz said the Sheriff's Office has no use for that building.
