1. Call to Order

Chairman Bill Wingren called the meeting to order at 9:41 a.m. and it was verified that the meeting was properly noticed.

2. Public Comments on agenda items

3. Presentation and discussion of Courthouse Security

Sheriff Matz again presented the same Power Point presentation as was presented at the last Judiciary and Public Safety Committee meeting held on 05/13/13; however, one additional option was added which was Option G and was in regards to having a new, in-depth study completed and cost figures in regards to Option B had been changed. This presentation also included the same videos that were shown of violent incidents that have occurred in courtrooms in different states.

There was then a lengthy discussion regarding how some of the options given would be accomplished such as how a welcome center would work, how many cameras would be needed etc. There was also discussion in regards to how each option worked with the other options. This discussion led to a determination that Option E, which involved staffing, and Option F, which involved construction of a new courthouse, should be removed from the table for consideration due to the expense involved and that a comprehensive proposal combining the different options from Options A-D be done to determine how those options could be molded into the present infrastructure of the courthouse. It was determined that another joint meeting between these two committees would be held in regards to this where the judges could also be present. The date of that meeting will be determined at a later time.
