#### REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Barker announced that David Galassie, a former Menasha resident, has written a book on the history of Menasha. He will be at the Menasha Public Library on Thursday, June 28 at 7:00 to speak about the book. Books will be available for sale. Part of the proceeds will go to the Menasha Historical Society.

Supervisor Barker reported that she attended the May 17 graduation of the Class of 2012 from UW-Fox Valley. Since the engineering program started at UW-Fox Valley, 57 students have gotten their degrees from UW-Platteville by attending classes at UW-Fox Valley. She had a copy of the graduation program if anyone wanted to look at it.

Supervisor Barker distributed copies of the 100 years of UW-Extension brochure to the Board.

Supervisor Ramos reported that typically the Board of Health meets on the first Friday of the month, but because the first Friday in July is part of the 4<sup>th</sup> of July holiday weekend, they have rescheduled their meeting to July 13.

Supervisor Brennand reported that changes to the county's Farmland Preservation Program have been submitted to Wisconsin's Agriculture Secretary Brancel's office for approval. Once it's been approved by Sec. Brancel, it will come to the County Board for their approval.

Supervisor Wingren reminded the Board that at 8:00 a.m. on the 4<sup>th</sup> of July, Sheriff Matz will be reading the Declaration of Independence on the front steps of the Winnebago County Courthouse. He encouraged all the Supervisors to attend.

Supervisor Kline reported that the Legislative Committee will be meeting on June 25 at 8:30 a.m.

Supervisor Lennon reported that the Aviation Committee will not be meeting on July 11. The date of their July meeting will be announced at a later date.

Supervisor Ellis reported on his attendance at a seminar at the Winnebago County Jail about recovering from disasters and the roles of local, state and federal government in that recovery. He stated the instructor was from the Portage, Wisconsin area and was involved in the recovery efforts at the Wisconsin Dells/Lake Delton area during the floods of 2008.

Supervisor Hegg reported that he was recently at the Atlanta and Detroit airports and he did not see 18' paved, asphalt roads at either of those airports.

Supervisor Eisen reported that he attended the Winnebago Drug Court graduation on June 15. He commended Judges Woldt and Key for their efforts and work with this program.

Supervisor Eisen reported on his attendance at the May 17 WCA Judiciary & Public Safety Steering Committee meeting, where a representative from the Wisconsin Department of Corrections introduced the state level Criminal Justice Coordinating Counsel, which works to reduce the number of incarcerations and to find alternatives to incarceration.

Motion by Supervisor Robl and seconded to approve the County Board Proceedings from May 1 and May 15, 2012 meetings. CARRIED BY VOICE VOTE.

#### **COUNTY EXECUTIVE'S REPORT**

Executive Harris discussed the following resolutions:

- Resolution No. 36-62012, "Authority to Execute 2010-2015 Labor Agreement with the Winnebago County
  Deputies Association." Executive Harris explained that this is the one bargaining group that did not loose
  their collective bargaining rights—including mediation and arbitration—with the passage of Act 10. He
  explained various aspects of the contract and recommended that the Board approve this resolution.
- Resolution No. 39-62012, "Approve Consortium Agreements for Local Elected Officials of the Fox Valley Workforce Development Area." Executive Harris said that this resolution was previously approved by the Board, but since then Outagamie County has now left this group, so the State of Wisconsin has asked that new agreements be approved. Executive Harris asked for the Board's approval of this resolution.

Executive Harris reported that the Outagamie County Executive has indicated that Outagamie County is not interested in making any capital investments in the Tri-County Ice Arena and would like to sell their share to Winnebago County for \$1.00. Executive Harris explained that because Outagamie County is refusing to contribute to any capital improvements at the ice arena, Winnebago County has not been able to make any capital improvements as well. Executive Harris explained that he feels it is in the best interest of the ice arena and Winnebago County to accept Outagamie County's offer. This item will be coming before the Board in the near future.

Executive Harris then took questions from the Board

#### **COUNTY BOARD CHAIRMAN'S REPORT**

Chairman Albrecht reported that Supervisor Sievert is excused from tonight's meeting.

Chairman Albrecht congratulated Morgan Hinkley, Park View Health Center Administrator, on Park View Health Center's designation as a 5-star facility. The Board congratulated Ms. Hinkley with a round of applause.

#### PRESENTATION OF 2012 WINNEBAGO COUNTY SCHOLARSHIPS

Chairman Albrecht and Supervisor Nancy Barker, Chairperson of the UW Education, Extension and Agriculture Committee, presented the 2012 Winnebago County Scholarships to the following high school seniors:

The students were presented with a certificate and a book about the history of Winnebago County, entitled <u>In this</u> <u>Century</u>. Each student announced where they will be going on to college and what they will be studying.

Chairman Albrecht announced that Ricky Bares, Omro High School, was not able to attend tonight's meeting, so his certificate and book will be mailed to him.

#### COUNTY HIGHWAY G BRIDGE REPLACEMENT PRESENTATION

Ernie Winters, Winnebago County Highway Commissioner, presented information on the County Highway G bridge replacement project. He explained that they will be replacing the existing bridge that goes over the Neenah Slough. The existing bridge has severely deteriorated and is in need of replacement.

Mr. Winters explained that the current bridge was built in 1943 and a lot of the timber components are from the original structure. He stated that when there is high water, it reaches the lower portions of the deck structure causing much of this deterioration. Other problems with the bridge include:

- Railings are not up to current safety standards
- West abutment is splitting and cracked and is beginning to separate
- Wood girder is split and breaking apart
- East abutment columns are severely deteriorated
- · Other timber components are starting to fall apart

Mr. Winter explained that this project has been in the Five Year Capital Improvement Program for design in 2012 and construction in 2014, if approved.

Mr. Winter stated that the bridge's sufficiency rating is 35, which qualifies it for Federal funding. They applied for federal funding and received \$409,600 to apply towards construction costs. Mr. Winter stated that the anticipated total cost for the project will be approximately \$612,000.

The average daily traffic on CTH G is approximately 1,400 vehicles per day. The bridge will be closed during the project and a detour will be posted and maintained by the county. The project should take between four and six months to complete.

Mr. Winter stated that there will be a resolution coming before the Board in July asking for funds to complete this project. He then took questions from the Board.

## RESOLUTION NO. 36-62012: Authority to Execute 2010-2015 Labor Agreement with the Winnebago County Deputies Association

BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Executive and the Winnebago County Clerk to execute a six-year Agreement on behalf of Winnebago County and the Winnebago County Deputies Association, for the years 2010, 2011, 2012, 2013, 2014, and 2015, effective January 1, 2010, which Agreement will provide the following major changes from the previous Agreement:

#### 1) WAGES

0%	Across-the-board increase on 1/01/2010
0%	Across-the-board increase on 1/01/2011

- 1.5% Across-the-board increase on 6/07/2012
- 1.0% Across-the-board increase on 9/27/2012
- 1.0% Across-the-board increase on 10/11/2012 and 1% employee contribution to the Wisconsin Retirement System (WRS)
- 1.0% Across-the-board increase on 1/03/2013
- 1.0% Across-the-board increase on 1/02/2014, and 1% additional employee contribution to Wisconsin Retirement System (WRS)
- 1.0% Across-the-board increase on 7/03/2014
- 1.0% Across-the-board increase on 1/01/2015, and 1% additional employee contribution to Wisconsin Retirement System (WRS)
- 1.5% Across-the-board increase on 7/02/2015

#### 2) ARTICLE XIII: GROUP HEALTH INSURANCE

Effective for the October 1, 2012, premium, Winnebago County will contribute 85% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Insurance Plan toward each employee's monthly health insurance premium. If an employee and the employee's spouse complete an annual Health Risk Assessment on or before September 1 of each year, the County will contribute 90% of the monthly premium amount of Plan 2 in either the Network Health Plan or the UMR Health Plan toward each employee's monthly health insurance premium.

The employer reserves the right to change health insurance providers and/or move to an insurance pool. If a married couple are both employees of Winnebago County, they shall share one family plan.

#### 3) ARTICLE XII: SICK LEAVE

SLIP (Sick Leave Incentive Program) ended on December 31, 2009.

In addition to the foregoing, the new Agreement provides for modifications to Management Rights, and allows an additional 8 hours of floating holiday time in 2012, and 4 hours in 2013.

# RESOLUTION NO. 37-62012: Authorize the Public Health Department to Accept a \$20,000 Wisconsin Department of Public Health Grant and Appropriate the Funds to Costs of Implementing a Formal Quality Improvement Plan

WHEREAS, the State of Wisconsin Department of Public Health is making grant funds of \$20,000 available to the Winnebago County Public Health Department; and

WHEREAS, the purpose of the funding is to allow the Department to implement a formal quality improvement plan and conduct a strategic planning process; and

WHEREAS, these activities will help prepare the health department for voluntary national accreditation; and WHEREAS, the timing of this award is of special benefit because of the consolidation of the City of Oshkosh

Health Department and City of Neenah Health Department with the Winnebago County Health Department; and WHEREAS, the Winnebago County Health Department will need to incur costs for contractual services of \$10,000 and incur additional labor costs of \$10,000 to carry out this process; and

WHEREAS, no County funding is needed to complete the project.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Health Department to accept a \$20,000 State of Wisconsin Department of Public

Health grant and appropriates the funds as follows: Contractual services: \$10,000; and Labor: \$10,000, to carry out this project.

## ORDINANCE NO. 38-62012: Create Section 9.36 of the General Code of Winnebago County: Regulation of Motor Vehicles on Icebound Inland Lakes

WHEREAS, as a consequence of complaints and concerns raised by citizens of Winnebago County residing near Lake Winnebago, it has become apparent to your undersigned Committee that there is a need to create an ordinance to control speed and noise on Lake Winnebago during the winter months in relationship to the use of snowmobiles and other motor vehicles; and

WHEREAS, the proposed Ordinance entitled "9.36 Regulation of Motor Vehicles on Icebound Inland Lakes" would provide authority to the Winnebago County Sheriff to issue citations to individuals operating motor vehicles on Lake Winnebago in an unsafe manner or in such a way that results in a nuisance to those citizens residing near Lake Winnebago.

NOW, THEREFORE, BE IT ORDAINED by the Winnebago County Board of Supervisors that it hereby creates Section 9.36 of the General Code of Winnebago County to read as follows.

- 9.36 <u>REGULATION OF MOTOR VEHICLES ON ICEBOUND INLAND LAKES.</u>
- (1) Authority: This Ordinance is created pursuant to § 30.81(2), Wis Stats.
- (2) <u>Jurisdiction</u>: This Ordinance shall be applicable to any icebound inland waters over which Winnebago County has jurisdiction, except to the extent that icebound inland lakes are regulated by valid local ordinances enacted pursuant to §§ 30.81(1) and (1m), Wis Stats.
- (3) <u>Exemption</u>: This Ordinance shall not apply to motor vehicles competing in a race or derby sanctioned by a township or municipality, provided that at least 7 days prior written notice of the race or derby has been provided to the Winnebago County Sheriff's Office.
  - (4) Definitions:
- (a) <u>Law Enforcement Officer</u>: A law enforcement officer shall be defined as specified in § 165.85(2)(c), Wis Stats, and shall include a Conservation Warden.
- (b) <u>Motor Vehicle</u>: A motor vehicle shall be defined as a vehicle, including a combination of two or more vehicles or an articulated vehicle, that is self propelled, except a vehicle operating exclusively on a rail. The term "motor vehicle" shall include, without limitation, a commercial motor vehicle including but not limited to snowmobiles, motorcycles, all-terrain vehicles, and utility-terrain vehicles.
  - (5) Operating Motor Vehicles on the Frozen Surfaces of Inland Lakes:
- (a) No person may operate a motor vehicle at a speed exceeding 10 miles per hour within 100 feet of another person who is not in or operating a motor vehicle on the frozen surface of an inland lake in Winnebago County.
- (b) No person may operate a motor vehicle at a speed exceeding 10 miles per hour within 100 feet of a fishing shanty on the frozen surface of an inland lake in Winnebago County.
- (c) The operator of a motor vehicle shall yield the right of way to another person who is not in or operating another motor vehicle, and who is within 100 feet of the operator's motor vehicle on the frozen surface of an inland lake in Winnebago County.
- (d) No person shall operate a motor vehicle on the frozen surface of an inland lake at a rate of speed that is unreasonable or improper under the circumstances, or is in excess of 25 miles per hour while traveling within 1,000 feet from the shoreline on the frozen surface of an inland lake in Winnebago County.
- (e) No person may operate a motor vehicle on the frozen surface of an inland lake unless it is equipped with a muffler in good working order. Exhaust and overall engine noise levels while in stationary operation shall not exceed 90 decibels as measured in accordance with the procedures established for the measurement of exhaust sound levels in the January 2004 Society of Automotive Engineers Standard J2567.
- (6) Operation of a Motor Vehicle on the Frozen Surface of an Inland Lake During Hours of Darkness: Any person operating a motor vehicle on an icebound inland lake during hours of darkness is required to light all headlamps, tail lamps, and clearance lamps with which the vehicle is required to be equipped.
- (7) <u>Penalty</u>: Any person who violates any provision of this Section of the Code shall be subject to a forfeiture of \$40.00 plus any statutory surcharges imposed by the State Legislature.
  - (8) Effective Date: This Ordinance shall be in full force and effect as of September 1, 2012.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves the attached Consortium Agreements by and between Winnebago County and Calumet, Fond du Lac, Green Lake, Waupaca, and Waushara Counties to organize a Workforce Development Area and implement the Workforce Investment Act of 1998.
