Committee reviewed the findings and conditions in order to take action on a conditional use request to expand an existing conditional use to include outdoor sports fields. MOTION by C. Thompson, seconded by T. Egan, to approve with findings and conditions as submitted. Committee discussed hours of operation and town condition regarding change of ownership. MOTION by T. Egan, seconded by P. Brennand to amend county condition a) to read "Outdoor sports field hours shall be limited to 7:00 am to 9:00 pm." Motion carried 4-0-1. 3. <u>Cellu Tissue Corp, E of 212 N Lake St, Town of Menasha – Conditional</u> <u>Use.</u>
