#### 1. <u>Touchmark on West Prospect LLC, 2601 Touchmark Dr, Town of Menasha –</u> <u>Conditional Use Permit</u>.

Applicant is requesting an amendment to a previously granted Conditional Use Permit for development of a retirement community and a private road.

Committee members reviewed the findings and proposed conditions.

Motion to approve with conditions by J. Sievert. Seconded by C. Thomson. Motion carried 5-0.

No further testimony was given.

### 2. <u>Ament Investments, Across from 200 County Rd CB, Town of Neenah – Conditional</u> <u>Use Permit</u>.

Applicant is requesting a Conditional Use Permit to store recreational vehicles in an outside storage yard.

Committee members reviewed the findings and proposed conditions.

Motion to approve with conditions by J. Sievert. Seconded by C. Thomson.

Committee members discussed whether or not there should be a condition of a minimum and/or maximum separation between screenings.

Motion to amend a condition requiring plantings of coniferous vegetation so that there is no more than three feet of separation between plantings by J. Sievert. No second. Motion failed.

Vote on original motion carried 4-1-0 (Sievert - Nay)

No further testimony was given.

## 3. <u>Jeffrey Sauerberg, 6188 Clark Point Rd, Town of Winneconne – Conditional Use</u> <u>Permit</u>.

Applicant is requesting a Conditional Use Permit to erect solar panels which will be connected to the grid in a residential district.

Committee members reviewed the findings and proposed conditions.

Motion to approve with conditions by C. Thomson. Seconded by T. Egan. Motion carried 5-0.

No further testimony was given.

4. Gale Tigert, 1676 Clay Rd, Town of Nekimi – Conditional Use Two Year Review.

B. O'Rourke stated that staff has not received any complaints regarding this conditional use, which was for a sports field and bar.

P. Brennand stated that the Committee will no longer need to review the conditional use permit unless at such time there would be a complaint(s).
