Owner/Applicant is requesting a Zoning Map Amendment/Zoning Change to PDD (Planned Development District) to create two residential lots on an existing private road.

P. Brennand read the revised staff report, recommending approval with Town and County conditions.

Owner/Applicant is requesting a Zoning Map Amendment/Zoning Change to R-1 (Rural Residential) to eliminate dual zoning on combined parcels.

5. <u>Committee review of town zone changes – Town of Vinland</u>.

Motion to forward the proposed Town of Vinland zoning changes to County Board by M. Gabbert. Seconded by C. Thompson. Motion carried 5-0.
