 the use of inpatient rehab facilities, an equalization of payments for certain
 conditions commonly treated in inpatient rehab facilities, and an adjustment of
 skilled nursing facilities payments to reduce hospital readmissions (of which PVHC
 currently tracks and makes every effort to minimize), among other items.
- There was a question regarding the Kronos time clock situation at PVHC. The topic will be an agenda item at this evening's Information Systems Committee meeting.

The income statement through February 2012 was distributed and discussed. It
was noted that next week there will be a meeting regarding a created Munis system
