 - Park View was given a budget target to decrease the levy by 1.8%. This target was not met due to expected expenses exceeding anticipated revenues. Last year the 2011 target of 2.36% was met and exceeded, further compounding the challenge of continued reductions for 2012.
 - One change to the non direct care staff table of organization is the only opportunity for labor savings at this time.
 - The 2012 capital expense requests were presented.

9. Administrator's Report -

- The Resident Census Report for July 2011 was distributed and reviewed.
- Facilities Report –

Mike Elder, Facilities and Property Management Director, sent information noting that:

- The gable trim will be repaired August 16-17.
- The seasonal grounds person resigned and until that position is filled, Facilities will be mowing the lawn.
- The bids for razing the old buildings are being reviewed. Work should begin in 4-6 weeks.
- Any plantings within twelve feet of the old buildings that the Master Gardeners want to keep should be relocated.
 - The Master Gardeners have been notified of the twelve foot perimeter. It was noted that the Master Gardeners is an extremely important program for the Park View residents and much care needs to be taken to protect their gardens during deconstruction.
 - The committee also requested that Facilities be contacted regarding the bird droppings under the front entrance canopy.
