APPROVAL OF AGENDA:

Agenda approved.

PUBLIC COMMENTS:

Steve Barney renewed his request that there be tobacco free transitional housing for inmates. This would include a requirement that residents and staff be prohibited from having tobacco on their person or within the premises.

GinaMarie Opalescent, ESTHER, advised that a UW-Oshkosh graduate student has organized a Second Chance Choir and the choir will be performing at a Martin Luther King, Jr. Celebration at Algoma Methodist Church, 1174 Algoma Blvd., Oshkosh on January 20, 2014.

APPROVAL OF MINUTES:

Motion made to approve meeting minutes from September, 2013. Motion passed unanimously.

STATUS REPORTS:

DRUG COURT:

An application has been made to extend the grant that provides for supervision of the 18-25 year old opiate addicts. There are currently 14 participants monitored under the grant funding and 36 total participants in Drug Court. As of December, 2013 there have been 75 drug court graduates. 20 participants have been terminated from the program and 49 have withdrawn from the program.

A motion was made to modify the current drug court handbook to provide for an Administrative Discharge, without notice or hearing, for anyone in absconder status from the program for 30 days or more. A second incidence of absconding may be grounds for Administrative Discharge without notice.

Since 2006 there have been 133 participants. The recidivism rates for those participants are attached.

SSTOP:

Statistics regarding the program were distributed prior to the meeting and are attached. An additional benefit of SSTOP and Drug Court is that over 44,000 hours of community service has been performed by participants. There is also a decrease in the number of people cited for Operating after Revocation. Human Services now offers a walk-in clinic for those requiring an AODA assessment, however, the \$250 fee is still required prior to reinstatement of a driver's license.

24/7 PROGRAM:

There are currently 101 participants with approximately 85% on the soberlink monitor and 15% reporting for a PBT twice a day. The average length of time spent in the program is 84 days. 80% of participants are on bond for a criminal traffic or misdemeanor offense and 20% are on bond for a felony. The recidivism rate for those off the program for more than 6 months is 15% for criminal traffic or misdemeanor and 7% for felonies. The overall general recidivism rate is 13.3%.

There was discussion about possible legislation to expand the use of the 24/7 program post-conviction as it is used in South Dakota, as well as using 24/7 in place of the ignition interlock.

DOMESTIC VIOLENCE DIVERSION PROGRAM:

Valerie Stuart is now the diversion coordinator for the District Attorney's office. An application to reapply for the misdemeanor grant was circulated for approval signatures.

DRUG DIVERSION PROGRAM:

350 people have been assessed for the program with 181 found eligible. There are 68 current participants, 49 have declined the program and 63 are pending a decision. As of September, 2013 there have been no revocations from the current program. The program has been expanded to allow for non-Winnebago County residents to participate.

JUVENILE TREATMENT COURT:

The formal Juvenile treatment court has ended. Those in need of the juvenile treatment program will be serviced through Winnebago County Human services.

STEP UP PROGRAM:

No update available.

Drug Court Recidivism Rates 2007 – 2012

From the inception of the drug court program on January 1, 2006 until our most recent graduation ceremony on December 6, 2013 there have been a total of 133 participants. Those who have completed drug court successfully are considered “graduates”. Those who have not completed are divided into two groups. Participants who have absconded while in drug court are considered “withdrawn” whereas those who have had behavioral issues (such as accruing new charges) are considered “terminated”.

Withdrawn Rate of Reoffending	82%
