- 1. Call to Order: P. O'Brien called the meeting to order at 9:01 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the May 20, 2015 agenda, with one adjustment to move Item 9 between Items 5 and 6, made by D. Nelson and seconded by J. Finch. Motion carried 7-0.
- 3. Public Comments on Agenda Items: None.
- 4. <u>Announcement/Communications:</u> J. Rabe distributed invitations to the Solid Waste Management Board (SWMB) Members for the Tri-County Single Stream Recycling Facility Open House on Saturday, June 13, 2015, 9:00 a.m. Noon. J. Rabe explained that Staff will host facility tours for Elected Officials from 9 a.m. 10 a.m. and for the general public starting at 10 a.m.
- 5. <u>Approval of Minutes May 6, 2015 Open Session:</u> Motion to approve the May 6, 2015 open session minutes, made by J. Finch and seconded by G. Konrad. Motion carried 7-0.

- 9. <u>Discussion/Action Award for Electronics Recycling Services (SW06-15):</u> J. Semrau presented the following summary for Electronics Recycling Services (SW06-15) to the SWMB:
 - Sims Recycling Solutions (current vendor) declined to extend the electronics waste recycling contract that expires June 30, 2015.
 - Brown, Outagamie and Winnebago County (BOW) Staff developed a Request for Proposal (RFP) document to solicit pricing for Electronics Recycling Services.
 - The Electronics Recycling Services RFP (RFP) was issued on behalf of the BOW to attract competitive pricing from vendors (combined, BOW recycles ~1 million lbs. of electronics per year).
 - The RFP was structured to accommodate site-specific operations for each county.
 - Outagamie County (OC) and Winnebago County (WC) require vendor spotted trailers.
 - o Brown County (BC) stores palletized materials and live loads trailers.
 - o BC requested pricing for optional materials.
 - The RFP was published on April 8, 2015 and distributed to Wisconsin Department of Natural Resources (WDNR) E-Cycle Wisconsin registered Recyclers (BOW Facilities are certified as Collectors through E-Cycle Wisconsin and must use registered Recyclers to comply with certification standards).
 - BOW Staff issued an RFP Addendum on April 23, 2015 to answer vendor questions.
 - RFP responses were due by April 27, 2015 and resulted in three quotes.
 - J. Semrau presented the following Electronic Recycling Services (SW06-15) Proposal Tally to the SWMB.

^{*}Eligible electronic devices (EEDs) are defined by E-Cycle Wisconsin as consumer computers, consumer printers, televisions, laptops and computer monitors, computer peripherals, fax machines, DVD players and VCRs.

- J. Semrau explained to the SWMB that:
 - Previously, the marketplace for EEDs allowed Recyclers to credit Collectors for recycled electronics; the marketplace has since transitioned to charging Collectors per pound for recycled electronics. Contributing factors include:
 - The global marketplace for cathode ray tube (CRT) unit (older tube televisions) processing has been reduced to one smelter located in India (for glass to glass application).
 - o Overall, recycled material commodity markets are low.
 - The marketplace is saturated with recycled electronics so Manufacturers are paying Recyclers less for the recycled materials.
 - BOW used Universal Recycling in the past and recently toured Dynamic Recycling and R3NEW's facilities; all three facilities can handle the RFP requirements and vendor reference checks returned favorable.
 - The RFP gives BOW the ability to award Electronics Recycling Service contracts to multiple vendors.
 - BOW Staff recommend awarding Electronics Recycling Services (SW06-15)
 contracts to Universal Recycling for the BC Facility because it offers BC the best site
 specific rate, and to R3NEW for the OC and WC Facilities because it is a local
 vendor (Town of Menasha) that offers competitive rates.

Discussion ensued amongst the SWMB members.

Motion made by J. Finch and seconded by G. Konrad to Award the Electronics Recycling Services (SW06-15) contract to R3NEW for the WC SWMB Facility at \$0.15/lb for Mixed-EED and Non-EED recycling with a 53' vendor spotted trailer. Motion carried 7-0.

6. <u>Discussion – Landfill Gas Operations Report:</u> J. Rabe updated the SWMB with the following landfill gas operations report.

- Landfill gas-to-energy engine meter operational hours and one-week runtime have been added to the Landfill Gas Operations Report.
- Engines #1, #2, #3 and #5 are running at full load with intermittent use of the Sunnyview Flare to burn excess landfill gas (control odors).
- WPS/Highway Revenues are \$273,153 for April 2015. 2015 revenues are down slightly compared to 2014 due to the unexpected downtime for shortblock replacement in Engines #4 and #5.

Discussion ensued amongst the SWMB.

- 7. <u>Discussion/Action Authorization of Engine #4 Repairs:</u> J. Rabe presented the following Engine #4 Repairs timeline to the SWMB.
 - April 14, 2015 Damage found by Maintenance Technician during a 30,000 hour rebuild.
 - April, 21, 2015 Inland Techs on site confirmed the journal bearing failure damaged the crankshaft. Inland recommended replacement of the shortblock.
 - April 22, 2015 Inland provided SWMB Staff a price quote with four (4) repair options: Emergency Block, Shortblock, Premium Shortblock and Longblock. SWMB Staff and Maintenance Techs determined that a premium shortblock would be best option (based on availability and best match to the engine rebuild schedule). SWMB Staff also determined that air inbound freight was desired to expedite the repair. The premium shortblock quote is \$429,350 (includes a \$90,000 refundable core credit). SWMB Staff anticipate a total repair cost of approximately \$330,000.
 - April 29, 2015 J. Rabe approved the order for a premium shortblock with air inbound freight.
 - May 4, 2015 K. Pernsteiner issued a Purchase Order to Inland Power Group in the amount of \$429,349.79 for the premium shortblock replacement.
 - The premium shortblock is expected to arrive in the U.S. during the week of May 18, 2015. Installation is expected to begin in early June 2015.

Discussion ensued amongst the SWMB.

Motion made by P. Eisen and seconded by J. Finch to authorize SWMB Staff to move forward with the Engine #4 Repairs. Motion carried 7-0.

8. <u>Discussion/Action – 2014 Financial Report:</u> J. Rabe explained to the SWMB that the 2014 Financial Report is still being audited but the Finance Department expects it to be finalized without changes. K. Pernsteiner presented the 2014 Statement of Revenues and Expenses (Unaudited) to the SWMB as follows:

K. Pernsteiner reviewed the major changes between 2013 and 2014 amounts with the SWMB.

J. Rabe explained to the SWMB that reduced incoming waste, a decrease in power sales and the depreciation and amortization adjustment that occurred in 2013 (resultant from the transition of running the BOW Co-Disposal site to Transfer Station operations), along with a market adjustment to the Interest Income, created large fluctuations in revenues and expenses

from 2013 to 2014. J. Rabe further explained that overall, revenues and expenses were down in 2014 and are expected to be more representative of future budgeting.

Discussion ensued amongst the SWMB.

J. Rabe explained to the SWMB that the Snell Road Long Term Care (LTC) funds were moved into the Sunnyview Landfill LTC account. 2015 changes to the Restricted Investments will include splitting the Sunnyview LTC account into an active landfill account for the Sunnyview Sludge Site and an inactive landfill account for the Sunnyview Co-Disposal Site.

Discussion ensued amongst the SWMB.

Motion made by P. Eisen and seconded by G. Konrad to accept the 2014 Financial Report as presented by K. Pernsteiner. Motion carried 7-0.

- 10. <u>Discussion/Action Changes to 2015 Standard Rate Schedule:</u> J. Rabe explained to the SWMB that Staff anticipate recent contract rate changes for Recycling of Asphalt Shingles and Electronics Recycling Services will impact the 2015 Standard Rate Schedule. SWMB Staff recommend the following rate changes to the 2015 Standard Rate Schedule (effective July 1, 2015):
 - \$30.00/Ton <u>Asphalt Shingles</u> Clean asphalt shingles (Non Asbestos) from residential dwellings of (4) units or less and must be free from cedar shakes, wood, metal and other residential debris/trash. All weighed vehicles over 500 lbs. are prorated at \$30.00/Ton with a \$10.00 minimum charge.
 - \$20.00/Each <u>Televisions</u> 32" or greater (measured diagonally) (Residential Only Limit 4)
 - \$15.00/Each <u>Televisions</u> Less than 32" (measured diagonally) (Residential Only Limit 4)
 - \$5.00/Each <u>Computers/Electronics</u> Monitor, laptop, CPU, printer, DVD player or VCR (Residential Only Limit 4)
 - K. Pernsteiner explained that SWMB Staff would like to incentivize asphalt shingle recycling by offering a significantly lower rate than the standard general refuse tipping fee (\$40.00/ton) and the construction & demolition material tipping fee (\$36.00/ton). The current asphalt shingle tipping fee is \$36.00/ton. The 2015 SWMB Recycling of Asphalt Shingles Contract (SW03-15) with SPS Roofing allows for a cost savings that can be passed onto customers.
 - J. Semrau explained that long-term changes to the E-Waste marketplace have had a significant impact on material handling and recycling fees. SWMB Staff sampled weights and quantities of TVs and electronics collected at the WC Facility to estimate electronics recycling costs. SWMB Staff recommend increasing collection fees on all Televisions and

Computers/Electronics to meet the increase in vendor recycling fees. The current collection fees are as follows: Televisions 32" or greater (measured diagonally) are \$10.00 each; Televisions less than 32" (measured diagonally) are \$5.00 each; and Computers/Electronics are \$2.00 each.

Discussion ensued amongst the SWMB.

Motion made by D. Nelson and seconded by J. Finch to accept the Changes to 2015 Standard Rate Schedule (effective July 1, 2015), as presented by SWMB Staff. Motion carried 7-0.
