- 1. Call to Order: P. O'Brien called the meeting to order at 9:01 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the December 18, 2013 agenda, made by J. Finch and seconded by P. Brennand. Motion carried 8-0.
- 3. Public Comments on Agenda Items: None.
- 4. Announcement/Communications: D. Nelson announced to the Solid Waste Management Board (SWMB) that he recently attended a meeting for Battle on Bago where he had a conversation with a number of parties who were interested in the Snell Road Landfill Nature Center project. D. Nelson reported that Wisconsin Department of Natural Resources (WDNR), Battle on Bago, Boy Scouts of America and Boys & Girls Clubs of America may be potential resources for the SWMB when further discussion of the Snell Road Landfill Nature Center project occurs.

- 5. <u>Approval of Minutes December 4, 2013 Open Session:</u> Motion to approve the December 4, 2013 open session minutes made by J. Finch and seconded by P. Brennand. Motion carried 8-0.
- 6. <u>Discussion Landfill Gas Operations Update:</u> J. Rabe updated the SWMB on the landfill gas operations, WPS revenues, Air Permit and projects as follows:

- Operations Summary Problem with Engine #3 vibration issues (camshaft/lobe) and currently running at a reduced load; may require a block replacement; Inland is researching block configurations, prices and availability of parts.
- WPS/Highway Revenues \$280,824.09 for November 2013. Revenues continue to be on target for 2013 estimate of ~\$3 Million.
- Q4 SEM completed week of December 2, 2013 through December 6, 2013. Sunnyview Landfill had 7 exceedances and Snell Road Landfill had 6 exceedances. All exceedances passed 10-day remonitoring after corrective actions were taken. 30-day remonitoring remains.
- Air Permit WDNR held a follow-up meeting on Tuesday, December 10, 2013 and determined that a Notice of Violation would be issued for exceeding Formaldehyde emissions standards. J. Rabe is still waiting for the official document.
- p-BACT Analysis p-BACT has yet to be approved by WDNR and does not appear to fit the SWMB site due to our current power purchase agreement. SWMB Staff will need to prepare a site specific BACT analysis by January 27, 2014 per WDNR air compliance evaluation report (90 day deadline). Foth is currently working on the site specific BACT analysis.

Discussion ensued amongst the SWMB members.
