**New Business:** Explanation of mechanics of VSC. Chapter 45 area of State Statute governing the Commission distributed. Robert briefly explained how application process, etc. works. Commission addresses issue of financial urgency. Not meant as an income augmentation. Bob Warnke again spoke on habits of some folks continually coming back for further assistance. Wants to make effort to get some moneys paid back. Robert will instruct office staff to try and make more of an effort in this area and do some follow-up in a few months. Tom Snider would like to see initials of benefit specialist taking the

application and the client in this area. Robert will also be talking with staff regarding changes to the application and incorporating VIMS comments. This will allow history of assistance in summation. Also discussion on taking social security number off applications. VSC Guidelines distributed. Everyone to look at and will be reviewed at next meeting.

December CVSO and 2011/2012 comparison distributed. Robert briefly detailed. Federal figures state that over \$40 millions dollars are brought into the county through benefits that are done at the CVSO office.
