Old Business: Jim Romnek will be involved in the selection process for the new CVSO. Again asked that if the Commissioners have any questions they wish to have posed to the candidates, they get to him before process starts. The job posting will be up until 1/16/15. Robert detailed process.

New Business: Several CVSO reports distributed to include: December 2014, comparison of 2013-2014 and cumulative report from 2008 to the present. Significance of last report is Robert's tenure at office. It was noted that deaths are down in 2014. This is because of the rate of death of the WWII veterans and the shear number of veteran going down. Choice Card also briefly explained. Many veterans enrolled in VA Health Care have received but few will be authorized to use. Have to be outside of a 40 mile radius from a VA Medical Facility or the VA can not get the veteran in for a "medically necessary" appointment within 30 days. Before the card is utilized, it has to be activated.

This is 3 year program or until the end of the money allocated. Joe again asked if a previous year comparison could be done on a monthly basis.
