WINNEBAGO COUNTY BOARD OF SUPERVISORS JUNE 2, 1998 SPECIAL ORDERS OF BUSINESS

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the Fourth Floor County Board Room, Winnebago County Courthouse, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an Invocation by Supervisor Wagner. Motion by Supervisor Robl and seconded to adopt the agenda. CARRIED BY UNANIMOUS VOICE VOTE.

COMMITTEE REPORT

Supervisor Wagner reported that additional lighting will be installed in the parking lot at the Oshkosh Human Services Building. Employees are concerned about how dark the parking lot is when they have to leave the building at night. She also reported that the Property Management and Maintenance Committee met with Sheriff Brooks and Officer Puesthol, Oshkosh Police Department, in regards to storage space at the old highway building for equipment shared by the two departments. Currently, they are not paying for the use of the building. In 1999, they will start paying rent for the use of this building.

They also met with Mr. Rasmussen, City of Oshkosh, regarding the purchasing or renting of the salt sheds at the old highway building. In addition, they met with people from the ice arena about their needs for additional acreage. They also met with the citizens committee on the future of the Vulcan Quarry. The owners of the quarry would like to start making plans to develop the quarry as a lake for recreational activities. Supervisor Wagner explained that no decisions have been made regarding the county-owned property in this area. She anticipates having the Parks & Recreation Committee involved in the future. The quarry owners need to know what the county's plans are, because they need to start making their preparations. Because of the costs that would be involved in a project of this nature, she would like to invite the owners of the quarry to make a presentation to the Board.

Chairman Maehl thanked all the people who attended the Sesquicentennial bell ringing celebration at the Courthouse on Friday, May 29. The Sesquicentennial flag was raised and dedicated, as was the new flag pole at the back entrance of the Courthouse. He explained that the flag pole was dedicated to all past and present citizens who participated in any wars or served in the armed services.

Supervisor Barker reported that she attended the State's Sesquicentennial bell ringing ceremony in Madison. She was proud to represent the County and participated in the official county role call. The role call was done by the year inwhich the counties were created. Winnebago County was the twenty-third county created in Wisconsin. There were many activities, including the presenting of the colors and speeches, and a fly over by 115th Thunder Blue Wisconsin Air National Guard. Governors Thompson, Dreyfuss and Lucy cut the giant, Wisconsin-shaped birthday cake. 10,000 people were served cake and milk.

Environmental Protection Agency's National Priorities

(Superfund) List

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisor's that it hereby opposes the addition of a 39 mile stretch of the lower Fox River to the United States Environmental Protection Agency's National Priorities (Superfund) List.

BE IT FURTHER RESOLVED, by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to transmit a copy of this resolution to the United States Environmental Protection Agency, c/o Timothy Fields; to the Office of Congressman Thomas Petri; to the Offices of United States Senators Russell Feingold and Herbert Kohl; and to the Office of Governor Tommy Thompson.
