The Sheriff's Department, municipal police and fire departments, the State Patrol and others are involved in this event.

Supervisor Wagner commended the Sesquicentennial Committee for their work on the fair and the parade.

Supervisor Sundquist reported that the Public Safety Building Board had their budget meeting with the County Executive. They are 1% below their 1998 budget. He reported that they are having problems with the building's heating and air-conditioning systems. Supervisor Sundquist reported that the increase in the jail population and in the number of people who work in the safety building are a factor in these problems. He reported that they are making some changes and studying the situation.

COUNTY EXECUTIVE APPOINTMENTS

Winnebago County Housing Authority

Executive Van De Hey asked for the Boards approval of her appointment of Ralph Kennedy, Evans Title Companies, Inc., 330 West College Avenue, Appleton, Wisconsin to the Winnebago County Housing Authority. He will fill the unexpired term of Gerald Wagner. Mr. Kennedy's term will begin immediately and expire on April 18, 2000. Motion by Supervisor Hue and seconded to approve. CARRIED BY UNANIMOUS VOICE VOTE.

COUNTY BOARD CHAIRMAN'S REPORT

Chairman Maehl commended the Fair Association on another successful fair. He commented on the numerous events that are held in August, such as the EAA and the fair. Chairman Maehl shared other historic events that happened in August, such as: in 1898 President McKinley signed a treaty that ended the Spanish-American War; and in August, 1914 World War I began.

Chairman Maehl told the Board that a granite stone and plaque has been placed at the base of the flagpole at the back entrance of the Courthouse. The plaque indicates that the flagpole is dedicated to any Winnebago County citizen who served in a war.

Chairman Maehl then reported that he went through the County Board's last 110 years of proceedings and discovered that a U.S. Senator has never addressed this Board. At this time, he introduced U.S. Senator Russell Feingold to the County Board.

ADDRESS BY SENATOR RUSS FEINGOLD

Senator Feingold thanked Chairman Maehl for inviting him to speak to the Board. He commended the Board for their commitment to "Wisconsin's tradition of open government." He told the Board that he has upheld is campaign promise to visit every Wisconsin county each year of his six year term and hold "town meetings." He reported that tomorrow he will reach is goal of 432 "town meetings". He said that the sessions he's held in Winnebago County have been, "very lively." He said that Winnebago County, "is a very vibrant county, and one that is absolutely basic to the economic power of this State." He said that his past experiences as a State Senator makes him very comfortable working with county level government and he realizes the important role it plays in the lives of its citizens.

One of the issues that Senator Feingold spoke about was the importance of reducing the nation's deficit and balancing the Federal budget. He said that at the county level, spending is closely monitored; however, in Washington, D.C., that isn't always the case. In his efforts to try to change this, he has worked to eliminate outdated and unnecessary programs. In addition, he has co-authored a bill with Senator Hollings that will prohibit the Federal Government from using Social Security funds to lower the deficit.

Another issue that Senator Feingold spoke on was campaign finance reform. He thanked the Board for their resolution supporting the McCain-Feingold Bill. He said that this is the first bi-partisan campaign finance reform bill in 10 years. He said that the President is waiting to sign it, but there are a few Senators who are, "standing in the way." He said that campaign finance limits that were created after Watergate have been destroyed. A "soft money" loophole has made it possible for PAC's, labor unions and others to make huge contributions.

Senator Feingold also spoke to the Board about Wisconsin's dairy industry. He is working to change unfair and outdated federal regulations that date back to the 1930's. He told the Board that Wisconsin farmers receive \$3 to \$4 less per 100 pounds of milk than a dairy farmer in Vermont, Texas or Florida. He said there isn't enough representation in Wisconsin and Minnesota to generate change in Congress, but there are other things that could generate change. One thing is the lawsuits that are going through the appeals courts in Minnesota and St. Louis. Senator Feingold said the Minnesota Appeals Court said that this system is, "just plain illegal." The other thing that could change these regulations is the support of the Secretary of Agriculture, Daniel Glickman. Secretary Glickman has visited Greenleaf, Wisconsin and told the farmers that this system is outdated and has made a preliminary proposal that, "would begin to narrow the difference."

Senator Feingold said that some members of the House of Representative didn't like Secretary

Glickman's proposal and they tried to change it. Senators Kohl and Feingold had those anti-Wisconsin changes removed from the Senate bill and got the bill passed. This is a very important time for Wisconsin dairy farmers. He told the Board that since 1980, Wisconsin has lost gone from 45,000 to 25,0000 dairy farmers.

Senator Feingold told the Board that he was honored to speak with them during Wisconsin's Sesquicentennial year and that is has been a privilege to serve as their U.S. Senator.

Senator Feingold took questions from the Board.

Chairman Maehl presented Senator Feingold with a Winnebago County flag, which he has agreed to hang in his Washington, D.C. office.

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 21.05(3) and (4) of the General Code be amended to read as follows:

21.05 RATES AND CHARGES

(3) LAND RENTAL RATES. Land on the premises of Wittman Regional Airport, subject to approved developmental and use criteria, shall be rented at the following rates:

Owners of private (non-commercial) hangars who are not subject to commercial minimum standards shall be assessed a premium of 30% of the annual land rental rate if they elect to utilize airport sanitary sewer and water facilities.

RESOLUTION NO. 82-898: Resolution Authorizing the Borrowing of Not to Exceed \$10,000,000; and Providing for the Issuance and Sale of General Obligation

Promissory Notes Therefor

WHEREAS, the County Board of Supervisors of Winnebago County, Wisconsin (the "County") hereby

finds and determines that it is necessary, desirable and in the best interest of the County to raise funds for the purpose of paying the cost of acquiring and installing computer hardware, software and systems; constructing and/or renovating and improving various new and existing County buildings, sites and facilities; constructing, improving and/or relocating roads, walkways and utilities; and acquiring equipment furnishings and fixtures (the "Projects"), and there are insufficient funds on hand to pay said costs;

WHEREAS, the County Board of Supervisors hereby finds and determines that the Project is within the County's power to undertake and therefore serves a "public purpose" as that term is defined in Section 67.04(1)(b) of the Wisconsin Statutes;

WHEREAS, counties are authorized by the provisions of Section 67.12(12) of the Wisconsin Statutes to borrow money and to issue general obligation promissory notes for such public purposes; and

WHEREAS, the County Board of Supervisors of the County hereby finds and determines that general obligation promissory notes, issued in one or more series, in the aggregate amount of not to exceed \$10,000,000 should be issued, and it is now necessary and desirable to authorize their issuance and sale.

NOW, THEREFORE, BE IT RESOLVED by the County Board of Supervisors of the County that:

<u>Section 1. Authorization of the Notes</u>. For the purpose of paying the cost of the Project, there shall be borrowed pursuant to Section 67.12(12) of the Wisconsin Statutes, the principal sum of TEN MILLION DOLLARS (\$10,000,000) from a purchaser or purchasers to be determined by competitive sale (the "Purchaser").

Section 2. Sale of the Notes. To evidence such indebtedness, the Chairperson and County Clerk are hereby authorized, empowered and directed to make, execute, issue and sell to the Purchaser for, on behalf of and in the name of the County, general obligation promissory notes, issued in one or more series, aggregating the principal amount of TEN MILLION DOLLARS (\$10,000,000) (the "Notes"). There be and there hereby is levied on all the taxable property in the County a direct, annual tax in such years and in such amounts as are sufficient to pay when due the principal and interest on the Notes.

Section 3. Notice of Sale. The County Finance Director (in consultation with the County's financial advisor, Robert W. Baird & Co. Incorporated) is hereby authorized and directed to cause a notice of sale to be published at least once in either the Oshkosh Northwestern, the official newspaper of the County, or in The Bond Buyer, a financial newspaper published in New York, New York, prior to the date set for the sale of the Notes.

Section 4. Official Notice of Sale. The County Finance Director (in consultation with the County's financial advisor, Robert W. Baird & Co. Incorporated) shall also cause an Official Notice of Sale to be prepared and distributed and may prepare or cause to be prepared and distributed an Official Statement or other form of offering circular.

<u>Section 5. Award of the Notes.</u> Following receipt of bids for the Notes, the County Board of Supervisors shall consider taking further action to provide the details of the Notes and to award the Notes to the lowest responsible bidder or bidders therefor.

Section 6. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the County Board of Supervisors or any parts thereof in conflict with the provisions hereof shall be, and the same are, hereby rescinded insofar as the same may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.
