ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, DECEMBER 21,1999

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Wagner.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey presented Chuck Orenstein, Finance Director, with the 1999 Distinguished Budget Presentation Award from the Government Finance Office Association. She congratulated Mr. Orenstein and thanked him for his excellent work on the county's annual budget.

Executive Van De Hey extended wishes for a happy holiday season to the Board.

COUNTY BOARD CHAIRMAN'S REPORT

Chairman Maehl presented the composite photos of the 1999 and 1899 Winnebago County Boards to the supervisors. It will be hung in the Courthouse lobby.

Chairman Maehl extended "happy birthday" wishes to Supervisors Koziczkowski, Brennand and Wingren and to Don Wilmot, Emergency Government Director.

Chairman Maehl asked that the Board take notice of the George Washington handout provided by the Winnebago County Public Libraries that was included in their packet. In commemoration of the bicentennial of George Washington's death, the library has put together a bibliography of works on George Washington that are available in the county's libraries.

Chairman Maehl reported that the Wisconsin Counties Mutual Insurance Corporation has informed us that the Winnebago County Highway Department has the best loss ratio of the 55 participating counties.

Chairman Maehl reported that two of the four Neenah TIF Districts have been dissolved 2.5 years early. As a result of this, Winnebago County received \$89,000.

Chairman Maehl told the Board about the article in the December 20 <u>Post Crescent</u> acknowledging Supervisor Griesbach for his many years of service to the City of Menasha and Winnebago County. Chairman Maehl extended Winnebago County's thanks to Supervisor Griesbach for his years of service.

Chairman Maehl reported that Supervisor Brennand has made a \$25.00 contribution to the Winnebago County Scholarship Fund. He thanked Supervisor Brennand for his generosity.

Chairman Maehl read a letter from a person who wishes to remain anonymous, announcing their donation of \$1,000 to the Winnebago County Scholarship Fund in honor of John Planalp, a retired Winnebago County Board Supervisor, for his "magnificent example of public service."

WINNEBAGO COUNTY Y2K READINESS - DON WILMOT, EMERGENCY GOVERNMENT DIRECTOR

Don Wilmot, Winnebago County Emergency Government Director, reported that because of advanced planning by the private sector and federal, state and local governments, Y2K problems on January 1 should be minimal. He explained that the problems people are concerned about, such as power outages, failures at medical facilities, ATM failures, no telephones, etc., are all situations that we've experienced before and know how to handle. The people who are responsible for all these systems are very competent and have been preparing for this event for a number of years.

Mr. Wilmot explained that shelters will be opened if needed. He also reported that starting at 8:00 p.m. on New Year's Eve, an Emergency Operation Center will be partially activated so that if an emergency arises, they will be ready.

Sheriff Brooks explained that many of the Y2K concerns are situations that Winnebago County has faced and addressed in the past, such as the failure of the 911 Center in 1998. He reported that arrangements have been made for supplemental power in case power from Wisconsin Public Service is lost. Sheriff Brooks also reported that emergency numbers will be published in the newspaper in the event the 911 Center would fail.

Both Mr. Wilmot and Sheriff Brooks reported that they have "backups to backups to backups" and reassured the Board and the public that Winnebago County is prepared for any Y2K situations.
