## ORGANIZATIONAL SESSION COUNTY BOARD MEETING

#### **TUESDAY, APRIL 18, 2000**

County Clerk Sue Ertmer called the meeting to order at 6:00 P.M. in the Supervisors' Room, Fourth Floor, Courthouse, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an Invocation by Supervisor Rankin.

County Executive Van De Hey congratulated the Supervisors on their election to the board. She told the Board that courthouse security, communication towers, 911 upgrade, comprehensive land-use plan, re-design of long-term health care and Human Services Department implementation are some of the major issues facing Winnebago County. She also stated that she looks forward to working with them on these issues and encouraged them to come to her office and speak with her if they have any questions or comments.

Judges Bruce Schmidt, Barbara Key and William Crane were introduced to the Board. Judge Crane then administered the oath of office to the supervisors.

After commenting that he is retiring when his term expires in July, Judge Crane received a standing ovation from the Board.

Judges Schmidt and Key congratulated the Board on their election.

Printed ballots were distributed to the Board. After voting, the Supervisors' ballots were collected and counted. The final results were 28 votes for Supervisor Maehl, 7 votes for Supervisor Schaidler and 1 write-in for Supervisor Albrecht. Supervisor Maehl was seated as Chairman.

Chairman Maehl thanked the Board for their support and assured them that he would work in the best interest of Winnebago County.

### **ELECTION OF COUNTY BOARD VICE CHAIRMAN**

Chairman Maehl called for nominations for Vice Chairman.

Motion by Supervisor Robl and seconded to nominate Supervisor David Albrecht as Vice Chairman.

Motion by Supervisor Diakoff and seconded to nominate Supervisor Patrick Brennand as Vice Chairman.

Motion by O'Brien and seconded to close nominations for Vice Chairman.

Printed ballots were distributed to the Board. After voting, the Supervisors' ballots were collected and counted. The final results were 26 votes for Supervisor Albrecht and 10 votes for Supervisor Brennand. Supervisor Albrecht was seated as Vice Chairman.

Vice Chairman Albrecht thanked the Board for their support and assured them that he would serve to the best of his ability.
