SOLID WASTE MANAGEMENT BOARD COOPERATIVE RECYCLING & DISPOSAL PLAN

Pat O'Brien, Chairman of the Solid Waste Management Board, and Len Leverence, Solid Waste Director, explained the tri-county cooperative recycling and disposal plan.

In his power point presentation, Mr. Leverence explained the following:

- The plan includes Brown, Outagamie and Winnebago Counties. Brown and Outagamie Counties have approved the plan.
- Regionalization will:
 - improve government's ability to meet citizens' needs
 - increase economy of scale
 - maximize existing assets
 - provide operational savings
- Combining the three counties' operations will reduce landfill and recycling facilities equipment and staffing costs.
- Cooperative Plan three processing facilities will become two by:
 - Closing Winnebago County's recycling facility and turning it into a transfer facility. The new transfer facility will continue to receive all of Winnebago County's communities' recyclable materials, but paper will be transferred to Outagamie County for processing and co-mingled products (glass, plastic, etc.) will be transferred to Brown County.
 - Outagamie County will process Winnebago County's and their own recyclable paper products (Brown County doesn't process paper products—it's sent directly to the paper mills for recycling.)
 - Brown County will process all three counties co-mingled products.
- One landfill will be used at a time until it is filled. The schedule is as follows:

- 1. Outagamie County's East Landfill 2003-2004
- 2. Winnebago County's Sunnyview Landfill 2005-2011
- 3. Outagamie County's Northeast Landfill 2012-2020
- 4. Brown County South Municipal Landfill 2021-2027
- Plan Administration
 - This is not a merger—each county will retain its own budget, solid waste management boards/committees and customers
 - Does not include household hazard waste programs, landfill gas recovery programs or maintenance of closed landfills
- Economy of scale As tonnage increases, your fixed costs decrease. Each county will see an approximate 25-30% decrease in operating costs.
- Annual savings for Winnebago County in the 12-year recycling program will be approximately \$212,000.
- Annual savings for Winnebago County in the 25-year landfill disposal program will be approximately \$514,000.
- Annual savings for all three counties under the 12-year recycling program is approximately \$693,000.
- Annual savings for all three counties under the 25-year landfill disposal program will be approximately \$1,420,000.
- By they year 2011, there will be a 33% reduction in personnel needs.
