NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors that item #5 of Resolution 156-297 be, and hereby is amended to read as follows:

5. Following the successful completion of a one-year probationary period, the person appointed to the position of Chief Deputy Sheriff shall enjoy tenure in the position at the pleasure of the Sheriff and, upon removal from such position for reasons other than misconduct, shall be eligible to be immediately placed in a vacant subordinate management position within the Sheriff's Department.

RESOLUTION NO. 357-122001: Establish County Policy So As to Allow County Employees Access to Courthouse and Tunnels Between the Courthouse and the Public Safety Building and Orrin H. King Building Without Passing Through Security Check Points

WHEREAS, employees of Winnebago County, and specifically those assigned to offices within the Courthouse, the Orrin H. King Building, the Public Safety Building and the District Attorney's Office, ingress and egress the Courthouse on numerous occasions each day; and

WHEREAS, those employees, as well as all Winnebago County employees, have been subject to a criminal background check by the Winnebago County Human Resources Office prior to employment; and

WHEREAS, most of these employees are charged with the duty of running the courts, courtrelated offices, and important County offices and the utmost trust of the community is placed in said employees; and

WHEREAS, to the best of your undersigned Supervisor's knowledge, no Winnebago County employee has ever made a threat upon the Court or anybody within the Winnebago County Courthouse with a weapon; and

WHEREAS, it is your undersigned Supervisor's belief that any risks with regard to employees harming fellow employees or assisting others so as to breach court security are infinitesimal, at best; and

WHEREAS, the continued practice of subjecting County and court-related employees to continued search upon entering the Winnebago County Courthouse is time consuming and costly and results in inconvenience to the public and to employees and hinders them from accomplishing their jobs; and

WHEREAS, the current practice of closing the tunnels to the Courthouse to Winnebago County employees adds nothing with to promoting court security and results in a major inconvenience to County employees and physically exposes equipment, such as computer equipment, to the elements, which now must be transported outside in order to move such equipment between buildings; and

WHEREAS, a security system presently exists so as to only allow employees possessing computer program cards to enter the tunnels, thus alleviating security concerns.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby establishes the following policy with regard to admission to the Winnebago County Courthouse:

- (1) All Winnebago County employees, elected officials, court officials and District Attorneys, employees of the District Attorney's Office and State Public Defenders shall be issued an identification card by Winnebago County with their photographs upon said card.
- (2) Upon presenting said picture identification card to the security guard within the Courthouse, and the employee being positively identified by the security guard, all employees and officials listed in the preceding paragraph shall be allowed entry to the Winnebago County Courthouse without being subject to a search.
- (3) Those employees and officers described in Paragraph (1) above shall be allowed access and use of the tunnels between the Courthouse and the Winnebago County Public Safety Building and the Orrin King Building through the use of a computer program magnetic card which is issued to that employee. The doors to the tunnel shall remain locked to those not provided such a card.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said policy shall take effect immediately.

RESOLUTION NO. 352-122001: Oppose Reduction of and/or Limitation on County Shares of Fines and Forfeitures Imposed by the Courts Under Chapters 341 Through 347, 349 and 351 of the Wisconsin Statutes

WHEREAS, County dollars, supplies and resources, including law enforcement personnel, court personnel and prosecutorial support staff, are utilized in the enforcement of traffic laws, as well as the prosecution of citations issued for violations of traffic laws, the housing of inmates sentenced to jail for violations of said traffic laws, and the collection of fines and forfeitures imposed by the courts for violations of said traffic laws; and

WHEREAS, despite the foregoing, each county is permitted to retain only a small portion of each fine and forfeiture imposed by the courts and collected by the county for violations of traffic laws, and is required to remand the major share of each fine and forfeiture to the State of Wisconsin; and

WHEREAS, the Joint Finance Committee of the Wisconsin Senate and Assembly recently passed Motion #1058, a proposal which would set a permanent cap on that portion of dollars currently retained by counties for fines and forfeitures imposed by the courts under Chapters 341 through 347, 349 and 351; and

WHEREAS, according to the provisions of Motion #1058, each county would be required to remand to the state Treasurer 100% of any fine and forfeiture funds collected by it after the cap was met, and the monies collected in excess of their respective caps would be utilized, in part, to fund Assistant District Attorney positions in fourteen counties; and

WHEREAS, fines and forfeitures represent a legitimate funding source which assists county efforts to control tax levies and benefits county taxpayers; and

WHEREAS, Motion #1058 seeks to place a cap on a source of county revenue while county expenditures continue to grow; and

WHEREAS, the funding mechanism proposed in Motion #1058 is inherently unfair to the 58 counties which will be required to contribute county monies to fund the Assistant District Attorney positions awarded to the remaining fourteen counties in the State, and because it represents a significant policy change in that it initiates the return of the cost for District Attorneys and Assistant District Attorneys, now a state funded program, back to the counties, to be funded with dollars collected at the local level.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby goes on record opposing Motion #1058 and any and all substantially similar proposals, and requests that the Legislature and Governor of the State of Wisconsin not accept or pass said motion, or any substantially similar proposal of legislation; and

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Winnebago County Clerk is hereby directed to forward a copy of this resolution to the Governor of the State of Wisconsin, all legislators representing constituents within Winnebago County and the Wisconsin Counties Association.

WHEREAS, the operating levy is that portion of the Count levy which is utilized for operating purposes including salaries, fringe benefits, and other non debt operating costs excluding special purpose levies; and

WHEREAS, the percentage increase in the operating levy rates is limited by the percentage increase in the County's equalized valuation; and

WHEREAS, all Wisconsin counties and private businesses have experienced double digit increases in health care costs over the past several years; and

WHEREAS, Wisconsin Counties have minimal control over the dramatic rise in health care costs for employees; and

WHEREAS, the State of Wisconsin should recognize the problems caused by rising employee health care costs and modify the law to afford counties immunity from employee health care costs increases in computing the operating tax levy rate.

NOW, THEREFORE, BE IT RESOLVED that the Winnebago County Board of Supervisors respectfully requests the State Assembly and Senate to draft and enact legislation to provide for exemption of employee health costs increases from the formula for computing the County operating tax levy rate.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of the resolution be transmitted to Governor Scott McCallum, State Senators and State Assembly Representatives representing Winnebago County constituents and to the Wisconsin Counties Association.

RESOLUTION NO. 359-122001: Support Assembly Bill 547 and Senate Bill 271 (Resource Protection Bill)

WHEREAS, under current law, the Department of Natural Resources regulates the mining of metallic minerals. Under those laws, the DNR promulgates rules to regulate metallic mining, the storage and disposal of solid waste and hazardous waste and the granting of exemptions with regard to the above

matters; and

WHEREAS, Assembly 547 and its companion Senate Bill 271 would prohibit the DNR from granting exemptions from its rules regulating the storage and disposal of solid waste and hazardous waste as they relate to mining waste; and

WHEREAS, said Bill would also require the DNR to regulate any waste from the mining, processing and refining of ores and minerals as a hazardous waste if it has the characteristics of a hazardous waste, not withstanding any federal exclusions; and

WHEREAS, said Bill would also eliminate the exemption of mining activities and facilities, including mining waste sites, from the groundwater quality standards under the groundwater law. Said Bill would also eliminate the separate provision authorizing the DNR to establish groundwater quality standards for mining activities and would also prohibit the DNR from using criteria that provide for a larger design management zones for mining waste facilities than are provided for other solid waste facilities; and

WHEREAS, your undersigned Committee believes that said Bills are an essential step in the delicate balance between a healthy viable economy and the responsible natural resources management plan and that the Bill will provide a reasonable mechanism for all industry in the State of Wisconsin to dispel hazardous waste.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby indicates its support for Assembly Bill 547 and Senate Bill 271.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes and directs the Winnebago County Clerk to transmit a copy of said Resolution to the Office of Governor Scott McCallum; to all Legislators representing constituents within Winnebago County; and to the Wisconsin Counties Association.
