ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, JANUARY 15, 2002

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Rankin. Excused: Savas, Crowley and Finch.

Motion by Supervisor Robl seconded to adopt the agenda. CARRIED BY VOICE VOTE.

COMMUNICATIONS, PETITIONS, ETC.

A "thank you" note from Supervisor Savas was read. She thanked the board for the flowers they sent her during her recent stay at the hospital.

Information was read about an upcoming mini-conference entitled, "Utilizing Historical and Cultural Resources in Community Planning." It will be held on Friday, January 25 at the Pioneer Inn in Oshkosh.

The Board was advised that the Federal mileage reimbursement rate has been raised to 36.5 cents per mile as of January 1, 2002. They should use this rate when figuring their mileage reimbursement.

Supervisor Nielsen asked that the Board look over the information in their packets on Wittman Regional Airport and other aviation issues. Supervisor Nielsen reported that the airport will be on the February 12 Special Orders agenda.

Supervisor Rengstorf asked that the Board look over the cost estimate for moving the courthouse

security check point to the second floor that was placed on their desks.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey reported that she has been meeting with area legislators to discuss the State's \$1 Billion+ deficit and how it will affect Winnebago County. She stated that we may need citizen input in helping to determine which county services can be reduced or eliminated.

Executive Van De Hey reported that some county property has been sold, creating significant revenue to the county. She stated that details of the sale will be presented to the Board at their next meeting.

Executive Van De Hey stated that a consortium of business people are working on a plan for a limited racing season at the Sunnyview Speedzone. More details on this proposal will be presented to the Board at the February or March meeting.

Chairman Maehl announced that John Planalp, a former county board supervisor from the City of Oshkosh, passed away last week. As a memorial to Mr. Planalp, Supervisor Sundquist made a donation to the county's scholarship fund in his name.

TRANSPORTATION PLAN ELEMENT OF THE WINNEBAGO COUNTY COMPREHENSIVE PLAN

RESOLUTION NO. 365-12002: Authorize Lump Sum Payment to the State Retirement System as Partial Payment of Prior Service Liability in the Amount of \$757,000

WHEREAS, Wisconsin Act 11, which went into effect in 2001, gave all participating units of government in the State Retirement System a holiday for making payments for past service liability; and

WHEREAS, said payment holiday to Winnebago County was in relationship to an anticipated payment for 2001 of \$757,000; and

WHEREAS, said payment was budgeted in the 2001 Budget and as a result of said payment not being made during that year, said funds remained on hand at the end of 2001; and

WHEREAS, payment of the sum of \$757,000 to the State Retirement System by January 31, 2002 would relieve the County from paying interest to the State in relationship to the \$757,000 which the State deferred payment of by virtue of the holiday which it granted; and

WHEREAS, said interest would total approximately \$61,000; and

WHEREAS, payment of such a lump sum to the State Retirement System would result in reducing the County's liability toward the State Retirement System as early as 2009 instead of 2014, as was originally anticipated.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes a payment of \$757,000 by Winnebago County to the State Retirement System as a lump sum partial payment of Winnebago County's past service liability, on or before January 30, 2002.

BE IT FURTHER RESOLVED that funds to make the lump sum partial payment shall be transferred from the various funds of Winnebago County as outlined on the attached Budget Transfer Form which is made a part of this resolution by reference.

ORDINANCE NO. 375-12002: Amend Section 11.01, General Code of Winnebago County: County Human Services Board

WHEREAS, the Winnebago County Human Services Board was established pursuant to Chapter 11 of the General Code of Winnebago County on January 1, 2000; and

WHEREAS, subsequent to that date, the County Human Services Board has met on a regular basis; and

WHEREAS, the Winnebago County Human Services Board presently consists of twelve (12) members; and

WHEREAS, because of the size of the Human Services Board, it has become increasingly difficult to schedule meetings wherein a quorum of members was able to be present; and

WHEREAS, the present Human Services Board believes that it would be in the best interests of Winnebago County and its citizens to reduce the number of members on the Human Services Board from twelve (12) to nine (9) members in order to more easily facilitate meetings of said Board; and

WHEREAS, your undersigned Board does not believe that there will be any decrease in the level of effectiveness of the Board as a result of a reduction in the size of the Board.

NOW, THEREFORE, BE IT ORDAINED by the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 11.01(2) and (4) of the General Code of Winnebago County be amended to read as follows:

HEALTH AND SOCIAL SERVICES – CHAPTER 11

11.01 COUNTY HUMAN SERVICES BOARD....

- (2) MEMBERSHIP. The Winnebago County Human Services Board shall consist of nine (9) members. Five (5) members of the Human Services Board shall be members of the Winnebago County Board of Supervisors. Of the four (4) remaining members of the Human Services Board, at least one (1) member shall be an individual who receives or has received human services or shall be a family member of such an individual. The remainder of the County Human Services Board members may be either consumers of services, citizens-at-large or members of the County Board of Supervisors. No public or private provider of services may be appointed to the County Human Services Board.
- (3) **TERM.** (a) All members of the Winnebago County Human Services Board shall serve a term of three (3) years. Three (3) of those members appointed to the Human Services Board shall serve a term which shall expire on December 31, 2002. Three (3) of those members appointed to the Human Services Board shall serve a term which shall expire on December 31, 2003. The remaining three (3) members of Human Services Board shall serve a term which shall expire on December 31, 2004. Vacancies within the Board shall be filled as provided pursuant to Subsections (2) and (3) above. Members of the Human Services Board who are not members of the County Board of Supervisors shall be entitled to a per diem and expense of attendance of Human Services Board meetings in the same amounts as paid to those persons who are members of the County Board of Supervisors.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that this amendment to this Ordinance shall take effect on April 16, 2002.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that those seats on the County Human Services Board abolished as a consequence of this Ordinance shall be those seats most recently held by the following Human Services Board members:

WHEREAS, Evercom would also assume all costs with regard to software updates in relationship to said phone service; and

WHEREAS, said agreement would be for a period of three (3) years with a County option to renew said agreement for an additional three (3) year period; and

WHEREAS, your undersigned Committee recommends that the Winnebago County Board of Supervisors authorize the Winnebago County Executive and Winnebago County Clerk to enter into said agreement

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Executive and Winnebago County Clerk to enter into a three (3) year contract with Ebercom Corporation of Irving, Texas, with an option granted to the County to extend said agreement for an additional three (3) years thereafter, for the provision of inmate telephone services at the Winnebago County Jail and the Winnebago County Huber Center pursuant to those terms described above. (A copy of the proposed agreement may be obtained from the Winnebago County Sheriff.)

Authority to Execute 2001-2002 Labor Agreement with the Winnebago County Highway Department Employees' Union, Local 1903, AFSCME

BE IT RESOLVED, by the Winnebago County Board of Supervisors, that the County Executive and the County Clerk be, and they hereby are, authorized to execute a two-year Agreement on behalf of Winnebago County and the Winnebago County Highway Department Employees' Union, Local 1903, AFSCME, for the years 2001 and 2002, effective January 1, 2001, which Agreement will provide the following major changes from the previous Agreement:

1) WAGES

3.0% across-the-board effective January 1, 2001 1.0% across-the-board effective October 1, 2001 3.0% across-the-board effective January 1, 2002

2) ARTICLE 15 – FUNERAL LEAVE

Add aunt, uncle, niece and nephew to one-day funeral leave eligibility and provide for three day funeral leave use within one week of the day of the funeral.

3) ARTICLE 18 - GROUP HEALTH INSURANCE PROGRAM

Effective with the premium for the month of October, 2001 and thereafter, provide for an employee contribution rate of 5% toward the monthly premium of all plans with maximum employee contribution caps of \$25 per month for single coverage and \$50 per month for family coverage.

4) ARTICLE 21 – HOURS OF WORK

Replace a first shift position of Night Mechanic with a second shift position of Night Mechanic in the Parks Department, with a daily work schedule of eight hours containing a twenty minute paid lunch period, Monday through Friday, commencing at 3:00 P.M. and ending at 11:00 P.M.

Redefine the work schedule of the Night Mechanic in the Highway Department as 2:30 P.M. to 10:30 P.M., Monday through Friday.

In addition to the foregoing, the new agreement provides for minor modifications to the articles covering holiday dates, management rights, recognition and unit of representation, grievance procedure, sick leave with pay, long term disability insurance, vacation scheduling in the Highway Department, duration, and a revision to Appendix A (pay schedules).

BE IT RESOLVED, by the Winnebago County Board of Supervisors, that the Winnebago County

Administrative Salary Schedule be revised for the year 2002, as set forth and described in the document attached hereto; and

BE IT FURTHER RESOLVED, that, in accordance with the "Rules For Administration" the wages of all covered employees, except employees in positions listed on Appendix C (Sheriff's Department and District Attorney's Sworn Administrative Employees) having continuing satisfactory job performance be increased by 3.0% across-the-board effective January 1, 2002 ; and

BE IT FURTHER RESOLVED, that employees in positions listed on Appendix C (Sheriff's Department and District Attorney's Sworn Administrative Employees) having continuing satisfactory job performance be increased by 3.5% across-the-board effective January 1, 2002; and

BE IT FURTHER RESOLVED, that Section B of Chapter 20 (Vacation) of the Handbook of Employment Policies Covering Appointed Non-Represented Employees of Winnebago County be amended as follows:

A) Amend the first part to read as follows (change in bold type):

<u>ELIGIBILITY.</u> All regular full-time and regular part-time employees **except Registered Nurses assigned to Park View Health Center** shall be entitled to paid vacation benefits.

B) Add the following language to the end of this section:

<u>REGISTERED NURSES ASSIGNED TO PARK VIEW HEALTH CENTER.</u> Registered Nurses assigned to Park View Health Center shall be entitled to paid vacation benefits as of January 1 of each year based upon their length of continuous service. For purposes of determining future vacation eligibility, the year of hire shall be treated as a full year of service. Paid vacations shall be provided in accordance with the following:

- 1. <u>YEAR OF HIRE.</u> Persons hired prior to July 1 of any year shall be eligible to use seven work days of vacation during their year of hire subject to approval of their department head and in accordance with department policies governing a minimum waiting period and scheduling.
- 2. <u>THREE WEEKS (15 WORKDAYS).</u> Provided each year following the year of hire through the tenth year of continuous service.
- 3. <u>FOUR WEEKS (20 WORKDAYS).</u> Provided each year following completion of ten years of continuous service through the twentieth year.
- 4. <u>FIVE WEEKS (25 WORKDAYS).</u> Provided each year following completion of twenty years of continuous service.
- C) Revise item 2 of SECTION C GENERAL PROVISIONS, to read as follows (change in bold type):
 - 2. Up to five days of vacation not used in the year in which it is available for use may be converted, at the employee's option, to pay. Such payment shall be made during January of the following year. Except for vacation that is converted to pay, all vacation not used in the year in which it is available for use may be converted at the end of the year to sick leave.

BE IT FURTHER RESOLVED, that Chapter 21 (Fringe Benefits) be modified as follows:

- A) Delete the entirety of the second paragraph of Section C (Group Health Insurance).
- B) Insert the following two paragraphs after the previous third paragraph of Section C (Group Health Insurance):

Effective with the premium for the month of October, 2002, the level of County participation in the cost of group health premiums shall be 93% of the premium for single, double or family coverage for any of the plans offered by the County and for which an employee may be eligible.

Effective with the premium for the month of October, 2003, the level of County participation in the cost of group health premiums shall be 90% of the premium for single, double or family coverage for any of the plans offered by the County and for which an employee may be eligible.

C) Add the following to the end of the last paragraph of Section C (Group Health Insurance): Employees who retire from County employment and are immediately eligible for a pension under the Wisconsin Retirement System shall have the option of continuing their participation, and that of their spouse and eligible dependents, in any of the group health insurance programs offered by Winnebago County, at their expense, for up to the number of years that they continuously served Winnebago County or until both the employee and spouse have attained the age of sixty-five, whichever affords the longer time frame, but not less than the amount of time provided for under the COBRA Law. This eligibility shall also apply to the spouse and eligible dependents of an employee who dies while employed by Winnebago County.

BE IT FURTHER RESOLVED, that the second paragraph of Section I-1 (Termination Benefits – Retirement) of Chapter 22 (Employment Termination) be replaced with the following (change in bold type) and that the relevant portion of Section F (Separation Benefit) of Chapter 13 (Sick Leave) be modified similarly:

Persons retiring with twenty or more years of continuous County service and who are immediately eligible for an annuity under the Wisconsin Retirement System, **employees who die with twenty or more years of continuous County service,** and persons who were previously covered under Section I (4) of Chapter 22-Grandfathered Sick Leave Payout Provision of the "Handbook," shall be eligible for a payout of **65%** of their unused sick leave at their last rate of pay.

BE IT FURTHER RESOLVED, that the necessary funds to cover the costs resulting from the adoption of the 2002 Revisions to the Winnebago County Administrative Salary Schedule and Benefits Program shall be made available from funds budgeted for this purpose.
