COUNTY EXECUTIVE'S REPORT

Executive Van De Hey reminded the Board about the upcoming public issues forum being sponsored by the Oshkosh Rotary Club. The forum, entitled "The Future of Local Government," will be presented by Michael Best & Friedrich, LLP. It will be held on Monday, March 31 at the Oshkosh Pioneer Inn at 12 o'clock noon. The Board is invited to attend.

Executive Van De Hey announced that after 27 years of employment with Winnebago County, Keith Laux will retire in June as the head of the Human Services Department. She commended him on his years of dedicated service to Winnebago County.

Executive Van De Hey reported that at a recent meeting, county department heads were brought up-to-date on what the county has been doing to prepare for possible emergency situations. She explained that the appropriate county departments (Sheriff, Public Health, Emergency Government, etc.) are preparing for various types of emergency situations.

Executive Van De Hey reported that she is a member of the Board of Directors for the Oshkosh Junior Achievement group and that she finds the volunteer work she does for them at Merrill Elementary School very rewarding. She encouraged others, especially during these difficult times, to look into helping their community by volunteering for various organizations.

Executive Van De Hey asked for the Board's support of Resolution No. 176-32002, "Authority to Execute the Winnebago County Sick Leave Conversion Plan for Non-Represented Employees."

Executive Van De Hey reported that at the suggestion of Supervisor Patrick O'Brien, she and Toby Paltzer, Outagamie County Executive, are developing an ad hoc committee to determine what areas of emergency services the two counties can share. Members of this ad hoc committee will be county board supervisors and appropriate emergency services people from both counties. It is also anticipated that in the future, this ad hoc committee could tackle other issues of concern to both counties, such as transportation, solid waste, etc.

CHAIRMAN'S REPORT

Chairman Maehl welcomed John Schaidler back and wished him well.

Chairman Maehl reported that the rally held in support of our military troops in Oshkosh on Saturday was very well attended. Siegried Nielsen, the wife of deployed Supervisor Mark Nielsen, gave a very moving speech at the rally.

Chairman Maehl encouraged everyone to display their American flags.

Chairman Maehl extended "happy birthday" wishes to Supervisors Thompson, Schaidler and Griesbach and Executive Van De Hey.

Chairman Maehl reported that 24 scholarship applications have been received. He also thanked Supervisors Schaidler, Scoville and Sevenich for their donations to the scholarship fund.

MASTER GARDENERS PROGRAM

Rosemary Eiden, Winnebago County Horticulturist, introduced Marilyn Miller, master gardener and past president of Winnebago County's Master Gardener program.

Ms. Miller described the master gardeners program and some of the projects in which they are involved. The Winnebago County Master Gardeners program began in 1991 and is open to anyone interested in horticulture. Some of the projects they are involved or places where they have gardens are:

Supervisor Koziczkowski commended Keith Laux on his years of service to the county, commenting on how instrumental he was in helping to establish Winnebago County's Human Services Department.

Supervisor Schaidler reported that there will be a Winn Tomorrow meeting on Thursday, March 27 starting at 5:00 p.m. at the Fox Valley Lanes in Neenah to continue the planning and development of the county's comprehensive land use plan. Everyone is invited to attend this important meeting.

WHEREAS, Governor Doyle in the proposed budget for the next biennial budget proposed a base level funding of \$15 million for tobacco prevention and control; and

WHEREAS, such a reduction would occur between January 1 and June 30, 2003 in the current State of Wisconsin Budget; and

WHEREAS, this is roughly a 40% cut to the funding for the Wisconsin Tobacco Control Board; and

WHEREAS, the Budget to this Program was reduced over previous levels by 43% during the last legislative session; and

WHEREAS, 16% of all deaths in Wisconsin are attributable to cigarette smoking; and

WHEREAS, Wisconsin's tobacco-related health care costs are estimated to be \$1.6 Billion Dollars per year; and

WHEREAS, the State of Wisconsin's Comprehensive Tobacco Control Program has helped reduce teen smoking by 18% in the past three (3) years; and

WHEREAS, the State of Wisconsin's Comprehensive Tobacco Control Program has played an important role in reducing tobacco consumption by 5% in 2002, compared to the national rate of a 1% reduction in tobacco consumption; and

WHEREAS, your undersigned Supervisors believe that it is in the best interest of the citizens of Winnebago County and the State of Wisconsin that funding for Wisconsin's Comprehensive Tobacco Control Program remain

intact.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby voices its opposition to any reduction by the State of Wisconsin in the State Comprehensive Tobacco Control Program.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this Resolution be transmitted to all Legislators representing constituents within Winnebago County, to the Wisconsin Counties Association and to the Office of Governor James Doyle.

WHEREAS, the State of Wisconsin's Agricultural Chemical Clean Sweep Program provides grants which play a critical role in helping counties collect dangerous chemicals from the agricultural community in a safe, convenient and efficient manner; and

WHEREAS, since 1990, Clean Sweep collections have grown to become frequent, multi-faceted events which have diverted over two million pounds of chemicals per year from Wisconsin landfills; and

WHEREAS, even though a large range of chemicals are accepted at clean sweeps and only 10% of waste is pesticide-related, pesticide product registration fees have been the sole source of state grants for both the Department of Agriculture and Department of Natural Resources Household Hazardous Waste Grant Program; and

WHEREAS, there is a significant shortfall in the Department of Agricultural Management Program which presently places the Agricultural Clean Sweep grants to counties in jeopardy; and

WHEREAS, it is unlikely that most clean sweep programs will continue on a county-wide basis without the continuation of state grants.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby supports the continued funding of Agricultural Clean Sweep Grants by the State of Wisconsin through a combination of Recycling Fund surplus revenues, pesticide product fees and hazardous product surcharges.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it supports the combination and administration of the Agricultural Clean Sweep Program and the Household Hazardous Waste Program within the Department of Agriculture to achieve a more efficient and succinct administration at both the state and local level.

RESOLUTION NO. 166-32003: Impose Moratorium on Zoning Applications and Amendments in Specific Sections of the Town of Clayton

WHEREAS, on or about February 24, 2003, the Town of Clayton Board of Supervisors requested that a moratorium be imposed in the Town of Clayton through February 29, 2004 for the purpose of prohibiting various applications, conditional use permit applications, parcel split to create new lots whether by certified survey map or plat, temporary use permit applications, permits for new principal structures if outside of an existing plat, permits for new detached accessory structures and permits for new detached accessory structures within Sections 14, 15, 16, 17, 19, 20, 21, 22 and 23 in the Town of Clayton; and

WHEREAS, within said restricted area, the Town of Clayton would consider zoning change applications in relationship to said moratorium for requests to change from an A-1 classification to an A-2 classification within Sections 19, 20, 21, 22 and 23; and

WHEREAS, the issuance of permits for a new principle structure in existing plats, the issuance of permits for building replacements and the issuance of permits for additions to existing structures, including attached garages would be allowed during said moratorium; and

WHEREAS, during said moratorium, minor exceptions to the moratorium could be made by the Town if, within the discretion of the Town Board, the intent of the moratorium would be maintained; and

WHEREAS, the purpose of the proposed moratorium is to allow for the East Central Regional Planning Commission, in conjunction with the Clayton Town Board, to obtain the services of an independent company to evaluate the capabilitity of various areas within the Town to support sewer extensions and the subsequent potential for a large industrial park within the referenced area.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby places a moratorium through February 29, 2004 upon any applications for a zoning variance or conditional use permit, for the splitting of parcels to create a new lot whether by certified survey map or plat, for temporary use permits, for the issuance of permits for new principle structures if outside of an existing plat and the issuance of permits for new detached accessory structures in the following Sections of the Town of Clayton: Section 14, 15, 16, 17, 19, 20, 21, 22 and 23.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that zoning amendment applications shall be considered in Sections 19, 20, 21, 22 and 23 of the Town of Clayton for a request for a zoning change from an A-1 to an A-2 district during the term of said moratorium.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that during the term of said moratorium, permits for new principle structures in existing plats, permits for building replacements and permits for additions to existing structures, including attached garages, would be issued within the Town of Clayton.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Town of Clayton Board of Supervisors may approve zoning matters involving minor exceptions to the moratorium within its discretion if the intent of the moratorium will be maintained.
