MOTION TO RECONSIDER COUNTY EXECUTIVE'S VETO LINE ITEM OF AMENDMENT #1 TO WINNEBAGO COUNTY BUDGET RESOLUTION #105-102004 ADDING \$33,038 TO THE SALARY AND FRINGE BENEFITS ACCOUNT OF THE UNIVERSITY OF WISCONSIN EDUCATION, EXTENSION AND AGRICULTURE BUDGET ACCOUNT AND CREATION OF HORTICULTURIST POSITION

LINE ITEM VETO OF 2004 ANNUAL BUDGET (RESOLUTION #105-102004, AMENDMENT #1)

Please be advised that I am hereby vetoing a line item which pursuant to Amendment #1 of Resolution #105-102004 added \$33,038 to the Salaries and Fringe Benefits Account of the University of Wisconsin Extension and Agriculture Budget as indicated on Page 360 of the Winnebago County Budget as well as adding a position to the County's Table of Organization.

I am vetoing this Amendment and line item and returning it to the Winnebago County Board of Supervisors for reconsideration for the following reasons:

The 2005 Budget, which I submitted to the Winnebago County Board of Supervisors proposed a reduction of \$500,000 to the Winnebago County tax levy because of the elimination and/or consolidation of positions within the Winnebago County Table of Organization. I believe that such elimination of positions or consolidation of positions when possible is important to relieving the taxpayers of a portion of their property tax burden. I have vetoed this line item to restore the County horticulturist position in the budget based upon a balancing of the cost of the position versus the service provided to the taxpayers as a result of the position. Presently, the Master Gardener Program in Winnebago County is an excellent program. I am committed to continuing that excellence. As County Executive, I have personally observed the talent of the County horticulturist in creating a wonderful community garden at the Resource Center along with many other projects.

I am confident, however, that the Agriculture Agent position which was recently vacated by the retirement of Jeff Key, can be combined with the horticulturist position and that one professional can be hired who will have the ability to perform both positions at a substantial savings of funds to the taxpayers. I believe that the present Department Head, Chris Kniep, has the ability to establish and manage those services provided in the past by both the agriculture agent and horticulturist so that there will be no decline in service to the public as a result of the combination of these positions. It is my intent, during the 2005 budget year, to continue to monitor the status of these services and to keep the Board of Supervisors informed as to these programs.

LINE ITEM VETO OF 2004 ANNUAL BUDGET (RESOLUTION #105-102004, AMENDMENT #21)

Please be advised that I am hereby vetoing a line item adding \$600,000 to the Winnebago County Human Services Budget pursuant to Amendment #21 of Resolution #105-102004. I am vetoing this amendment for the following reasons:

Winnebago County has a long history of being very committed to caring for the elderly and disabled and providing long-term care for persons in those categories. Over the past four years additional funds have been added to the Human Services Budget to help reduce or eliminate a waiting list for community-based residential placement. Unfortunately, in that medical assistance and other federal and state programs do not provide sufficient resources to pay for the cost of long-term care to all persons in need of such care who are not placed in nursing home facilities, the ability to provide long-term community-based care to such persons is beyond the property tax resources of any county government. The provision of community-based residential care to those persons who are indigent is an issue that necessitates review by both the state and federal government. It is my intent as County Executive to actively pursue this issue at those levels.

Additionally, it should be noted that the 2005 amended budget contains an appropriation of \$279,296 to the Reserve Fund of the Human Services Department. This appropriation provides a safety net for those in need of community-based residential services should additional monies be required during the course of 2005.

WHEREAS, Clarity Care Incorporated is the largest provider of residential services to persons suffering from developmental disabilities within Winnebago County; and

WHEREAS, the bankruptcy of Clarity Care Incorporated could be temporarily problematic to those persons within Winnebago County who receive residential care from that corporation; and

WHEREAS, the Winnebago County Personnel and Finance Committee and the Winnebago County Human Services Board believe it to be in the best interest of Winnebago County and its citizens to enter into the debt repayment agreement which was previously provided to members of the Winnebago County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Executive and the Winnebago County Clerk to enter into a debt repayment agreement with Clarity Care Incorporated as is evidenced in a document which was previously distributed to the Winnebago County Board of Supervisors and which shall be made available upon request by the Winnebago County Clerk to any party requesting a copy of said agreement. Said agreement is made a part of this resolution by reference.
