ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, FEBRUARY 17, 2004

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Rankin.

The following Supervisors were present: Sevenich, Barker, Griesbach, Hotynski, Scoville, Maehl, Klitzke, Lauson, Albrecht, Pech, Steineke, Madison, Radewan, Sundquist, Wingren, Jacobson, Norton, Robl, Eichman, Kline, Kramer, Schaidler, Finch, Farrey, Arne, Diakoff, Brennand, Egan, Rankin, Rengstorf and O'Brien. Excused: Hert, Nielsen, Sievert and Widener. Absent: Koziczkowski, Thompson and Tierney.

Motion by Supervisor Robl and seconded to approve the agenda by moving Resolution No. 333-22004 and Resolution No. 331-22004 before Resolution No. 327-22004. CARRIED BY VOICE VOTE.

COMMUNICATIONS, PETITIONS, ETC.

A thank you card was received from the family of Blondie Pawlowski for flowers sent by the Board for his recent death.

An e-mail was read from Kathleen Propp, President of the Oshkosh Area League of Women Voters. A copy of a letter from the Oshkosh Area League of Women Voters was placed on each Supervisor's desk.

Resolution No. 9-2-04 from Jackson County was received regarding "Support of Municipal Employment Relations Reforms" and forwarded to the Legislative Committee.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Lauson asked each Supervisor to look at a handout on their desk regarding a summary of the Boat Trailer Parking Fee Program. Rob Way, Parks Director, gave a brief overview of the handout. The program brought in more money than had been anticipated (\$98,425.05); however, the expenses were also higher (\$49,587.15). Mr. Way anticipates expenditures to be reduced by one-half due to the elimination of the start-up cost. Mr. Way estimates revenue for next year will be \$20,000 to \$26,000. He feels revenues may be reduced by as much as \$15,000 due to boaters choosing to purchase an annual or multi-year permits rather than the \$4.00 daily fee. There may be an increase in revenue in the enforcement area. Supervisor Lauson ended by reminding everyone that all profits from the sale of the permits will go to maintain and improve the boat launches. Supervisor Lauson wanted to commend Mr. Way and his staff, especially his secretary, for the additional work done to make this project a success.

Supervisor Norton asked Supervisors to look at two handouts placed on their desk. The first was a summary of highlights from the WCA Annual Legislative Exchange. The second was an article entitled "Colorado tax "freeze" ices services". The article was relating to a bill called the "TABOR" (Taxpayers Bill of Rights). There is legislation currently pending in Wisconsin regarding this matter. Supervisor Norton also invited all Supervisors to make a pledge to either himself or Supervisor Pech for the upcoming Polar Plunge. Profits will go to Special Olympics.

Supervisor Radewan traveled to Oshkosh West, Oshkosh North and Lourdes high schools promoting the Scholarship Program. Oshkosh West ran out of applications. Additional applications were taken to all three high schools.

Supervisor Finch reported the scholarship program is going very well. He appeared on Channel 10 promoting the scholarship program. The program will be aired in Oshkosh as well as the northern part of the County.

Supervisor Barker stated although no agenda was on their desks, a Legislative Committee meeting will be held on Monday, February 23, 9:00 a.m. at the Coughlin Building. One of the topics being discussed is TABOR.

Supervisor Brennand reported Chairman Maehl had requested he check on the cost savings realized by having the zoning maps put on the web page, rather than printed in color. The savings per year would be \$2,400 and there is a miniscule cost for getting the maps put on the web page.

COUNTY EXECUTIVE'S REPORT

County Executive Van De Hey stated she had attended the WCEA (Wisconsin County Executive Administrator) meeting where TABOR had also been discussed. This legislation is being watched very carefully because of the negative impact similar legislation had in Colorado.

County Executive Van De Hey announced she had attended the swearing in of Judge Scott Woldt, the newest Circuit Court Judge.

County Executive Van De Hey stated work is beginning on the upcoming budget. She is hoping to have a budget equal to this year's.

COUNTY EXECUTIVE'S APPOINTMENTS Director of Public Health

Executive Van De Hey asked for the Board's approval of her appointment of Douglas D. Gieryn as the Director of Health.

Motion by Supervisor Rankin and seconded to approve. CARRIED BY VOICE VOTE.

Winnefox Library System Board

Executive Van De Hey asked for the Board's approval of her appointments of Tom Willardsen and Carol Stinson to the Winnefox Library Board. Mr. Willardsen will complete the term of Don Stolley and Ms. Stinson will complete the term of Dorothy Nimmer. These are three-year terms that will expire on December 31, 2006.

CHAIRMAN'S REPORT

Chairman Maehl extended happy birthday wishes to Supervisors Nielsen and Radewan as well as Sue Ertmer, County Clerk.

Chairman Maehl brought Supervisors' attention to two informative pieces of literature, "Shhhout about libraries" and "The Legislative Review" received in their packet. He also wanted each supervisor to look at a graph, which could be found on their desk, showing the usage of the meeting rooms at the J.P. Coughlin Center.

Chairman Maehl notified Supervisors of the passing of past Sheriff Krause. The funeral will be Wednesday, February 18 at 11:00 a.m. in Neenah.

Chairman Maehl shared Winnebago County will be receiving another check from Wisconsin Counties Insurance Company of \$12,434. This is in addition to the \$306,000 check received in January.

RESOLUTION NO. 333-22004: Authorize Appropriation of \$15,198.69 to the East Wisconsin Counties Railroad Consortium

WHEREAS, Winnebago County became a member of the East Wisconsin Counties Railroad Consortium in April, 1980 for the purpose of facilitating the continuance of rail service on the Northern Division of the Milwaukee Road and the preservation of the facilities for the continuation of such service; and

WHEREAS, Winnebago, Dodge, Fond du Lac, Green Lake and Washington Counties are members of said Consortium; and

WHEREAS, railroad service is needed in Winnebago County to help provide efficient and cost-effective transportation to existing and potential businesses; and

WHEREAS, the East Wisconsin Counties Railroad Consortium and the State of Wisconsin own the rail trackage and right-of-way of the former Northern Division of the Milwaukee Road; and

WHEREAS, Crawford, Grant, Iowa, Dane, Sauk, Walworth, Rock and Waukesha Counties are now members of the Wisconsin River Rail Transit Commission; and

WHEREAS, said Commission and the State of Wisconsin own a portion of the rail trackage and right-of-way of the former Southern Division of the Milwaukee Road; and

WHEREAS, rail trackage and right-of-way located in Rock County, Wisconsin, from Anderson Siding to Milton Junction, are in need of rehabilitation in order to provide adequate rail service on the former Northern Division and the former Southern Division of the Milwaukee Road; and

WHEREAS, the Wisconsin and Southern Railroad Company, a private corporation, has proposed a program to rehabilitate this rail trackage and right-of-way in 2004 at a total cost of \$1,975,829.65; and

WHEREAS, eighty per cent (80%) of the cost of this rehabilitation is available in the form of a grant from the

Wisconsin Department of Transportation with the remaining twenty per cent (20%) to be provided by other sources; and

WHEREAS, the Wisconsin & Southern Railroad Company will participate in this rehabilitation program to the extent of providing ten per cent (10%) of the cost of the rehabilitation; and

WHEREAS, the East Wisconsin Counties Railroad Consortium has proposed to participate in this rehabilitation program by providing 3.8% of the cost of the rehabilitation program; and

WHEREAS, in order to participate in this program, the East Wisconsin Counties Railroad Consortium has requested each of its members to contribute the sum of \$15,198.69 to the East Wisconsin Counties Railroad Consortium; and

WHEREAS, the Wisconsin River Rail Transit Commission has proposed to participate in this program to the extent of providing 6.2% of the cost of the rehabilitation; and

WHEREAS, to enable the Wisconsin River Rail Transit Commission to participate, that Commission has requested each of its member counties to contribute \$15,198.69 to the Commission.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$15,198.69 from the Contingency Fund of the Winnebago County 2004 Adopted Budget as a contribution to the East Wisconsin Counties Railroad Consortium for rehabilitation of the right-of-way located in Rock County, Wisconsin from Anderson Siding to Milton Junction.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that in the event that one or more of the Wisconsin Counties that are members of the Wisconsin River Rail Transit Commission or one or more of the Wisconsin Counties that are members of the East Wisconsin Counties Railroad Consortium do not appropriate \$15,198.69 for the rehabilitation of rail trackage and right-of-way located in Rock County, as described above during the calendar year 2004, that Winnebago County is hereby authorized to withhold said contribution to the East Wisconsin Counties Railroad Consortium.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Sheriff to accept grant funds from the State of Wisconsin in the amount of \$70,606 to fund wages and fringe benefits in relationship to said position.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that should funding for said position expire, the first vacancy thereafter in the Detective Unit in the Winnebago County Sheriff's Department would not be filled and said position would be allowed to lapse through attrition.

RESOLUTION NO. 327-22004: Oppose Assembly Bill 606: Authorizing Referendum to Allow Reduction of Size of County Boards

WHEREAS, Representative Greg Underheim has introduced Assembly Bill 606, which basically would allow a referendum during the decade after the last census to reduce the size of the County Boards of Supervisors upon a vote equal to at least 25% of the total votes cast in the County for the office of County Board Supervisor at the most recent spring election proceeding the date of filing; and

WHEREAS, said law does not set a limit on the number of such referenda that can be held nor does it set a limit on the size to which a County Board could be reduced; and

WHEREAS, said law provides no authority for a referendum to increase the size of the County Board; and

WHEREAS, if said referendum were passed, according to said proposed Bill, the County Board Districts would be established by a committee of one person appointed by the County Board Chairperson and two persons appointed by the County Clerk; and

WHEREAS, presently, the County Board Supervisory Districts are established by the County Board of Supervisors pursuant to a majority vote of those supervisors elected by the people of Winnebago County; and

WHEREAS, said Bill would remove such authority from duly elected officials; and

WHEREAS, each redistricting which would occur would involve numerous man hours spent by County staff in assisting said Committee; and

WHEREAS, each redistricting effort would result in an undetermined amount of money spent by Winnebago County in relationship to said redistricting in addition to the costs it would have on underlying municipalities with regard to the establishment of district and precinct boundaries; and

WHEREAS, there is no indication or proof at the present time that County government is inefficient nor in need of amendment; and

WHEREAS, the recent history of county government throughout Wisconsin indicates that counties have acted appropriately and conservatively in relationship to safeguarding and utilizing public monies, in contrast to the recent history of the Wisconsin State Legislature.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it voices it opposition to the passage of Assembly Bill 606.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to transmit a copy of this resolution to all Legislators representing constituents within Winnebago County; to the Wisconsin Counties Association; and to the Office of Governor James Doyle.

- (D) FEES......
- (2) An individual currently owning property within Winnebago County as is indicated by a tax receipt from the prior year.

At the time of the initial transaction when an annual or multi-year boat trailer parking permit is being purchased, residents may purchase a second permit for other automobile, motor home or truck registered to the same individual which they intend to use to pull a boat trailer. The second permit shall cost \$5.00. At any time following the initial transaction, a second permit or a replacement permit may be purchased at the Parks Department office for the same permit period at a cost of \$5.00 per permit. Proof of vehicle registration shall be provided for all transactions. Annual and multi-year permit stickers shall be prominently displayed and permanently affixed to the lower corner of the interior of the windshield on the *drivers* side of the automobile, motor home or truck utilized to pull the boat trailer. Daily boat trailer parking permit fees shall be \$4.00. The printed side of the daily permit shall be prominently displayed on the interior of the passenger side windshield of the automobile, motor home or truck pulling the boat trailer.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that this ordinance shall be effective as of the date following the date of its publication.

WHEREAS, the Winnebago County Legislative Committee and the Winnebago County Planning and Zoning Committee recognize the broad impact that the development of real estate has on the many programs and actions with which government is involved; and

WHEREAS, the reduction of the number of functions and actions which must be consistent with the comprehensive plan of a municipality serves to erode the usefulness of comprehensive plans in relationship to the review of developmental activity; and

WHEREAS, the above-mentioned Committees have gone on record to unanimously oppose AB 608 for the reasons stated herein.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby states its opposition to Assembly Bill 608.

WHEREAS, Assembly Bill 527, a copy of which is herewith attached, proposes to amend Wisconsin law so as to negate County shoreland zoning in areas which are annexed to a city or village, thus creating a significant imbalance in the management of shoreland resources between incorporated shoreland areas and unincorporated shoreland areas; and

WHEREAS, the Legislative Committee, Planning and Zoning Committee and the Land Conservation Committee have unanimously expressed their opposition to Assembly Bill 527 for the reasons stated herein.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby states its opposition to the passage of Assembly Bill 527.
