REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Kline reported the county has an opportunity to refund and refinance the notes issued in 1998 with a cost savings of \$27,500 per year for 3 years. The Personnel & Finance Committee will bring this resolution to the March 1st Special Order of Business meeting to award the sale before the interest rates increase.

Supervisor Barker announced an agenda for the Monday, February 28th Legislative Committee meeting had been placed on their desk. Supervisor Barker encouraged all committee members to attend, since many legislators will be in attendance.

Supervisor Finch reported the Scholarship Committee contacted area schools and Supervisor Finch was interviewed on Channel 10 to further promote the Scholarship Program.

Supervisor Schaidler announced on Friday, February 11, the Planning & Zoning Committee had passed a draft of the Comprehensive Plan, which was forwarded to area municipalities for a 45-day review period. Anyone interested in looking at a copy of the Comprehensive Plan can do so by either going to the County Website or getting a cd from the Planning and Zoning Office. Supervisor Schaidler also announced on Friday, February 18th, the Planning & Zoning Committee will be viewing the property of 18 Wheel Enterprise. This is the property from the Town of Vinland that had been referred to the Planning & Zoning Committee at the January 18th County Board meeting. The public hearing for this property will be Tuesday, February 22nd.

Supervisor Kline reported Supervisor Maehl is home recovering from a fall. His vision has been affected, but he is hopeful this is temporary.

WHEREAS, the project was included in the Five-Year Capital Improvement Plan; and

WHEREAS, the project will have a positive economic impact on Winnebago County due to development that will continue to increase in the corridor that is adjacent to CTH A; and

WHEREAS, CTH A is forecast to have a continued increase in average daily traffic; and

WHEREAS, that portion of CTH A from CTH Y to Sherman Road will be constructed as a four lane segment of roadway with the remainder of the project to be constructed as a two lane segment of roadway with a 10' wide pedestrian – bike path placed on the west side of the entire project; and

WHEREAS, there is an estimated revenue offset of \$764,000 of State/Federal funding allocated for this project.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates the sum of \$1,704,000 from the General Fund of Winnebago County for the construction of CTH A for the purpose of paying said project costs.

BE IT FURTHER RESOLVED, by the Winnebago County Board of Supervisors that funds to pay for said project are hereby appropriated from the General Fund of Winnebago County, with said fund being reimbursed from a subsequent bond issue of \$940,000 covering Winnebago County's share of the project costs.

WHEREAS, a tentative agreement has been reached between Winnebago County and the Citadel Trust and The Jungbacker Children's Present Interest Trust, owners of the leased premises, for the rental of said property for an additional five (5) year term at an initial rental rate of \$103,976.90; and

WHEREAS, said lease would provide Winnebago County with two (2) additional one (1) year options to extend the lease through April 30, 2012; and

WHEREAS, the Facilities and Property Management Committee of the Winnebago County Board of Supervisors believes that execution of said lease serves the best interest of Winnebago County.

WHEREAS, the American Fiber Mills property, also known as the Ponderosa Fiber Mill property, which is located at 2800 North Main Street in the City of Oshkosh, has been abandoned for several years; and

WHEREAS, the principal shareholder in the corporation which owned said property is presently incarcerated in the State of New York in relationship to federal fraud charges; and

WHEREAS, the property is suspect of being environmentally contaminated in that its former use was as a paper pulp mill and in that there are vats of caustic chemicals still on the premises; and

WHEREAS, there are delinquent property taxes, special assessments and/or special charges for the tax years 1999 through 2003 in the amount of \$463,336.11 due to Winnebago County and 2004 property taxes, special assessments and/or special charges due and owing in the amount of \$39,194.57 to the City of Oshkosh upon said property; and

WHEREAS, said charges do not reflect any interest which would be normally assessed upon those taxes which are delinquent; and

WHEREAS, the Winnebago County Treasurer has been notified by the bankruptcy trustee for said property that a potential buyer for the property, who has experience in rehabilitating this type of property, would be willing to purchase the property and clean it and repair the structure for lease; and

WHEREAS, the offered purchase price for said property is inadequate to cover interest owed upon said property; and

WHEREAS, the Winnebago County Personnel & Finance Committee believes that it would be in the best interest of Winnebago County citizens and citizens of the City of Oshkosh, to accept payment upon said taxes and waive any interest charges upon delinquent taxes.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Treasurer to agree to accept payment of \$463,336.11 as payment in full of all property taxes, special assessments and/or special charges upon said property for tax years 1999 to 2003 upon the American Fiber Mills property at 2800 N. Main Street, City of Oshkosh.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby waives all interest payments owed to Winnebago County upon said delinquent property.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that from those funds received from the bankruptcy trustee for delinquent taxes upon said property, that Winnebago County appropriate and pay to the City of Oshkosh the sum of \$39,194.57 as payment in full for 2004 property taxes, special assessments and/or special charges upon said property.

WISCONSIN COUNTIES ASSOCIATION TABOR PRESENTATION

Mark O'Connell, Executive Director of Wisconsin Counties Association said TABOR, Taxpayers Bill of Rights. has been around for a long time. It garnered momentum last session, but did not come to a vote by both houses. TABOR caps spending; however, the goal is to reduce property taxes. The concept of TABOR is to reduce spending needing less revenue thereby reducing taxes. Mr. O'Connell said all changes in TABOR can be done without any amendments to the constitution by holding spending down in the budget; however, there is a belief that the legislators do not have the courage to make the necessary budget cuts.

Mr. O'Connell said the current TABOR legislation, authored by Representative Frank Lasee and Representative Jeff Wood, states spending cannot increase from one year to the next by more than the consumer index or inflation, which currently is less than 2%. TABOR does allow a transfer of services, which means if the state transfers costs for a service, the municipality can increase taxes to cover the costs. If the state reduces funding for a mandated service, the municipality would not have to comply with that service. Mr. O'Connell said TABOR would allow exceeding spending limits by a vote of the electors.

Mr. O'Connell suggested there are two problems with the current TABOR-the spending cap could actually increase taxes and the referendum option. An example was given showing if the state goes over their budget, the excess will come out of the amount given to local municipalities. Mr. O'Connell states the counties have the responsibility for programs that create the needed "social safety nets"; however, when asked on a referendum question to support increased spending to fund those programs, there is a likelihood it would not pass.

Mr. O'Connell said the state reports 2/3's of their money goes to local governments in aid, when in actuality, the money is a reimbursement for services performed by the local governments.

Mr. O'Connell explained there is a joint bill for a property tax freeze, which should be voted on by the Assembly at a Thursday Special Orders meeting and will then go to the Senate for a vote. If passed by both houses, it would go to the Governor, but Mr. O'Connell would expect him to veto that bill. An override would be highly unlikely. This could bring up more talk of TABOR.

After a period of discussion, Mr. O'Connell thanked the Board for the opportunity to speak and said a document, which should be ready in the next few days, is being prepared for distribution of all things relating to the County in Governor Doyle's budget.

COUNTY BOARD CHAIRMAN'S APPOINTMENT

Chairman Albrecht asked for the approval of his appointment of Supervisor Harold Steineke to the Aviation Committee. Supervisor Steineke will replace Mark Nielsen who resigned from the Winnebago County Board. Motion by Supervisor Lauson and seconded to adopt. CARRIED BY VOICE VOTE.

Chairman Albrecht said Supervisor Sundquist will not be making a presentation on tourism.

AIRPORT MASTER PLAN

Supervisor Kline, Acting Chair of the Aviation Committee began the presentation by saying he was glad to have Mark Nielsen at the meeting to assist in the presentation. The committee has been working on the Airport Master Plan for the past 2 ½ years and Mr. Nielsen was Chair of the Aviation Committee during most of that time. Supervisor Kline referred supervisors to a booklet that had been sent to them entitled "Wittman Regional Airport Master Plan Update, Executive Summary." Supervisor Kline said the Master Plan is not a blueprint for development, but is an evolving document that builds on previous planning efforts, and establishes a framework for development of the Airport. Although it's intent is to establish a vision of the Airport's future looking at both aviation business and industry developments, it is not a commitment for any specific project.

Mark Nielsen gave a brief background of Wittman Regional Airport noting its construction in the late 1920's. An Airport Master Plan Committee was established. Their primary role was to assist in reviewing and advising the consultants regarding the technical and community issues related to the study. The members of the committee included county, state, townships, city, Chamber of Commerce and tenants.

Mr. Nielsen said the "starting block" was the 1992 Master Plan. The objectives of the Master Plan Update were:

- Assess the Airport's compliance with new Federal Aviation Regulations and FAA Airport Design Criteria.
- Evaluate the long-term potential and aviation demand of the Airport.
- Develop a capital improvement plan that will satisfy the future aviation demand and provide for more organized and orderly development of the site.
- Assist the Airport with focused development for Corporate and General Aviation site uses.

The Master Plan Update is a guide to meet the projected aviation needs for the next 20 years. Supervisor Kline explained the Airport was subdivided into five development areas:

- 1. The Airfield This consists of approximately 625 acres.
- 2. The North Terminal Area This area is located south of 20th Avenue and north of Runway 9/27. This area is 100 acres and consists of the main terminal building, fixed based operators and corporate and private aircraft hangars.
- 3. The East Terminal Area This area is generally bounded by Runway 9/27, 13/31 and Hughes Avenue. This 38-acre area is comprised of general aviation businesses, hangar developments and maintenance facilities.
- 4. The Industrial Park Area This area is a 40-acre area located east of Runway 18/36 along Taxiway D. This area consists of hangars and aprons for the DNR and Fox Valley Technical Center. This area adjoins Oshkosh's aviation industrial park to the south.

5. West Terminal Area – This area is west of Runway 18/36 and south of Runway 9/27. This 245-acre area is primarily used for the annual EAA AirVenture.

Mr. Nielsen stated that since the loss of regularly scheduled airline service at Wittman Regional Airport in 2003, the study focused on corporate and general aviation as the primary industry to accommodate over the planning period. The study showed the primary area that will require additional facilities in the future will be aircraft storage. Over the forecast period, it is estimated that approximately 63 new t-type hangars will be needed for single and multiengine aircraft. It was determined in 2002, by the FAA, that the tower needed to be replaced. Construction should begin in 2005.

Supervisor Kline explained the Airport Development Program needs as follows:

- Displace Runway 27 threshold to comply with FAA Airport Design requirements.
- Close Airport Perimeter Road for safety and security, and complete the airside perimeter service road development.
- Extend Taxiway P north for improved traffic flow.
- Install an Instrument Landing System on Runway 9.
- Strengthen Runway 18/36 to 210,000 lbs. dual tandem wheel loading during the next reconstruction of the runway to accommodate larger aircraft and extend service life.
- Relocate a portion of Taxiway B between Taxiway B3 and the Main Terminal to comply with FAA Airport Design requirements.
- Construct a new taxiway from Runway 9/27 directly south to the West General Aviation Apron for improved traffic flow.
- Construct a partial parallel taxiway on the southwest side of Runway 9/27 adjoining Taxiway P extension for safety and improved traffic flow.
- Extend the paved ditch on the west side of Runway 18/36.

The first two recommendations are the only recommendations slated to be completed in the near future. Supervisor Kline explained the handout given supervisors was only an "Executive Summary". Anyone interested in looking at the entire Airport Master Plan should contact the Airport Office.

RESOLUTION NO. 146-22005: Authorize Execution of Airport Hangar Lease Between Winnebago County and Janie Gee Aviation, Incorporated (Wittman Regional Airport)

WHEREAS, Janie Gee Aviation, Incorporated wishes to execute a three (3) year lease for the purpose of occupying an airport hangar at Wittman Regional Airport; and

WHEREAS, the lease of said Hangar Unit #2, Building #1 is for approximately 2,500 square feet of interior aircraft storage building space; and

WHEREAS, the term of said proposed lease would provide for annual rent at a rate of \$663.74 for the first two (2) years of said lease and for the lease to be adjusted pursuant to any increase in the Consumer Price Index for the third year of said lease; and

WHEREAS, said lease would run for a term from February 1, 2005 through January 31, 2008; and

WHEREAS, the Aviation Committee recommends approval and execution of said proposed lease agreement.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves and authorizes the Winnebago County Executive and Winnebago County Clerk to execute a three (3) year lease between Winnebago County and Janie Gee Aviation, Incorporated for Hangar Unit #2, Building #1 which is comprised of 2,500 square feet of interior aircraft storage building space at Wittman Regional Airport at an initial rate of \$663.74 per year. Said proposed lease is incorporated by reference as a part of this resolution. A copy of the full lease agreement may be obtained upon request from the Winnebago County Corporation Counsel's Office or the Office of the Airport Director.

- 3. Evaluation of aviation demand at the Airport;
- 4. Development of a Capital Improvement Plan that will satisfy the future aviation demand and provide for a more organized and orderly development of the site; and
- 5. Assistance of the Airport with focused development for corporate and general aviation; and

WHEREAS, said Master Plan update is a guide for Airport improvements to meet the projected aviation needs in the next twenty (20) years. Said Master Plan update is not a commitment for any specific project identified within the Master Plan; and

WHEREAS, your Aviation Committee recommends that said Master Plan Amendment be approved by the Winnebago County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves the update and amendment of the Wittman Regional Airport Master Plan as prepared by URS Corporation BRW on behalf of Winnebago County. Said Master Plan update is incorporated by reference as a part of this resolution. (A copy of said Master Plan may be obtained upon request from the Office of the Airport Director).

RESOLUTION NO. 155-22005: Extend Moratorium Applicable to Land Divisions by Certified Survey Maps, Subdivisions, Conditional Use Permits and Zoning Change Requests in Town of Wiinchester

WHEREAS, the Land Use Plan Commission of the Town of Winchester is currently developing a comprehensive plan for that Town's consideration, but the development of the plan and the implementation of ordinances to affectuate the plan will involve continued study and time; and

WHEREAS, the current planning process is unlike any prior planning activities of the Town of Winchester; and

WHEREAS, existing land use policies may allow new development or the intensification of existing development that may hamper or curtail the effectiveness of the new policies before they can be completed and adopted by the Town of Winchester; and

WHEREAS, an interim control ordinance relating to land division, subdivision, conditional use and rezoning requests would provide the Town with the opportunity to complete and adopt new policies; and

WHEREAS, absent an interim control ordinance, development pressures within the Town of Winchester might increase during the planning process as a result of landowners and developers seeking to rush their projects in order to gain approval before new policies can be adopted and implemented; and

WHEREAS, the Winnebago County Board of Supervisors in November, 2003 and June, 2004, upon the request of the Town of Winchester, established a temporary moratorium with regard to the above activities; and

WHEREAS, the Town of Winchester's Land Use Plan Commission is finalizing the comprehensive plan which is scheduled for completion in 2005; and

WHEREAS, additional time may be needed to adopt ordinances to implement the comprehensive plan, including but not limited to subdivision, land division, access control, historical preservation, design, sign, and impact fee ordinances (hereinafter referred to as Implementation Ordinances); and

WHEREAS, the Town of Winchester wishes to avoid a race of diligence, i.e. property owners seeking approval of actions which are allowed under current Town ordinances but which may not be consistent with the comprehensive plan and implementation ordinances; and

WHEREAS, the Town of Winchester also wishes to explore a limited access ordinance for designated roads which are considered to be substandard in design and construction for the purpose of handling additional traffic due to further land divisions; and

WHEREAS, the attached Schedule "A" sets forth those roads within the Town of Winchester which it believes to be substandard; and

WHEREAS, no further land division should be allowed in the interim on these designated roads unless new parcels have adequate legal frontage and access to other public roads; and

WHEREAS, in the interim, the Town of Winchester wishes to allow limited land divisions where not more than one additional parcel is created, provided no rezoning of the divided property shall take place, as these types of divisions are not expected to conflict with the eventual comprehensive plan and implementation ordinances; and

WHEREAS, the Winnebago County Planning and Zoning Committee is agreeable to the request of the Town of Winchester that a moratorium be extended through June 30, 2005 by Winnebago County in relationship to land divisions by certified survey maps; subdivisions, the granting of conditional use permits and zoning changes as noted above, provided that said moratorium not be again extended.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors as follows:

- 1. That no applications for land divisions, subdivisions, conditional use permits and rezoning requests shall be allowed through June 30, 2005 in the Town of Winchester except as otherwise provided herein
- 2. Not withstanding the foregoing, any existing parcel of land may be divided within the Town of Winchester into not more than two parcels, provided that the proposed division is allowed by the existing zoning classification for this property and applicable Winnebago County Ordinances and further provided that only one land division of any existing parcel shall be allowed under any circumstances.
- 3. That pursuant to this moratorium, any of the designated roads, as set forth in Schedule "A", which is attached hereto and made a part of this resolution, shall not constitute a public road for the purpose of complying with the Winnebago County Land Division Ordinance, which requires a minimum of 200 feet of frontage on a public road for any newly created parcel land to be approved. In order for any land division to be allowed, any newly created lot shall be required to have at least 200 feet of frontage on a public road other than any of those roads set forth in the attached Schedule "A". Furthermore, no access shall be allowed in any event from any newly created lot to any of the designated roads set forth in the attached Schedule "A".
- 4. Any certified survey map, conditional use permit request or rezoning request, which has already been approved shall not be affected herein. Any subdivision plat, which is currently being considered by the Winnebago County Planning and Zoning Office for which a conceptual plan was submitted to the Winnebago County Planning and Zoning Office prior to May 1, 2003, shall also not be affected berein
- 5. As an interim control ordinance, upon final action of the Town of Winchester with regard to the adoption of ordinances regulating land division, subdivision and access control, those restrictions made effective by this resolution shall terminate and shall be of no further force or effect.
- 6. This resolution shall not apply to emergency conditions that require a plat, certified survey map, conditional use permit or zoning change in order to avoid irreparable harm to the property owner. Delay in the opportunity to develop land shall not constitute irreparable harm or an emergency for purposes of this resolution. Any requests for variances as a result of emergency conditions shall first be heard by the Town Board of the Town of Winchester.

- 7. All ordinances and resolutions or provisions of resolutions and ordinances inconsistent with or contravening the provisions of this resolution are hereby temporarily voided during the moratorium period and shall have no legal force of effect during the period that this resolution is in effect.
- 8. If any part of this resolution is adjudged to be unlawful, invalid or unconstitutional by a court of competent jurisdiction, the remainder of this resolution shall not be effected thereby.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it finds that the request of the Town of Winchester for a moratorium is reasonable and similar to other requests made by other towns; that the temporary moratorium allows for an orderly planning process to take place without undue development pressure; that the temporary nature of the moratorium and the ability to address emergency conditions along with the ability to build within current zoning regulations alleviates any claims of a "taking"; and the implementation of such moratorium allows town and county officials to act cooperatively on issues of mutual concern.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that this resolution shall be effective as of the date following the date of its publication.
