ADJOURNED SESSION WINNEBAGO COUNTY BOARD MEETING TUESDAY, OCTOBER 16, 2007

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Chairman Albrecht.

Motion by Supervisor Robl and seconded to adopt tonight's agenda. CARRIED BY VOICE VOTE.

PUBLIC HEARING

Terry Toraason, 1260 Huron Court, Oshkosh, of Oshkosh Youth Soccer (OYS), reported to the Board that OYS has donated 675 pounds of premium grass seed (at a cost of \$1,999.00) and \$1,985 in fees to improve the soccer fields at Community Park. He stated that the working relationship between OYS, the county and other organizations will allow improvements to continue to be made at this facility. He thanked the Board and the Parks Department for providing such a wonderful place for area youth to play soccer.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Barker reported that because of a lack of agenda items, there will not be a Legislative Committee meeting in October. She asked that the Board members read the article from the <u>Farm Journal</u> that was placed on their desks by Tom Davies, Director of Winnebago County's Land & Water Conservation Department. The article discusses the importance of educating livestock producers on how to handle accidental manure spills.

Supervisor Egan reported that the cost to print the results from the Personnel Function Review Committee will be approximately \$50 per book. The UW-Extension Department has offered to make two copies of the book and have one available at their office and one at the County Clerk's Office. They will also put the information on CD's at no cost for anyone who would like one. The County Clerk will also look into getting the report on the county's website.

Supervisor Schmuhl placed a copy of the "Unique Your Trip" tourism brochure on everyone's desk. This is the latest project resulting from the partnership between the Wisconsin Counties Association and East Central International Trade, Business and Economic Development Council (ITBEC) and the counties of Winnebago, Calumet and Kewaunee.

Supervisor Lohry reported on her attendance at the Wisconsin Counties Association (WCA) Conference in the Wisconsin Dells. She attended a workshop on nursing homes and learned that counties are being encouraged to keep their nursing homes. She reported that changes are also being made to Act 100, which allows the reduction of the size of a county board between censuses.

Supervisor Widener reiterated that the proposed changes to Act 100 (increase the number of required signatures to 25% in each district) will make it a much better law.

Supervisor Norton reported that the Wisconsin Way, which is an organization supported by the Wisconsin Counties Association, will be having a presentation in Oshkosh on Tuesday, November 6 at the Park Plaza Convention Center. He encouraged everyone to attend.

Supervisor Farrey reported that he learned at the Wisconsin Counties Association Convention that the Wisconsin Department of Natural Resource's (DNR) NR115, which affects the Wisconsin Shoreland Management Program, will most likely be approved by the DNR in December and sent to the state legislature in January 2008.

Motion by Supervisor O'Brien and seconded to approve the September 4 & 18, 2007 proceedings. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris stated that the proposed 2008 County Budget has been placed on everyone's desk tonight. He informed the Board that there are some areas of the county's budget that could be affected by some unresolved state budget issues. Those issues are the levy freeze formula, revenue sharing, court aids, juvenile aids and child support enforcement funding. Executive Harris reported that revenue sharing will most likely stay at last year's levels and that court aids will not available. Executive Harris explained that:

- Juvenile aids, which are intended to offset the 30% increase in the state's fees for housing juveniles in state facilities, may remain in the state's budget.
- Child support enforcement funding is the state's effort to replace money that was taken away by the Federal government and may remain in the state's budget.

Executive Harris will keep the Board posted on these and other issues involving the state's budget and their impact on the county's budget hearings.

Executive Harris reported that the City of Oshkosh has signed a resolution to be a "green city" or to be "environmentally sound & sustainable". Executive Harris felt that it was important to note the many things that Winnebago County does to be "green". Those things include:

- The new Park View Health Center is being built to the "lead silver standard", which is a very high standard of environmental friendliness.
- Gas from the landfill is used to generate electricity which is sold back to the utilities. The waste heat from these generators is then used to heat water for the jail.
- Offices in the Highway Department are heated with landfill gas, with natural gas as a back up system.
- The mechanics bays at the Highway Department are heated with the waste oil from vehicle oil changes that area performed there.

Executive Harris stated that these initiatives are possible because of the efforts of the county's landfill.

COUNTY EXECUTIVE'S APPOINTMENT

Long-Term Support Advisory Committee

Executive Harris asked for the Board's approval of his appointment of Steve Jahns to the Long Term Support Advisory Committee. This is a three-year term that will expire on April 20, 2010. Motion by Supervisor Hotynski and seconded to approve. CARRIED BY VOICE VOTE.

COUNTY BOARD CHAIRMAN REPORT

Chairman Albrecht reported that Supervisors Hamblin and Finch are excused from tonight's meeting. Chairman Albrecht stated that the county's committees and boards, as well as the departments, have played an important role in the efforts to make Winnebago County "green" as described by County Executive Harris.

COMMUNITY PARK BEACH PROGRAM – ROB WAY, WINNEBAGO COUNTY PARKS DIRECTOR

Rob Way, Winnebago County Parks Director, presented information on the proposed 2008 program for the Community Park beach.

Mr. Way explained the importance of Community Park to the county and its communities. The park accommodates approximately 125,000 visitors per year and requires continuous maintenance, upkeep and financial support. Mr. Way explained that financial support not only comes from the county, but from area groups and organizations and revenue sources.

Mr. Way stated that this proposed beach program would re-open the beach as a "swim at your own risk" facility. There would also be a park service center/concession operation that would be run from the beach house.

Mr. Way explained that the beach area is a fenced, three acre site located in the center of the Community Park with a 1.2 acre, aerated lake surrounded by 2 acres of beach front. There is also a 4,000 sq. ft. beach house that contains men's and women's showers and restrooms; a 1,200 sq. ft. patio area with picnic tables and benches; and a concession stand with an attached kitchen facility.

Mr. Way stated that for the last two summers the beach has been closed because of the loss of lifeguards from the Oshkosh Area School District, who began working at the new Oshkosh water park (formerly Pollock Pool). The lake has been emptied so that work can be done on the drainage system and remove the cement diving platform.

Mr. Way explained that his department and the Parks & Recreation Committee have developed a proposal that would reopen the beach at minimal cost. It would become a free-access beach with a staff presence at the beach entrance, which is the beach house. The beach house would become the park service center and concession stand building. It would be staffed seven days a week with a crew of two or three people from June through August, 10:30 a.m. until 8:00 p.m. These seasonal workers would be paid between \$8.00 and \$10.00 per hour and would provide supervision to people using the facility. They would also operate the concession and retail sale stand, which would also provide the public the opportunity to access other Parks Department services, such as boat landing parking permits, park shelter sign ups and the Expo Center overnight camping facility.

Mr. Way asked that the Board not look at this program as a new proposal, but see it as the "revival" of an old program that his department had provided to the county for many years.

Mr. Way then took questions from the Board.

WHEREAS, should the need arise for the Wisconsin Department of Transportation to have to temporarily close said portion of the WIOUWASH Trail then the Wisconsin Department of Transportation agrees to keep such closing to a minimum and to reopen the trail section as quickly as possible; and

WHEREAS, the Wisconsin Department of Transportation shall assume responsibility for ensuring that all the affected property along the WIOUWASH Trail is restored to an acceptable standard, as determined by the Winnebago County Parks Department; and

WHEREAS, the Wisconsin Department of Transportation shall assume responsibility to pay any liabilities arising out of the exercise of the temporary construction easement; and

WHEREAS, your undersigned Committee believes that it would be in the best interest of Winnebago County to proceed in approving the aforementioned temporary construction easement in order to accommodate road improvements at the Hwy. 45/County Road T/Ryf Road intersection.

NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors that it hereby authorizes the County Executive to proceed to grant a thirty (30) day construction easement to the Wisconsin Department of Transportation in order to perform grade changes on County owned property within a one-hundred (100) foot circumference of the intersection of Ryf Road and the WIOUWASH Trail: and

BE IT FURTHER RESOLVED, by the Winnebago County Board of Supervisors that it hereby authorizes that the official activation of the thirty (30) day construction easement shall commence in the later half of 2007 and begin fourteen days following a required notice being presented to the Winnebago County Parks Department by Wisconsin Department of Transportation.

RESOLUTION NO. 294-102007: Application for Aids from the Oshkosh Convention & Visitors Bureau's Capital Development Fund to Assist in Efforts to Expand the Campground Facilities at the Sunnyview Exposition Center

WHEREAS, Winnebago County maintains campground facilities at the Sunnyview Expositions Center that over the years have accommodated a standard client base made up of horse show participants as well as concert and festival goers; and

WHEREAS, over the course of Expo operations much of the design and development of the campgrounds have been customized to fit the basic needs of said client base; and

WHEREAS, Winnebago County continues to experience great success in capturing the majority of the horse show market in the northeast region of the state; and

WHEREAS, the horse shows themselves are maintaining their own success and are continuing to grow because of the excellent facilities that Winnebago County has fostered at the Sunnyview Exposition Center; and

WHEREAS, in order to accommodate the growth in the size of said horse shows it is necessary to expand the Expo camping capacity; and

WHEREAS, the Expo grounds contain an available parcel of land near to an electrical source that is of sufficient size to service the new camping facility; and

WHEREAS, an estimated \$157,400 will be needed in order to improve the camping facility to the required standard where each of the 25 sites contains an adequate gravel base pad with separate electrical pedestal; and

WHEREAS, The Oshkosh Convention & Visitors Bureau's Capital Development Fund gives grants for capital costs related to development of visitor attractions and amenities.

WHEREAS, it is proposed that Winnebago County seek \$157,400 in funding assistance from the Oshkosh Convention & Visitors Bureau's Capital Development Fund in order to help expand the camping facilities at the Sunnyview Exposition Center.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that the County Executive be and he hereby is authorized to submit an application on behalf of Winnebago County to the Oshkosh Convention & Visitors Bureau for such funding aids as may be available for expansion of the camping facilities at the Sunnyview Exposition Center.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it shall require that the full County Board approve the acceptance and appropriation of donations to Winnebago County from the Oshkosh Convention & Visitors Bureau for the Sunnyview Exposition Center Campground Expansion Project.

RESOLUTION NO. 295-102007:

Application for Aids from the Oshkosh Convention and Visitors Bureau's Capital Development Fund to Expand & Improve the Community Park Disc Golf Course

WHEREAS, the sport of disc golf began over 30 years ago and has since grown in popularity to a point where there are now more than 19 courses located in the NE region of the state; and

WHEREAS, with the extensive areas of unused space found in the Community Park the property contains such attributes so as to make it an ideal location within which to develop the sport of disc golf; and

WHEREAS, the Parks Department has recently installed the first 15 holes of what may someday be a 36 hole disc golf course within the Community Park; and

WHEREAS, the dedication of small portions of Community Park property towards the establishment of a disc golf course has had little or no impact on the amount of funds available in the Parks Department's '07 Grounds Maintenance Account; and

WHEREAS, the widespread popularity of the Community Park course has already become evident by the large volume of disc golf participants observed using the facility day-after-day; and

WHEREAS, it is the department's goal to not only fashion a quality disc golf course for local enthusiasts but to also develop a facility that will meet requirements for the hosting of regional and state competitions and to thereby create a positive economic impact from dollars spent in the area by visitors from outside the community; and

SHERIFF'S RESERVE DEPUTIES.

Definitions.

"Reserve Deputy" is an adult deputized by the Winnebago County Sheriff for the purpose of voluntarily performing those duties as are set forth herein...

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that Section 5.02(4)(a)(3) of the General Code of Winnebago County be deleted. (That Section of the current Code reads as follows:

"In order for a person to qualify for deputization by the Sheriff as a Sheriff's Reserve Deputy that person shall first meet the following qualifications: ...

The person shall have been a resident of Winnebago County for at least six months prior to the date of deputization.")

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that said amendment to said Ordinance shall take effect on the date following the date of its publication.
