ADJOURNED SESSION WINNEBAGO COUNTY BOARD MEETING TUESDAY, FEBRUARY 27, 2007

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

The following Supervisors were present: Barker, Griesbach, Hotynski, Ramos, Maehl, Koziczkowski, Pollnow, Widener, Lauson, Albrecht, Anderson, Thompson, Lohry, Lennon, Farrell, Hall, Wingren, Jacobson, Norton, Warnke, Drexler, Robl, Schmuhl, Kline, Locke, Eisen, Schaidler, Finch, Farrey, Sievert, Arne, Diakoff, Brennand, Egan, Ellis, Rengstorf and O'Brien.

Motion by Supervisor Robl and seconded to adopt tonight's amended agenda. CARRIED BY VOICE VOTE.

COMMUNICATIONS, PETITIONS, ETC.

Notice of Claim received from Attorney Michael Limm for Tiffanie & Diane Goetz for damages resulting from incidents in a county foster home was referred to the Personnel & Finance Committee.

Notice of Injury received from Andrew R. Liverman of Gendlin & Liverman, S.C., for Arden Robel for injuries sustained in an accident with a Winnebago County Health Department vehicle was referred to the Personnel & Finance Committee. (Corporation Counsel's Office determined that this notice of injury will not be sent to the Personnel & Finance Committee until an actual Notice of Claim is received for this incident.)

Petition for zoning amended from Mike Hullar, Town of Nekimi, for zoning change for tax parcels 0120531 and 0120533 from A-1 to A-2 for residential and agriculture was referred to the Planning & Zoning Committee.

A thank you note from Supervisor Koziczkowski was read thanking the Board for the flowers they sent for his mother's funeral.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Egan reported that the roof on the Orrin King Administration Building was scheduled to be replaced this year at a cost of \$100,000. However, a new method of preserving the existing roof for another 5-10 years at a cost of \$10,000 will be done instead. Supervisor Egan reported that the Park View Health Center project is back on schedule. All footings, except for the garage, have been poured and most of the steel framing is up for the first floor and 1/3rd of the second floor.

Supervisor Warnke thanked the board for the plant that was sent to him after his recent knee surgery. He reported that he is doing well.

Supervisor Widener reported on actions taken by various WCA Steering Committees in the past month:

- Health & Human Services voted against placing 17 year olds back into the juvenile system.
- Personnel discussed Act 100 regarding county board downsizing. They proposed amendments to various provisions of Act 100.
- Personnel discussed Act 420 regarding libraries charging counties for their residents' use of other counties' libraries. Based on 2005 figures, this could potentially cost Winnebago County about \$111,000 annually. Winnefox Library is working with the WCA on modifications to this fee.

Supervisor Barker thanked the Board for the flowers that were sent to her after her recent surgery. She is doing very well. Supervisor Barker reported that the next Legislative Committee meeting will be in March. Items for the agenda should be given to her as soon as possible.

Supervisor Robl reported that the state Department of Transportation will begin work on the County Road T and Highway 45 interchange this year. He thanked area legislators for their efforts to get this project moved up on the

state's schedule.

Supervisor Eisen reported on his attendance at the 2007 Winter Conference of the Wisconsin Counties Solid Waste Management Association and Associate Recyclers. He reported that his attendance at this conference greatly broadened his knowledge of Solid Waste Management Board activities and the successful operation of solid waste management in the county.

Motion by Supervisor Lauson and seconded to approve the proceedings from the January 9 & January 16, 2007 meetings. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris addressed various newspaper articles about counties' with unfunded pension liabilities. He explained that changes in government accounting standards requires counties to explain in footnotes any unfunded liabilities that they have. Other states do have under-funded pensions, but Wisconsin's state retirement system is fully funded. Winnebago County's only significant unreported liability is the value of paid out sick time when an employee leaves or retires. Executive Harris believes that amount is approximately \$3.5 Million. This amount should decrease because sick leave accumulation was frozen on December 31, 2005. A reduction in employees should also help to decrease this amount.

Executive Harris recommended that the Board not take action on Resolution No. 166-22007, "Name County Building at Sunnyview Complex the Paul W. Stevenson Building." He feels that naming rights for this building could generate revenue for the county and that those options need to be explored before naming the building after Mr. Stevenson. Executive Harris stated he believes some county building should be named after Mr. Stevenson, but that the Expo Building may not be the best choice.

COUNTY EXECUTIVE'S APPOINTMENTS

East Wisconsin Counties Railroad Consortium

Executive Harris asked for the approval of Jef Hall to the East Wisconsin Counties Railroad Consortium. He will fill the unexpired term of Forrest Weber. This is a two (2) year term, which will expire April 15, 2008. Motion by Supervisor Lauson and seconded to adopt. CARRIED BY VOICE VOTE.

Local Emergency Planning Commission

Executive Harris asked for the approval of Todd Foerster and Amos Mikkelson to the Local Emergency Planning Commission. These are three (3) year terms, which will expire December 31, 2009. Motion by Supervisor Widener and seconded to adopt. CARRIED BY VOICE VOTE.

Long Term Support Advisory Committee

Executive Harris asked for the approval of Judy Thomas to the Long Term Support Advisory Committee. This is a three (3) year term, which will expire April 21, 2009. Motion by Supervisor Robl and seconded to adopt. CARRIED BY VOICE VOTE.

Oshkosh Public Library Board of Trustees

Executive Harris asked for the approval of Arlene Schmuhl to the Oshkosh Public Library Board of Trustees. She will fill the unexpired term of Patrick Brennand who resigned. This is a three (3) year term, which will expire December 31, 2009. Motion by Supervisor Lauson and seconded to adopt. CARRIED BY VOICE VOTE.

Winnefox Library System Board of Trustees

Executive Harris asked for the approval of Christopher Kunz to the Winnefox Library System Board of Trustees. He will fill the unexpired term of Merry Whipple who resigned. This is a three (3) year term, which will expire December 31, 2008. CARRIED BY VOICE VOTE.

COUNTY BOARD CHAIRMAN'S REPORT

Chairman Albrecht reported that Supervisor Drexler asked to be excused from tonight's meeting. (Supervisor Drexler arrived later to the meeting.)

Chairman Albrecht read a letter from Margie Rankin, Park View Health Center Administrator, thanking everyone who made donations to the Park View Health Center construction fund in memory of Forrest and Dale Weber. A bronze leaf bearing their names will be placed on Park View's giving tree as a permanent reminder of their

contributions to Park View Health Center and Winnebago County.

Chairman Albrecht read a letter from Supervisor James Lauson announcing his resignation from the County Board as of February 28, 2007. The Board recognized Supervisor Lauson's service on the Board with a round of applause.

Chairman Albrecht announced that the Personnel Function Review Committee will hold their first meeting on Wednesday, March 13 in Room 60 of the Courthouse.

COUNTY BOARD CHAIRMAN'S APPOINTMENTS

Supervisory District No. 1

Chairman Albrecht asked for the approval of Stanley Sevenich to Winnebago County Supervisor District No. 1. He will complete the unexpired term of Forrest Weber, who passed away. Mr. Sevenich's term will begin immediately and end on April 15, 2008. Motion by Supervisor Finch and seconded to adopt. CARRIED BY VOICE VOTE.

Parks & Recreation Committee

Chairman Albrecht asked for the approval of Supervisor Stanley Sevenich to the Parks & Recreation Committee. He will replace James Lauson who resigned from the Board. Motion by Supervisor Hotynski and seconded to adopt. CARRIED BY VOICE VOTE.

Park View Health Center Committee

Chairman Albrecht asked for the approval of Supervisor Tom Ellis to the Park View Health Center Committee. Supervisor Ellis will replace Forrest Weber who passed away. Motion by Supervisor Arne and seconded to adopt. CARRIED BY VOICE VOTE.

Scholarship Committee

Chairman Albrecht asked for the approval of Supervisor Diakoff to the Scholarship Committee. She will replace Supervisor Forrest Weber who passed away. Motion by Supervisor Finch and seconded to adopt. CARRIED BY VOICE VOTE.

REPORT ON COUNTYWIDE PHONE SYSTEM UPGRADE PATTY FRANCOUR, INFORMATION SYSTEMS DEPARTMENT DIRECTOR

Patty Francour, Information Systems Department Director, and Gina Eiden, Telecommunications Coordinator, gave a Powerpoint presentation explaining the county's current telephone system configuration and the proposed upgrade for that system.

Ms. Francour explained that this upgrade does not have anything to do with the telephone equipment used by employees' at their desks, but is an upgrade to the infrastructure equipment located in each of the county's buildings that make those phones work.

Ms. Francour stated that a request for proposal was sent out and after evaluating three responses, it was determined that based on cost and contact with the vendors, the best partner for this project will be North American Communication Resources (NACR).

Ms. Francour explained that currently the county has four primary switches, four communication lines to the provider and four locations that need to be administered. The four primary switches are located at the Sheriff's Office, Neenah Human Services, Park View Health Center and the Courthouse. Fiber connectivity also runs between these four locations. Ms. Francour stated that voice mail is administered through the courthouse switch. Because the courthouse fiber connectivity is direct to Park View Health Center, if that connection were interrupted, voice mail at the other two sites would also be interrupted.

The Expansion Port Network (EPN), which is other relatively large sites that have hardware but aren't considered primary switch sites, include Oshkosh Human Services, Workforce Development Center, James P. Coughlin Center and the Work Release Center. There are numerous other locations that are supported by the county's telephone system--airport, landfill, parks, etc.

Ms. Francour then explained why this upgrade is needed. Those reasons include:

- Technical support of current system will end in 2008
- Unacceptable downtime to relocate existing hardware for Park View Health Center
- Licensing costs per switch
- Single points of failure for each site
- Inefficiency with programming four sites

- "Add ons" must be licensed for each of the four switches--costly
- Voice Over IP (VOIP) would require hardware and software investments
- Intuity voice mail system faces end of support in 2011. June 2007 mailbox sales end.

The proposed configuration takes into account the significant investment the county has in its current system and is less expensive then other alternatives. The proposed configuration would include one primary switch location, four communication lines to provider and one location to administer. Ms. Francour explained that the cost for the proposed project is \$575,000. Because of the need to address this issue before Park View Health Center moves into their new building and before technical support for our current system ends in 2008, the Board's approval of this project will be requested in March 2007.

Ms. Francour then took questions from the Board. A copy of the Powerpoint presentation is on file in the County Clerk's Office.

PUBLIC HEARING

Todd Stevenson, 1341 Blueberry Lane, Neenah, spoke on Resolution No. 167-22007, "Authorize Commendation to James Lauson, District 10 Board Supervisor for Extended Years of Service Rendered to Winnebago County". Mr. Stevenson extended his thanks to Supervisor Lauson for his years of service on the County Board. Mr. Stevenson also spoke on Resolution No. 166-22007, "Name County Building at Sunnyview Complex the Paul W. Stevenson Building," which refers to his father, Paul W. Stevenson. Todd explained that his father would understand the county's need to take into consideration the naming rights of this building and the potential for revenue before naming this building after Paul Stevenson. However, because of Paul's passion for the county fair and his involvement in the relation of the fairgrounds to its current site, the family would be honored if the county would see fit to name a building at the fairgrounds after Paul at some point.

Bill Roh, 575 Riford Road, Neenah, spoke on Ordinance No. 170-22007, "Amend Section 2.01 of the General Code of Winnebago County". Because of the minor changes between this map and the one previously approved, he wondered whether it will be approved by the County Board and the County Executive.

REDUCING THE SIZE OF THE WINNEBAGO COUNTY BOARD OF SUPERVISORS PRESENTATION BY CHAIRMAN DAVID ALBRECHT

Chairman Albrecht gave a Powerpoint presentation on the findings and final determination of the Temporary Committee on County Board Size. He reported the following to the Board:

- Members of the Temporary Committee on County Board Size Supervisors Nancy Barker, Bernie Egan, Joseph Hotynski and Thomas Widener; Joe Knoll, Kathleen Propp and Larry Spanbauer.
- This committee voted 5-0 to present this information to the full county board.
- Wisconsin Act 100 allowed for the reduction in county board size by either citizen petitions or county board action once between censuses.
- It became apparent that a reduction in the board's size was going to happen--either by board action or petition.
- The County Board approved the formation of a committee to study the size of the board and the Chairman appointed the members. During this time "Citizens United to Transform the Winnebago County Board" (CUT) began circulating a petition to downsize the board.
- Under provisions of Wisconsin Act 100 and to forestall the petition drive, the County Board voted to reduce their size from 38 to 36 members, to take affect in 2008.
- The Temporary Committee on County Board Size determined that 28 was the appropriate number of supervisors for Winnebago County following the 2010 census. This is the "right" number based on the following three items:
 - ✓ Rural representation
 - > Board representation is more important to rural areas than municipal areas
 - > Rural representation becomes less as size of board decreases
 - > CUT was not concerned with this premise at this time
 - > Any minority would prefer 12 of 38 versus 6 of 19
 - Compromise is necessary
 - Conclusion committee feels that any number under 28 would exacerbate the already adverse impact on rural representation
 - ✓ Committee structure

- > Other county board committees' structure was examined and ideas were noted
- > Winnebago County must "organize" based upon its unique character
- Conclusion reduction in the number of committees by combining will not necessarily make us more efficient
- ✓ The impact of the "domination of the minority"
 - > 28 is the necessary minimum to retain committee oversight
 - > 28 minimizes the "domination of the minority"
 - Presently 13 votes can defeat a resolution that requires a 2/3 majority
 - Presently 10 votes can defeat a resolution that requires a 3/4 majority for bonding issues
 - With 19 members, that becomes 7 and 5 respectively
 - With 28 members, that becomes 10 and 9 respectively
- The reduction to 28 will go into effect after the 2010 census
- Allows for census blocks to be used to determine district boundaries
- Allows time to modify committee structure

Chairman Albrecht commended John Bodnar, Corporation Counsel, for his expertise and work in guiding the county through the CUT petition court case.

Chairman Albrecht took questions and comments from the Board and Larry Spanbauer, a member of the Temporary Committee on County Board Size. A copy of the Powerpoint presentation is on file in the County Clerk's Office.

RESOLUTION NO. 149-22007:

Authorize \$1.7 Million of Project Funding for the 2007 Phase of Pavement Resurfacing on County Trunk Highway E from Kirkland Road in the Town of Algoma to STH 116 in the Town of Omro.

WHEREAS, County Trunk Highway E (CTH E) is functionally classified as a major collector highway; and WHEREAS, CTH E from Kirkland Road in the Town of Algoma to STH 116 in the Town of Omro has an average daily traffic (ADT) count of 2800 vehicles; and

WHEREAS, CTH E has experienced a significant increase in commuter and truck traffic in recent years due to motorists who use this roadway in order to access the City of Oshkosh, USH 41 and other connecting highways; and

WHEREAS, CTH E has not been resurfaced in over thirty years and has been repeatedly seal coated over the life of the roadway in order to preserve it; and

WHEREAS, the underlying asphalt surface of CTH E is experiencing extensive wheel rutting and overall deterioration due to the age of the pavement and the increase in traffic including heavy trucks.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates the sum of \$1,700,000 from the General Fund of Winnebago County to pay for the resurfacing of CTH E from Kirkland Road to STH 116.

BE IT FURTHER RESOLVED, by the Winnebago County Board of Supervisors that funds to pay for said project are hereby appropriated from the General Fund of Winnebago County, with said fund to be reimbursed from a subsequent bond issue of \$1,700,000 in order to pay for the project costs.

BE IT FURTHER RESOLVED, by the Winnebago County Board of Supervisors that the 2007 Road Maintenance Materials expense budget of the Highway Department will be increased by \$800,000, and the Interfund Highway Services revenue budget will also be increased by \$800,000 to reflect work that will be performed by the Highway Department and materials provided directly by the Highway Department to the project.

RESOLUTION NO. 150-22007: Authorize and Appropriate \$178,000 Needed to Begin the Design Work for the CTH T Project from CTH Y to CTH G.

WHEREAS, the Winnebago County Board of Supervisors supports the design and reconstruction of County Trunk Highway T from County Trunk Highway Y to County Trunk Highway G; and

WHEREAS, the project will begin approximately .25 miles south of CTH Y and continue north to the intersection of CTH G, a distance of approximately 4 miles; and

WHEREAS, the project is in the Winnebago County Five Year Capital Improvement Plan; and

WHEREAS, the design project will include two proposed roundabouts which will be located at the intersection of CTH Y and CTH GG; and

WHEREAS, the adjacent area near the CTH T corridor is expected to continue to develop rapidly in the near future as other local and state highway projects are completed; and

WHEREAS, the roadway surface on CTH T is continuing to deteriorate due to the age and condition of the original concrete road bed and inadequate subgrade materials beneath it; and

ORDINANCE NO. 170-22007: AMEND SECTION 2.01 OF THE GENERAL CODE OF WINNEBAGO COUNTY

WHEREAS, the Winnebago County Board of Supervisors recently reduced the size of the County Board from 38 members to 36 members; and

WHEREAS, a new district map must be created in relationship to the decrease in the number of Supervisory Districts; and

WHEREAS, the Planning Department has created a map with proposed Supervisory Districts, pursuant to Section 59.10 Wisconsin Statutes, wherein no wards are split and the deviation between the sizes of the various sizes of the districts is minimized as much as is possible pursuant to the present statutory scheme.

NOW, WHEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 2.01 of the General Code of Winnebago County be amended to read as follows: (Please see attached amended resolution).

2.01 SUPERVISORY DISTRICTS CREATED

(1) Pursuant to Sec. 59.03, Wisconsin Statures, there is hereby created a total of 36 Supervisory Districts for Winnebago County wherein 36 County Supervisors shall be elected.

(2) The numbering of each Supervisory District and the boundaries thereof are as follows: (See Exhibit A attached)

(3) This Section of the Code shall take effect and be in force upon passage and publication to cover the election of Winnebago County Board Supervisors to be elected in the Spring of 2008 and thereafter until further action of this County Board.

(4) The Chairperson of the County Board shall file a certified copy of this Ordinance with the Secretary of State to satisfy the requirements of law and the same shall constitute the final redistricting plan of Winnebago County.

(5) The terms "boundaries", "boundary limits", "boundary line limits", and "boundary lines" as used in "Exhibit A" of this Ordinance shall be defined as the boundaries of towns, villages, cities, and tax parcels within Winnebago County as in existence on February 12, 2007.

(6) References to streets, roads, avenues, highways, railroad tracks and other fixtures referred to as district boundaries in this Ordinance are defined as the location of such fixtures as of February 12, 2007.
