WINNEBAGO COUNTY BOARD MEETING TUESDAY, JUNE 15, 2010

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

The following Supervisors were present: Konetzke, Barker, Eisen, Ramos, Roh, Smith, Widener, Hamblin, Albrecht, Gabert, Swanson, Thompson, Lennon, Hall, Wingren, Jacobson, Norton, Warnke, Robl, Kline, Locke, Hegg, Finch, Farrey, Diakoff, Brennand, Egan, Ellis, Rengstorf and Reinert. Excused: Miller, Reynolds, Eichman, Neubauer and Sievert.

Motion by Supervisor Robl and seconded to adopt tonight's amended agenda. CARRIED BY VOICE VOTE.

PUBLIC HEARING

COMMUNICATIONS, PETITIONS, ETC.

Petition for Zoning Amendment from Richard DeKleyn, Town of Menasha, for zoning change for tax parcel nos. 008-5670, 008-5671, 008-5672 & 008-5673 from R-3 to R-2 for construction of single-family homes was referred to the Planning & Zoning Committee.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Barker reported on her attendance at Clayton Fest. She said everyone had a wonderful time and she encouraged other supervisors to attend next year.

Supervisor Finch reported that the "Public Enemy" movie commemorative bench has been placed on the WIOUWASH Trail.

Supervisor Finch reported that he has asked the Highway Committee and John Haese, Winnebago County Highway Commissioner, to consider allowing vehicles exiting the Speedzone racetrack on Highway 76 to turn left. Prior to the construction project on County Road Y, left hand turns were allowed on to Highway 76 from the racetrack and he his hoping they will allow them again.

Supervisor Eisen reported on his attendance at the WCA educational seminar in Stevens Point regarding dealing with OWI offenders. At this seminar, he learned about public safety programs that are used as alternatives to incarceration.

Supervisor Widener reported that Catherine Neiswender, Winnebago County Community Resource Development Educator, received the Epsilon Sigma Phi Extension Professional Association's Mid-Career Service Award. Ms. Neiswender received the award because of her "significant contributions to extension programs during the second tenure" of her career.

Supervisor Kline reported that the Legislative Committee will not meet in June.

Supervisor Ramos reported that Resolution No. 65-62010 on tonight's agenda will be withdrawn pending further discussion with other county department heads on the issue.

Motion by Supervisor Robl and seconded to approve the proceedings from the May 18 County Board meeting. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris spoke to the Board about the county's participation in the Self-Sufficiency Projects Bare Essentials Campaign. He explained that this is a project to collect new socks and underwear for people in need in the community. There are collection boxes in the County Executive's Office, the County Clerk's Office, at the Sheriff's Office and at the James P. Coughlin Center where people can drop off their donations. Donations will then be distributed through St. Vincent DePaul.

Executive Harris discussed Resolution Nos. 66-62010 and 67-62010. He explained that both of these resolutions deal with future, non-represented employees. The goal of both of these resolutions is to reduce the amount that the county would pay towards the employees' state retirement plan. Executive Harris expressed some concern that because of the size of the proposed wage increases that the county is offering—1.5% or less—this large of a "shift of costs on to the employees" would most likely not fit the definition of quid pro quo and could cause problems for the county. If this provision only affected the non-represented employees, it might cause them to look for representation. This provision would also narrow the gap between represented and non-represented employees, making the represented employees' contract stronger. This type of disparity can also cause problems.

Executive Harris discussed the resolutions on tonight's agenda that are in regards to the county's Industrial Development Board. He explained that a number of years ago the Solid Waste Management Board transferred \$4 Million of their reserves to the Industrial Development Board's revolving loan fund. Executive Harris stated that \$4 Million was to be returned to the Solid Waste fund by 2010. When that money is returned to Solid Waste, there will be very little money available for the Industrial Development Board to loan. Executive Harris stated that the loans provided by the Industrial Development Board to the county's municipalities has been very successful and are still needed, especially during these economic times. Executive Harris encouraged the Board to pass these resolutions.

COUNTY EXECUTIVE'S APPOINTMENTS

Board of Adjustment

Executive Harris asked for the Board's approval of his reappointments of Arden Schroeder, 9458 Highway 76, Neenah; and Greg Kargus, 2934 Shorewood Drive, Oshkosh; to the Board of Adjustment. These are three-year terms that will expire on June 30, 2013. Motion by Supervisor Farrey and seconded to approve. CARRIED BY VOICE VOTE.

Local Emergency Planning Commission

Executive Harris asked for the Board's approval of his appointment of Ann Lagorio, Emergency Preparedness Coordinator at Aurora Medical Center, to the Local Emergency Planning Commission. Ms. Lagorio replaces Greg Gibbons whose term will expire on December 31, 2011. Motion by Supervisor Finch and seconded to approve. CARRIED BY VOICE VOTE.

Menasha Library Board

Executive Harris asked for the Board's approval of his appointment of Supervisor Paul Eisen to the Menasha Library Board. This is a three-year term that will expire on June 30, 2013. Motion by Supervisor Finch and seconded to approve. CARRIED BY VOICE VOTE.

Mississippi Valley Health Services Commission

Executive Harris asked for the Board's approval of his appointment of Supervisor Tom Widener to the Mississippi Valley Health Services Commission. This is a two-year term that will expire on June 30, 2012. Motion by Supervisor Kline and seconded to approve. CARRIED BY VOICE VOTE.

COUNTY BOARD CHAIRMAN'S REPORT

Chairman Albrecht reported that Supervisors Eichman, Miller and Neubauer are excused from tonight's meeting.

Chairman Albrecht thanked Supervisor Farrey for his donation to the county's scholarship fund.

Chairman Albrecht announced that he will be presenting his recommendation for appointment to Supervisor District 3 at the July meeting.

Chairman Albrecht recognized Supervisor Norton for bring a birthday cake for tonight's meeting.

PRESENTATION OF 2010 COUNTY SCHOLARSHIPS

Supervisor Widener presented Winnebago County's 2010 Scholarships to the following students: Julia Sprangers, Oshkosh West High School; Emily Wagner, Oshkosh North High School; Heather Smaby, Neenah High School; Benjamin Brand, Oshkosh West High School; Logan Schneider, Menasha High School; Joshua McAfee, Omro High School; Mikaela Skalmoski, Neenah High School; and Erin Look, Neenah High School. Breana Butt, an Omro High School graduate, was also awarded a scholarship, but she was not able to attend tonight's meeting. The Board recognized the students with a round of applause.

INVESTING IN YOUR FUTURE - CHANCELLOR DAVID WILSON, UW-COLLEGES & UW-EXTENSIONS

Chris Kniep, UW-Extension Department Head and Family Living Educator, introduced Chancellor David Wilson of UW-Colleges and UW-Extensions. Chancellor Wilson began his presentation by thanking the Board for their continued support and investment in UW-Fox Valley and the UW-Extension Department of Winnebago County.

Chancellor Wilson explained the structure of the University of Wisconsin and how it's broken into the following four sections:

- Two doctorate/research universities Madison and Milwaukee
- 11 comprehensive-to-masters universities Oshkosh, Stevens Point, Whitewater, etc.
- 13 UW colleges UW-Fox Valley, etc.
- UW Extension systems

Chancellor Wilson stated that the UW-Extension has the third largest budget in the University of Wisconsin system at \$225 Million. UW-Madison has the largest budget at \$2.5 Billion and UW-Milwaukee is second with an operating budget of approximately \$700 Million. The operating budgets of UW-Oshkosh and UW-Stevens Point are ranked fourth and fifth respectively.

Chancellor Wilson explained that there are four major divisions in UW-Extension:

- 1. Broadcasting & Media Innovations
- 2. Continuing Education, Outreach and E-Learning
- 3. Cooperative Extension (offices in all 72 counties and three tribal nations in Wisconsin)
- 4. Entrepreneurship & Economic Development (12 small business development centers across the state)

Chancellor Wilson explained that over 13,000 students are enrolled at the 13 UW colleges. These colleges are staffed by approximately 980 full-time faculty.

Chancellor Wilson stated that every year the 75 cooperative extension offices serve approximately 1.5 million people in the State of Wisconsin—that is approximately 35% of the state's entire population. These offices are staffed by approximately 1,600 faculty and staff.

Chancellor Wilson stated that approximately 33% of the UW colleges and extension offices funding comes from the state and approximately 11-12% comes from the federal government. Chancellor Wilson explained that Winnebago and Outagamie Counties have made a "huge investment in the future" of UW-Fox Valley, because they own the facilities on the campus and they pay 40% of the salaries for the professional staff and 100% of the salaries for the support staff. Chancellor Wilson explained that the UW colleges and the extension offices literally cover the whole State of Wisconsin and provide services to its citizens.

Chancellor Wilson addressed the Board about the success of their investment in UW-Fox Valley. He explained that at this year's commencement, seven students received their Bachelor of Science Degree in Engineering because of, "the most innovative program of its kind in the United States." This nationally accredited program at UW-Fox Valley is the result of a partnership between themselves and UW-Platteville that allows students to receive their bachelor degree in engineering from UW-Platteville without ever leaving the UW-Fox Valley campus. Chancellor Wilson stated that 48 students have graduated from that program over the last five years and 47 of them are employed as engineers in this area, which is a great return on the investment the county is making on UW-Fox Valley.

Chancellor Wilson also explained that students who graduate from UW-Fox Valley or any of the other twoyear campuses with an Associates Degree and then transfer to one of the four-year colleges, have an 82% graduation rate. This is the highest graduation rate in the UW system.

Chancellor Wilson also praised the county for their investment in the Communication Arts Center at UW-Fox Valley. He stated that it not only benefits UW-Fox Valley, but it also benefits the community as a "major cultural and information hub". They are currently averaging 13 events each week at the center.

Chancellor Wilson stated that the Barlow Planetarium is another wonderful asset at UW-Fox Valley and last year drew over 6,000 visitors from across the state. Likewise, the Weis Earth Science Museum provided tours to more than 11,000 school children and thousands of other guests from around the world.

Chancellor Wilson also commended the UW-Fox Valley Foundation for their contributions to the success of the UW-Fox Valley campus and its students through scholarships and fundraising.

Chancellor Wilson explained that last week the UW Board of Regents froze the tuition for the two-year

colleges for the fourth straight year. A student at a two-year campus like UW-Fox Valley will pay \$1,500 less in tuition than a student at a four-year campus, \$3,300 less than a student at UW-Milwaukee and \$4,000 less than a student at Madison. A two-year campus is a wonderful opportunity for those families that would find it financially difficult to send their child to a four-year campus for the first two years of a bachelor's degree.

Chancellor Wilson thanked Winnebago County for their support of the University Extension Office and the \$500,000 that they budgeted last year for its operations. Chancellor Wilson explained that the county's investment leverages additional money and services from the state and federal government and from the University of Wisconsin. He described and explained various UW-Extension programs and how they partner with local organizations to meet the needs of the community:

- Home and community education groups
- Master gardeners
- Farmers
- Youth coalition
- Department of Corrections
- United Way and partner agencies
- Department of Natural Resources
- After School Matters program for Menasha youth
- Oshkosh Area Community Pantry
- Oshkosh Collaboration Workgroup
- Wisconsin Nutrition Education Program

Chancellor Wilson explained that the UW colleges and the UW Extension offices are partnering to propose a new program called the University of Wisconsin System E-Campus. This will provide one location for people to access all of the on-line bachelor and master degree programs from all of the universities in the state.

Chancellor Wilson stated that with the county's continued support the UW system will serve the needs of the county's residents and give the county a positive return on their investment.

ASPHALT REPLACEMENT PROGRAM - MIKE ELDER, FACILITIES DIRECTOR

Mike Elder, Winnebago County Facilities Director, explained that this is a multi-year project that will repair or replace failing asphalt surfaces at the county's facilities. In 2006, the courthouse parking lot was repaired. The next project is the Dawes Street parking lot, which is across the street from the Administration Building.

Mr. Elder explained that the Dawes Street parking lot was originally two residential lots that the county acquired approximately 25 years ago. The homes were razed, their foundations were demolished and the area was paved. Mr. Elder stated that this area has now settled and the base of the parking lot is failing, which is causing the asphalt to break up into small pieces.

Mr. Elder stated that the county will be hiring an engineering firm to design the parking lot, which must comply with the City of Oshkosh's parking lot requirements for green space and stormwater drainage. The estimated cost of the project is \$162,000, which will be included in a future bonding issue. The whole project should be done by the spring of 2011.

Mr. Elder took questions from the Board.

PARK VIEW HEALTH CENTER - STORAGE BUILDING

Margie Rankin, Park View Health Center Administrator; and Mike Elder, Facilities Director; spoke to the Board about the need for an underground storage space and space for therapy services at the Park View Health Center. Ms. Rankin stated that in 2008 the new Park View Health Center opened. Since that time, they have reduced their staff by 56 full-time positions—mostly through attrition—which has reduced their operating expenses. Park View Health Center's property allowance—the amount medical assistance pays the county towards the facility's mortgage—went from \$5.00/day to \$18.42/day, totaling \$672,000 in 2009.

Ms. Rankin reported that the county receives \$122,640 annually in private room allowance. In addition, utility costs at Park View have decreased by \$245,000 per year. Since moving into the new facility, their operating levy has decreased by \$1.1 Million, despite expenses going up 3%-5%. Ms. Rankin stated that the county should be proud that they have a facility like Park View Health Center where the residents and their families are so happy with their care and the facility itself.

Ms. Rankin explained that the new building was designed to give optimum space to the residents' rooms and licensed beds. Because there was no discussion on razing the Pleasant Acres building, space for storage, therapy, the kitchen and staff were minimized. Pleasant Acres was going to be used for additional storage for Park View Health Center.

Ms. Rankin explained that currently, equipment and residents' supplies are being stored at the old Pleasant Acres building and the Rehabilitation Pavilion. When something is needed during regular business hours, two

employees and a lift truck go to those buildings and retrieve the supplies or equipment.

Ms. Rankin explained that she believes the best solution would be to have an underground storage area at the new Park View facility that is climate controlled and could be accessed 24 hours a day, seven days a week.

Ms. Rankin showed slides of the current storage and therapy space situations at Park View Health Center.

Ms. Rankin also discussed the need for an increase in space for therapy. She explained that they have had a 69% increase in requests for therapy—physical, occupational and speech. This increase has come about because of the type of residents that live at Park View—they are people with high therapy needs.

Ms. Rankin explained that Park View Health Center's current therapy space of 1,452 sq. ft. is well below the industry standard range of 2,352 sq. ft. to 4,368 sq. ft. Ms. Rankin stated that they are proposing therapy space of 2,652 sq. ft.

Mr. Elder stated that they have looked at various options for storage/therapy space and explained his concerns for the different options. The alternative preferred by the Facilities & Property Management and the Park View Health Center Committees is an addition to the north end of the facility. It would be connected by walkways at the basement and first floor levels. This addition would allow for storage in the basement and therapy rooms on the first floor. Construction at the north end of the facility will also be less disruptive to the residents. Mr. Elder showed architectural drawings of Park View Health Center and the proposed addition.

Mr. Elder stated that the estimated cost for this project is \$1.3 Million. Ms. Rankin explained that this project is in the 5-year capital project plan. She also explained that Medicare is the primary payer for therapy and that since they have moved into the new Park View Health Center, their therapy reimbursement has gone up by \$1 Million.

Ms. Rankin and Mr. Elder took questions from the Board.

WITTMAN REGIONAL AIRPORT UTILITY EXTENSION PRESENTATION - PETER MOLL. AIRPORT DIRECTOR

Peter Moll, Wittman Regional Airport Director, reported that the airport is considering extending utilities to a hangar area at the north end of the airport. Mr. Moll explained that they have two lease agreements in place and one hangar under construction. They are experiencing some "challenges" with this construction because utilities going to that area are "either insufficient or non-existent".

Mr. Moll explained that ideally they would like to have four hangars constructed in this area. To reach this goal, they will need to bring natural gas, water, sewer and electricity to this area from 20th Street. The utilities will be brought to a central location and then individual lines will go from that central location to the individual hangars.

At approximately 7:50 p.m., Chairman Albrecht called for a brief recess. The Board reconvened at 8:05 p.m.

RESOLUTION NO. 51-62010: Authorize \$300,000 of Funding Needed to Begin Acquisition of Right of Way for the County Trunk Highway (CTH) T Project

WHEREAS, the Winnebago County Board of Supervisors supports the design and reconstruction of CTH T from CTH Y to CTH G; and

WHEREAS, the project will begin approximately .25 miles south of CTH Y and continue north to the intersection of CTH G, a distance of approximately 4 miles; and

WHEREAS, the project is in the Winnebago County Five-Year Capital Improvement Plan; and

WHEREAS, the project will include construction of one roundabout which will be located at the intersection of CTH Y and CTH T; and

WHEREAS, the adjacent area near the CTH T corridor is expected to continue to develop rapidly in the near future as other local and state highway projects are completed; and

WHEREAS, the roadway surface on CTH T is continuing to deteriorate due to the age and condition of the original concrete road bed and inadequate subgrade materials beneath it; and

WHEREAS, the estimated cost to acquire the right of way needed to construct the project is \$300,000.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates the sum of \$300,000 from the General Fund of Winnebago County for the right of way costs related to the reconstruction of County Trunk Highway T.

9.31 Prohibition of Smoking in Certain Places

- (1) Authority. This ordinance is adopted pursuant to that authority provided by § 101.123(4m), Wis. Stats.
- (2) <u>Section 101.123, Wis. Stats., incorporated herein by reference</u>. Section 101.123, Wis. Stats., to the extent such Statutory section requires any act be performed or prohibited, is hereby adopted and herein by reference made a part of this section of the General Code of Winnebago County as if fully set forth herein. Any act required to be performed or prohibited by § 101.123, Wis. Stats., is required or prohibited by this section of the Code.
- (3) Penalty. Any person who violates any provision of this section of the Code shall be subject to forfeitures of no less than \$100.00 but no greater than \$250.00 as is set forth in § 101.123(8), Wis. Stats.
- (4) Applicability. The provisions of this ordinance shall apply in all unincorporated areas of Winnebago County.
- (5) Effective Date: This ordinance shall become effective as of July 5, 2010.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that the first two paragraphs of Chapter 22, Section D, of the Handbook of Employee Policies covering non-represented employees of Winnebago County shall be amended to read as follows:

CHAPTER 22 FRINGE BENEFITS Section D. Retirement Benefits.

All regular full-time employees and regular part-time employees who are scheduled to work over 600 hours per year shall be enrolled in the Wisconsin Retirement System, which serves as the County's pension and permanent disability program.

In addition to its required employer share of the retirement program, Winnebago County also will pay the full employee's share for those employees who were offered and accepted employment with Winnebago County on or before August 1, 2010. The level of County participation and the cost of the employee's share shall be no greater than 6.5% for general employees and 7.0% for protected employees. The level of County participation and the cost of the employee's share may be adjusted from time-to-time by action of the County Board of Supervisors. For those employees who were offered and accepted employment with Winnebago County after August 1, 2010, said employees shall be responsible for paying one-half (1/2) of the full employee's share of participation in the Wisconsin Retirement System.

22. FRINGE BENEFITS

SECTION D

<u>RETIREMENT BENEFITS</u>. All regular full-time employees and regular part-time employees who are scheduled to work over 600 hours per year shall be enrolled in the Wisconsin Retirement System, which serves as the County's pension and permanent disability program.

In addition to paying its required Employer Share of the retirement program, Winnebago County also will pay the full Employee Share, up to 6.5% for General Employees and 7.0% for Protective Employees. For all newly hired and appointed non-represented employees of Winnebago County beginning employment on or after July 1, 2010, in addition to paying its required Employer Share of the retirement program, Winnebago County will also pay the full Employee Share, up to 6.0% for General Employees and 6.5% for Protective Employees. The level of County participation in the cost of the Employee Share may be adjusted from time to time by action of the County Board of Supervisors.

Under the Wisconsin Retirement System, retiring employees may be eligible for a retirement annuity based upon a payment formula that takes into consideration their length of employment under the System, their age at the time of retirement, and their qualified average earnings.

Employees terminating prior to achieving retirement age, may exercise various payment options in accordance with the rules of the program.

In addition to retirement pension benefits, permanently disabled employees may be eligible for permanent disability retirement benefits under the Wisconsin Retirement System.

Full information regarding the Wisconsin Retirement System is available through the Department of Human Resources. Most public employers in Wisconsin participate in the Wisconsin Retirement System making this benefit portable in many cases.

ORDINANCE NO. 68-62010: Amend Chapter 7 of the General Code of Winnebago County: Traffic Control

WHEREAS, the Winnebago County Highway Committee has recommended a variety of amendments to Chapter 7 of the General Code of Winnebago County; and

WHEREAS, said amendments would clarify the existing ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Winnebago County Board of Supervisors: That the following sections within Chapter 7 of the General Code of Winnebago County be amended as follows:

7.05 Driveway Permits Upon County Trunk Highways is repealed and superseded by Section 7.14 of the General Code of Winnebago County;

7.14 Driveway Access to County Trunk Highways

- (1) This ordinance is adopted pursuant to the authority granted under §§ 59.03 and 66.07(2), Wis. Stats. *This ordinance shall apply to all designated and undesignated county trunk highways in Winnebago County.* Section 7.14 (7)(i) shall be created to read as follows:
 - (7) Permit Required to Construct or Reconstruct Driveway. . .
 - (i) The Highway Department shall be authorized to remove all objects and obstructions from the rightof-way adjacent to existing driveway approaches that have not been previously authorized by a Winnebago County Highway Department permit.

Section 7.14(9)(h) shall be amended as follows:

- (9) Location, design and construction requirements
- (h) All driveways shall be constructed or reconstructed to have sloped sides. Such construction shall be accomplished using only soil materials. The side slopes of the driveway shall be sloped no more than a length-to-height grade ratio of 4:1 2:1. All slopes shall be seeded or sodded by the property owner. Section 7.14(13) shall be amended to state as follows:
 - (13) <u>Variances</u>. Any person or any office or department aggrieved by an order, requirement, or interpretation made by the commission may request a review of that order, requirement, or interpretation before the Winnebago County Board of Adjustment. Requests for variances shall be filed with the Winnebago County Zoning Department within 30 days of notification. A fee shall be paid at the time of filing pursuant to Section 17.02(12) of the General Code of Winnebago County.

BE IT FURTHER ORDAINED by the Winnebago County Board of Supervisors that the above amendments to this ordinance shall take effect on the date following the date of its publication.

RESOLUTION NO. 69-62010: Authorize Granting of Easement to Wisconsin Public Service for Gas Line, Wittman Regional Airport

WHEREAS, Wisconsin Public Service has requested that Winnebago County grant an easement to them for the purpose of constructing and maintaining a gas line at Wittman Regional Airport; and

WHEREAS, the Aviation Committee has recommended approval of the granting of said easement in that it will accommodate the extension of a pipeline which is needed by Wisconsin Public Service to accommodate an increase in service requests.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Clerk and Winnebago County Executive to execute a permanent easement for the existence and maintenance of a gas line at Wittman Regional Airport on property which is more particularly described as follows:

A part of the southwest ¼ of the northwest ¼ and part of the southeast ¼ of the northwest ¼, section 34, T18N, R16E, City of Oshkosh, Winnebago County, Wisconsin, and being comprised of a strip of land being 25 feet wide, lying southeasterly, easterly and northerly of and parallel to the reference line up to the right of way lines of Poberezny Road, Knapp Street, and State Highway 44, containing 36,034 square feet or 0.827 acres of property.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it also grants the construction easement for a strip of land being 25 feet wide lying southerly and northwesterly of, parallel with and adjacent to the aforementioned 25 foot wide strip of land lying between the east right of way line or State Highway 44 and the north property line with the EAA Aviation Foundation Inc. as shown on the attached map which is made a part of this Resolution by reference. Said construction easement shall remain active from the time construction begins until the ground surface restoration along the portion of the route has been complete. Said construction easement contains approximately 35,731 square feet or 0.821 acres.

SECTION C

GROUP HEALTH INSURANCE. Employees in regular full-time and regular part-time positions (50% or more) may participate in the single or family group health insurance programs sponsored by Winnebago County beginning on the first day of the month following their date of hire. Persons not enrolling at this time may be required to produce evidence of good health at the point of later enrollment. Employees who marry after their date of initial enrollment shall be eligible for family coverage provided that they apply within thirty days of the date of their marriage.

Effective with the premium for the month of October, 2003, the level of County participation in the cost of group health premiums shall be 90% of the premium for single, double or family coverage for any of the plans offered by the County and for which an employee may be eligible. Effective with the October 1, 2010, premium, the County will contribute the following amounts to the cost of each employee's monthly group health insurance premium:

- A. For those employees participating in any Network Health Insurance Plan offered by the County, an amount equal to 85% of the monthly premium amount of Network Health Insurance Plan 2. The contribution by the County shall be increased to 90% of the monthly premium of Network Health Insurance Plan 2 if the employee and his or her spouse complete an annual Health Risk Assessment offered by the County on or before September 1 of each year.
- B. For those employees participating in any UMR Health Insurance Plan offered by the County, an amount equal to 85% of the monthly premium amount of UMR Health Insurance Plan 2. The contribution by the County shall be increased to 90% of the monthly premium of UMR Health Insurance Plan 2 if the employee and his or her spouse complete an annual Health Risk Assessment offered by the County on or before September 1 of each year.
- C. Employees and their spouses must have the Health Risk Assessment performed on or before September 1, 2010, to be eligible for the 90% premium contribution for the October 1, 2010, Plan Year.
- D. The Health Risk Assessment requirements described in Paragraphs A through C above shall not apply to spouses who are not covered under a Winnebago County sponsored health insurance plan.

Regular part-time employees shall receive the same benefit on a pro-rata basis. Required employee premium contributions may be processed through payroll deductions and shall be eligible for special treatment under Section 125 of the Internal Revenue Code.

Terminated employees may continue their participation in the group health program in accordance with the COBRA law. Such employees are normally advised of their group health options and contribution requirements at the time of termination.

Employees who retire from County employment and are immediately eligible for a pension under the Wisconsin Retirement System shall have the option of continuing their participation, and that of their spouse and eligible dependents, in any of the group health insurance programs offered by Winnebago County, at their expense, for up to the number of years that they continuously served Winnebago County or until both the employee and spouse have attained the age of sixty-five, whichever affords the longer time frame, but not less than the amount of time provided for under the COBRA Law. This eligibility shall also apply to the spouse and eligible dependents of an employee who dies while employed by Winnebago County.

RESOLUTION NO. 71-62010: Adopt Revisions to the Winnebago County Administrative Salary Schedule

WHEREAS, the salaries of Winnebago County's non-represented employees have not kept pace with unionized employees of Winnebago County in recent years; and

WHEREAS, it is in the best interests of Winnebago County that the salaries of non-represented employees keep pace with that of unionized employees in order to attract and maintain qualified managerial and supervisory employees throughout Winnebago County departments.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes that the Winnebago County Administrative Salary Schedule shall be amended so as to increase by 1.5% across the board, effective January 1, 2010, the wages of covered employees having continuing satisfactory job performances. Employees who terminate their employment with Winnebago County on or before June 16, 2010, except if such termination is due to the retirement, declared disability by Wisconsin Retirement System, or death of the employee, shall not be entitled to any retroactive pay or benefits.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that the attached list of proposed improvements are in the best interests of Wittman Regional Airport.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that this governing body contemplates requesting federal and/or state aid for the projects listed on the attached schedule of airport improvements.

RESOLUTION NO. 73-62010: Adopt Policy Regarding Dental Insurance for Married Couples with Both Spouses Employed Full-Time by Winnebago County

WHEREAS, the cost of dental insurance has become increasingly burdensome for Winnebago County and its employees in recent years; and

WHEREAS, it has been a past practice that married couples having both spouses employed by Winnebago County have made no contribution to their dental insurance premiums, and it is in the best interests of Winnebago County that all employees share in the cost of dental insurance and be treated uniformly.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby creates a policy that married couples having both spouses employed by Winnebago County shall receive no reduction in monthly employee contributions for dental insurance premiums.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said change in dental insurance contributions for married couples employed by Winnebago County shall become effective as of October 1, 2010 (with the payroll deduction for October 1, 2010, dental insurance coverage occurring in September 2010).

RESOLUTION NO. 74-62010: Petition the Secretary of Transportation for Airport Improvement Aid

WHEREAS, Winnebago County, Wisconsin, hereinafter referred to as the Sponsor, being a municipal Body Corporate of the State of Wisconsin, is authorized by law (§ 114.11, Wis. Stats.) to acquire, establish, construct, own, control, lease, equip, improve, maintain, and operate an airport; and

WHEREAS, the Sponsor desires to develop or improve the Wittman Regional Airport, Winnebago County, Wisconsin; and

WHEREAS, airport users have been consulted in formulation of the improvements included in this Resolution; and

WHEREAS, a public hearing was held prior to the adoption of this petition in accordance with § 114.33(2) as amended, and a transcript of the hearing is transmitted with this petition.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes that the Sponsor of said petition for Federal and/or State Aid in the following form is hereby approved:

The petitioner, desiring to sponsor an airport development project with Federal and State Aid or State Aid only, in accordance with the applicable State and Federal laws, respectfully represents and states as follows:

- 1. That the airport, which it is desired to develop, should generally conform to the requirements for a general aviation-type airport as defined by the Federal Aviation Administration.
- 2. That the character, extent, and kind of improvements desired under the project are as follows: purchase snow removal equipment; purchase turf mowing equipment; reconstruct terminal area ramps and Taxiway E; reconstruct Taxiway D ramp; repair ramp pavement; develop/expand hangar areas, including hangar removal; install/replace airport perimeter fencing; reconstruct Runway 4/22, Runway 13/31, and Taxiway C; relocate and reconstruct Taxiway B; acquire land near/in runway approaches as stated in Transportation Administrative Code Chapter 55; and any necessary related work.
- 3. That the airport project, which your petitioner desires to sponsor, is necessary for the following reasons: to meet the existing and future needs of the airport.

WHEREAS, it is recognized that the improvements petitioned for as listed will be funded individually or collectively as funds are available, with specific project costs to be approved as work is authorized, the proportionate cost of the airport development projects described above, which are to be paid by the Sponsor to the Secretary of the Wisconsin Department of Transportation (hereinafter referred to as the Secretary) to be held in trust for the purpose of the project; any unneeded and unspent balance after the project is completed is to be returned to the Sponsor by the Secretary; the Sponsor will make available any additional monies that may be found necessary, upon request of the Secretary, to complete the project as described above; the Secretary shall have the right to suspend or discontinue the project at any time additional monies are found to be necessary by the Secretary, and the Sponsor does not provide the same; and

WHEREAS, the Sponsor is required by law (§ 114.32(5), Wis. Stats.) to designate the Secretary as its agent to accept, receive, receipt for, and disburse any funds granted by the United States under the Federal Airway Improvement Act, and is authorized by law to designate the Secretary as its agent for other purposes.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors on behalf of the Sponsor that the Secretary is hereby designated as its agent and is requested to agree to act as such in matters relating to the airport development project described above, and is hereby authorized as its agent to make all arrangements for the development and final acceptance of the completed project whether by contract, agreement, force account, or otherwise; and particularly to accept, receive, receipt for, and disburse Federal monies or other monies, either public or private, for the acquisition, construction, improvement, maintenance, and operation of the airport; and to acquire property or interests in property by purchase, gift, lease, or eminent domain under Chapter 32 of the Wisconsin Statutes; and to supervise the work of any engineer, appraiser, negotiator, contractor, or other person employed by the Secretary; and to execute any assurances or other documents required or requested by any agency of the Federal government and to comply with all Federal and State laws, rules, and regulations relating to airport development projects.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Sponsor requests that the Secretary provide, per § 114.33(1)(a), Wis. Stats., that the Sponsor may acquire certain parts of the required land or interests in land that the Secretary shall find necessary to complete the aforesaid project.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Sponsor agrees to maintain and operate the airport in accordance with certain conditions established in Chapter Trans 55, Wisconsin Administrative Code, or in accordance with Sponsor assurances enumerated in a Federal Grant Agreement.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Winnebago County Executive and the Wittman Regional Airport Director be authorized to sign and execute the Agency Agreement and Federal Block Grant Owner Assurances authorized by this Resolution.
