# WINNEBAGO COUNTY BOARD MEETING TUESDAY, NOVEMBER 13, 2012

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

# REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Finch reported on his attendance at the state's Parks Convention. He stated that it was one of the best conventions he has attended because of the broad scope of the convention. They presented information on Human Resources; marketing parks and their facilities; park consolidations, etc.

Supervisor Norton stated that he also attended the Parks Convention and agreed that there was a wide range of topics at the convention. He attended a presentation on how the booming aging population is affecting counties' costs for the care and housing.

Supervisor Norton stated that Mark Weisensel of the Human Services Department is looking for opportunities to present information about the county's Aging and Disability Resource Center (ADRC) to various groups or organizations. If anyone has any suggestions or contacts, they should contact Supervisor Norton.

Supervisor Kline stated that the Legislative Committee will be meeting on Monday, November 26.

Motion by Supervisor Robl and seconded to approve the proceedings from the October 16 and October 29 & 30, 2012 meetings. Supervisor Singstock asked that the final approved budget amount be added to the October 29 & 30 proceedings after the passage of Resolution No. 104-102012, "Adopt 2013 Annual Budget." CARRIED BY VOICE VOTE to approve as corrected.

#### **COUNTY EXECUTIVE'S REPORT**

Executive Harris distributed information on the county's options in regards to the Tri-County Ice Arena. He will be making an official report on this at a future meeting.

Executive Harris stated that the county has received the deed for Outagamie County's portion of the ice arena. We will be sending them their \$1.00 check for the property and recording the deed in the near future.

Executive Harris wanted the Board to know that an article in the Oshkosh Northwestern about the county's 2013 Budget erroneously noted that the county's tax levy is going up, when it is actually going down. He explained that the error occurred because they were using the wrong figures when they made their calculations.

Executive Harris then explained that on Page 42 of the 2013 Budget book there is apportionment information that shows how much of the levy is apportioned to each municipality in the county. However, he explained that the information on Page 42 doesn't necessarily translate into the percentage change for individual residents' tax rates. There are other factors that will affect those tax rates.

Executive Harris recommended that the Board approve the following Resolutions that appear on tonight's agenda:

**RESOLUTION NO. 111-112012:** 

Authorize Health Department to Accept a \$57,735 State Department of Children and Families Grant and Apply to Program Expenses for Assisting Refugees Who Have Resettled in Winnebago County.

WHEREAS, the Oshkosh World Relief Organization is resettling about 100 refugees to the Oshkosh area; and WHEREAS, the State of Wisconsin, Department of Children and Families, is making funds in the amount of \$57,735 available to the Winnebago County Health Department for the purpose of providing services to newly-arriving refugees in the Oshkosh area; and

WHEREAS, these refugees need assistance in obtaining health screening and with being linked with necessary medical providers; and

WHEREAS, the grant funding will allow public health representatives to meet with refugees and conduct screenings for various communicable diseases, and provide interpreters when necessary; and

WHEREAS, it would be in the best interests of Winnebago County to accept this grant and utilize the funds to provide services identified as part of the program.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Public Health Department to accept grant funding in the amount of \$57,735 for the purpose of providing services as described above.

**RESOLUTION NO. 112-112012:** 

Authorize the Transfer of \$40,000 from the Highway Department's Fund Balance to the Capital Outlay Account of the Highway Satellite Shop Capital Project Fund to Cover Additional Project Costs

WHEREAS, the Highway Department Satellite Shop Capital Project has exceeded its budgeted limit by roughly \$40,000; and

WHEREAS, due to poor soil conditions, the project incurred additional costs; and

WHEREAS, as the project progressed, it was believed that savings in other areas would cover the additional costs: and

WHEREAS, as the project neared completion, it was determined that there would not be sufficient savings from other areas; and

WHEREAS, the project could not be halted or additional costs would have been incurred; and WHEREAS, the project has gone over budget by roughly \$40,000.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$40,000 from the Highway Department's Undesignated Fund Balance to be transferred to the Satellite Shop Capital Project Fund to cover the additional incurred costs.
