# WINNEBAGO COUNTY BOARD MEETING TUESDAY, JULY 16, 2013

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Locke.

### REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Eisen reported on the WCA Judicial and Public Safety Committee meeting that he attended July 12, 2013 in Madison. David Calendar, WCA Legislative Associate spoke in regard to the August 23 symposium on "Treatment Alternatives to Incarceration and Diversion from Prosecution". He spoke in regard to the impact of DNA collection law that will become effective February 1, 2015. Mr. Calendar feels that the trend to expand prisons has run it's course, and that this program will replace that.

Supervisor Brennand reported that there will be a Legislative Committee meeting on Monday, July 22, 2013 at 8:30 a.m.

Supervisor Finch reported that he attended Lifest. He received numerous compliments on the county's facilities and grounds. Mr. Finch highly commended Loren Dieck, Assistant Parks Director, for his hard work and dedication to making sure everything ran smoothly for this event. There were a few electrical malfunctions, but Loren was there to fix them.

Supervisor Norton reported that he received phone calls from Supervisors regarding the air conditioning at Court Tower in the City of Oshkosh. Supervisor Norton contacted Doug Gieryn, Public Health Director, in regard to cooling stations for residents of Court Tower. The location of the cooling sites are on the Public Health's website. Mr. Norton informed the board that there is an opening on the Winnebago County Housing Authority Board. He would like to see that position filled by someone from one of the county's townships.

Supervisor Lautenschlager would like to thank the Parks Department Director and staff for the beautiful job they did in restoring the bathing beach and shelter at the County Park. His family attended a function there and

relatives were commenting on how nice it was and would consider holding a wedding at the site. Mr. Lautenschlager passed out brochures in regard to the pavilion.

Supervisor Egan reported that the Winnebago County Fair will be held August 6-11. He stated that the Board would be receiving a letter from the Fair Association inviting them and a guest to attend the fair. He strongly encouraged everyone to come and see the projects that the youth, as well as seniors, are able to create.

### **RESOLUTIONS AND ORDINANCES**

RESOLUTION 234-72013: Authorize the Public Health Department to Accept a \$37,133 Refugee Health Grant and Apply the Funds to Expenses to Carry Out the Program Objectives.

WHEREAS, the Public Health Department has a Refugee Health Program that is funded from State grant funds; and

WHEREAS, the Public Health Department has been awarded an additional \$37,133 for Program expenses for 2013; and

WHEREAS, the purpose of the Program is to conduct health assessments on incoming refugees to Winnebago County; and

WHEREAS, refugees are also given direction and assistance to obtain health care services; and WHEREAS, it would be beneficial to the citizens of Winnebago County to accept and continue to support and conduct this Program.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Public Health Department to accept additional state funding of \$37,133 and apply the funds to the following accounts to carry out the Refugee Health Program: Regular Pay (\$36,933); and Medical Supplies (\$200) for a total of \$37,133.

WHEREAS, your Public Health Department has been awarded a Wisconsin Partnership Program Grant of \$40,290; and

WHEREAS, the purpose of the grant is to develop and evaluate an updated sexual health curriculum in the middle schools of Winnebago County; and

WHEREAS, the purpose of the Program is to reduce the occurrences of sexually transmitted diseases longterm and to increase knowledge of sexual health in the short term; and

WHEREAS, it would be beneficial to the citizens of Winnebago County to accept and institute this Program. NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Public Health Department to accept a \$40,290 Wisconsin Partnership Grant and apply the funds to the following accounts to carry out the objectives of the Program: Regular Pay (\$27,290); Other Contracted Services (\$6,000); and Other Operating Supplies (\$7,000), for a total of \$40,290.

**RESOLUTION 236-72013:** 

Support Legislative Changes So As to Reduce the Number of Non-Violent Offenders Sentenced to Jail or Prison for Alcohol and/or Other Drug Issues

WHEREAS, a year-long study conducted by Human Impact Partners, from October 2011 through October 2012, has shown that treatment instead of incarceration for non-violent offenders who suffer from alcohol and other drug-related issues, as well as those who suffer from mental health issues, is much more effective and is four times more cost effective; and

WHEREAS, mental illness and substance abuse are public health issues that are not best solved through incarceration: and

WHEREAS, it is in the best interests of the citizens of Winnebago County and the State of Wisconsin that a justice system be designed that does not simply punish and diminish individuals with alcohol, drug, and mental health issues, but restores the offenders to a productive role in our society while providing wholeness to victims of their crimes: and

WHEREAS, Treatment Alternative Diversion programs (TAD), which are already in place in Winnebago and other counties in Wisconsin, have proven effective in reducing recidivism rates and in restoring the offender to health, thus resulting in a savings of tax dollars and conserving resources for other vital needs in challenging economic times; and

WHEREAS, the incarceration rate in costs of corrections in Wisconsin has risen from less than 2 million dollars per year in 1990, to more than 1.3 billion dollars per year in 2011. A reduction in the rate of the number of individuals incarcerated in the Wisconsin Prison System to 11,000 inmates, which was the number incarcerated in 1995, would yield substantial cost savings and would place the per capita rate of incarceration in Wisconsin similar to neighboring

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby requests local state officials, legislators, and the governor to reexamine the policies which have led to historically high incarceration rates in the State of Wisconsin and to amend State laws so as to result in a substantial reduction in the number of low-risk, non-violent offenders in Wisconsin jails and prisons.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that these changes should include significant financial incentives for fewer individuals to be incarcerated in state prisons and a substantial increase in dedicated funding from the State to counties to enable significant growth and cost-effective, innovative, and proven local alternatives for non-violent and low-risk offenders.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Winnebago County Clerk transmit a copy of this Resolution to all legislators representing constituents in Winnebago County, the Wisconsin Counties Association, the Office of Governor Scott Walker, and all county boards within the State of Wisconsin.
