Supervisor Maribeth Gabert thanked all the Supervisors that attended the virtual meeting of the Open House for the Airport Master Plan.

Supervisor Brian Defferding reported on the National Counties Association Judiciary and Public Safety Steering Committee meeting. They had a webinar regarding the efforts in decarceration of jails. Oklahoma County has created a nine-person committee to take over the responsibilities of their jail and taking that responsibility away from the Sheriff.

COUNTY EXECUTIVE'S REPORT

Executive Harris announced that two courts have made decisions declining additional names being placed on the ballot for the Presidential race. The County Clerk's office will be delivering ballots to the municipal clerks to begin their absentee procedures. COUNTY BOARD CHAIRMAN'S REPORT

Chairman Ramos reported that Supervisors Warnke, Spellman and Wingren are excused from this meeting. Chairman Ramos noted that the County Board Budget meetings will start on Monday, October 26, 2020. Currently looking at being in the County Board chambers for some staff and Chairman Ramos, and virtually for others.

Chairman Ramos reminded Supervisors that during County Board meetings, especially virtually, no political signs should be displayed on or near your screen. Supervisors should not be calling or texting during the County Board meeting or any other meeting. This could be a violation of the open meetings law.

Director of Finance, Vicky Fitzgerald, announced that the 2021 Executive Budget books will be available on the County's website as of September 21, 2020. The printed copies will be available for pickup on October 5, 2020 from the County Clerk's office.

Corporation Counsel, Mary Anne Mueller, reminded the board of what a "walking quorum" is and how it can violate open meeting laws. A walking quorum is: "a series of gatherings among separate groups of members of a

governmental body, each less than quorum size, who agree, tacitly or explicitly, to act uniformly in sufficient number to reach a quorum". This includes e-mails back and forth amongst supervisors, texting before or during meetings, or phone calls or discussions before meetings to persuade and have an agreement to vote in a certain manner. The public has the right to be fully informed of governmental business. If violating the open meeting law, you could be fined and that fine will be paid by the Supervisor.

Chairman Ramos reported that the Wisconsin Counties Association has been working on the Public Health Officer authority for the past six weeks. A number of different organizations across the State helped to put this together. RESOLUTION NO. 078-092020:

Support the Implementation of the Winnebago Waterways Lake Management Plan

WHEREAS, the Winnebago Waterways are treasured resources that hold 17 percent of Wisconsin's surface water, supply more than 200,000 people with their drinking water, and provide an estimated \$297 Million in revenue annually from recreational angling in a five (5)-county region; and

WHEREAS, the Winnebago System has been showing signs of stress, and both the United States Environmental Protection Agency and the Wisconsin Department of Natural Resources have listed all four lakes as impaired for excessive phosphorus, sediment, low dissolved oxygen, and excess algae growth; and

WHEREAS, since 2010, a collaborative process to create the Winnebago Waterways Program to improve the Winnebago System has been ongoing with funding from the partnering counties of Calumet, Fond du Lac, and Winnebago, along with additional leadership by the Fox-Wolf Watershed Alliance; and

WHEREAS, after three (3) years of intensive research and significant input from the Winnebago Waterways Committee, Land Conservation Committee, and Land and Water Conservation Departments from Calumet, Fond du Lac, Waushara, and Winnebago Counties; the Department of Natural Resources; local governments; area organizations; property owners; and residents, the Winnebago Waterways Lake Management Plan was developed; and

WHEREAS, the Winnebago Waterways Committee, established by the Winnebago County Board of Supervisors, Resolution Number 173-72017: Approve Intergovernmental Cooperation Agreement Creating the "Winnebago Waterways Committee," also supports the implementation of the Winnebago Waterways Lake Management Plan; and WHEREAS, this Plan will leverage grant dollars and serve as a guide for strategic management of the Winnebago System, and focus the coordinated efforts of multiple agencies, organizations, and individuals working to meet water quality and pollution reduction targets over a 20-year time frame.

NOW, THEREFORE, BEITRESOLVED by the Winnebago CountyBoard of Supervisors that it hereby supports the implementation of the Winnebago Waterways Lake Management Plan.

RESOLUTION NO. 079-092020: Authorize Borrowing of an Amount Not to Exceed \$11,500,000, and Authorize the Issuance and Sale of General Obligation Promissory Notes as Evidence of Indebtedness

WHEREAS, the County Board of Supervisors of Winnebago County, Wisconsin (the "County") hereby finds and determines that it is necessary, desirable, and in the best interest of the County to raise funds for the purpose of paying the cost of constructing, remodeling, demolishing, and improving roads, highways, bridges, buildings, and sites, including projects at the University of Wisconsin Oshkosh-Fox Cities campus and airport projects, and acquiring and installing furnishings, fixtures, and equipment (the "Project"), and there are insufficient funds to pay said costs; and

WHEREAS, the Winnebago County Board of Supervisors hereby finds and determines that the Project is within the County's power to undertake and therefore serves a "public purpose" as that term is defined in §67.04(1)(b), Wis. Stats.; and

WHEREAS, counties are authorized by the provisions of §67.12(12), Wis. Stats., to borrow money and to issue general obligation promissory notes for such public purposes; and

WHEREAS, the Winnebago County Board of Supervisors hereby finds and determines that general obligation promissory notes in the aggregate amount of not to exceed \$11,500,000 should be issued, and it is now necessary and desirable to authorize their issuance and sale.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that;

Section 1. Authorization of the Notes. For the purpose of paying costs of the Project, there shall be borrowed pursuant to Section 67.12(12) of the Wisconsin Statutes, a principal sum not to exceed ELEVEN MILLION FIVE HUNDRED THOUSAND DOLLARS (\$11,500,000).

Section 2. Sale of the Notes. To evidence such indebtedness, the Chairperson and County Clerk are hereby authorized, empowered and directed to make, execute, issue and sell, on behalf of and in the name of the County, general obligation promissory notes aggregating a principal amount not to exceed ELEVEN MILLION FIVE HUNDRED THOUSAND DOLLARS (\$11,500,000) (the "Notes"). The sale of the Notes shall be negotiated with Robert W. Baird & Co. Incorporated ("Baird"), and the terms of the Notes, including the dating, interest rates, maturity schedule and other details with respect to the Notes, shall be subject to approval by subsequent resolution of the County Board of Supervisors. There hereby is levied on all the taxable property in the County a direct, annual tax in such years and in such amounts as are sufficient to pay when due the principal and interest on the Notes.

Section 3. Official Statement. The County Clerk shall cause an Official Statement concerning this issue to be prepared by Baird. The appropriate County officials shall determine when the Official Statement is final for purposes of Securities and Exchange Commission Rule 15c2-12 and shall certify said Statement, such certification to constitute full authorization of such Statement under this resolution.

Section 4. Conflicting Resolutions; Severability; Effective Date. All prior resolutions, rules or other actions of the County Board of Supervisors or any parts thereof in conflict with the provisions hereof shall be, and the same are, hereby rescinded insofar as the same may so conflict. In the event that any one or more provisions hereof shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.
