## 1 **RESOLUTION: Accept Town of Menasha Zoning Ordinance** 2 3 4 TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS: 5 WHEREAS, on March 20, 2012, Winnebago County adopted a comprehensive revision of the Town/County 6 Zoning Ordinance, with an effective date of April 29, 2012; and 7 WHEREAS, pursuant to § 60.62, Wis Stats, towns exercising village powers have the authority to adopt zoning ordinances upon failure by the town to approve the comprehensive revision and upon the expiration of one 8 9 year following the county's comprehensive revision; and 10 WHEREAS, the Town of Menasha has notified Winnebago County that the Town of Menasha will not 11 approve Winnebago County's comprehensive revision of the Town/County Ordinance that became effective April 29. 12 2012: and 13 WHEREAS, the Town of Menasha has drafted a local Zoning Ordinance specific to the Town of Menasha; 14 and 15 WHEREAS, the Town of Menasha Planning Commission and the Town of Menasha Board have held the 16 required public hearings to present the proposed Town of Menasha Zoning Ordinance to its citizens; and 17 WHEREAS, on November 14, 2012, the Town of Menasha Planning Commission voted to approve the 18 proposed Town of Menasha Zoning Ordinance and send it to the Town of Menasha Board: and 19 WHEREAS, on December 17, 2012, the Town of Menasha Board voted to approve the proposed Town of 20 Menasha Zoning Ordinance and request that the Winnebago County Board pass a resolution approving the Town of 21 Menasha Zoning Ordinance; and 22 WHEREAS, the Winnebago County Planning and Zoning Committee has recommended that the Winnebago 23 County Board of Supervisors approve the Town of Menasha's proposed comprehensive zoning ordinance, which is 24 posted at the Town's electronic website and is available upon request from the Town of Menasha or from the 25 Winnebago County Zoning Department, and which is incorporated herein by reference. 26 NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby 27 approves the comprehensive Zoning Ordinance for the Town of Menasha.. 28 Respectfully submitted by: 29 PLANNING AND ZONING COMMITTEE 30 Committee Vote: 5-0 31 Vote Required for Passage: Majority of Those Presesnt 32
