285-122013 1 **RESOLUTION:** Transfer \$115,000 to the Miscellaneous Unclassified Cost Center to 2 Cover Overages in the "Labor" and "Other Operating Expense" 3 4 **Categories** 5 TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS: 6 7 WHEREAS, sick leave payouts had previously been charged to individual county departments from which 8 the retired or long-term employee terminated; and 9 WHEREAS, these departments often have budget overruns from when the budgets are prepared because of 10 the difficulty of anticipating terminations or retirements; and 11 WHEREAS, rather than have individual departments over-budget this expense because of its 12 unpredictability, it makes more sense to charge these costs to one cost center; and 13 WHEREAS, the Finance Department changed the accounting for this expense during 2013, yet the budget 14 did not reflect this bookkeeping change; and 15 WHEREAS, it is now necessary to transfer funds from the Salary Contingency Fund to cover this budget 16 overage; and 17 WHEREAS, the "Other Operating Expense" category in the Miscellaneous Unclassified cost center is over 18 budget because of a change in how the Finance Department is accounting for investment management fees; and 19 WHEREAS, these fees were previously netted against investment income in the financial records; and 20 WHEREAS, accounting for the investment management fees separately was desirable so that the Finance 21 Department could track County spending for this service; and 22 WHEREAS, because this bookkeeping change occurred after the 2013 Budget was adopted, the 2013 23 Budget does not reflect this cost in the Miscellaneous Unclassified cost center; and 24 WHEREAS, the 2013 Budget needs to be adjusted to reflect this change.
