3 **RESOLUTION: Authorize the Winnebago County Sheriff's**
4 **Department to Transfer \$10,400 from its**
5 **2011 Regular Pay and Small Equipment**
6 **Account to its 2011 Small Equipment**
7 **Account to Purchase Weapons Racks and**
8 **Other Courtroom Security Equipment**

11 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

13 **WHEREAS**, in 2011 the Winnebago County Board of Supervisors authorized the Sheriff's Department to
14 accept a Firearms Surrender Grant; and
15

16 **WHEREAS**, after the project was completed, there was \$10, 400 remaining of unspent grant funds; and
17

18 **WHEREAS**, the Winnebago County Sheriff's Department recommended to the grant agency other items to
19 be purchased with the remaining funds; and
20

21 **WHEREAS**, these purchases included weapons racks, which are needed, and courtroom security wands,
22 which would enhance courtroom security; and
23

24 **WHEREAS**, the Winnebago County Board of Supervisors believes these purchases would be beneficial;
25 and

27 **WHEREAS**, the grant agency approved these purchases; and

29 **WHEREAS**, the funds need to be moved from labor accounts to small equipment accounts to make the
30 purchases, and this type of transfer of funds requires County Board approval.

33 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of Supervisors that it hereby
34 authorizes the transfer of \$10,400 from the Sheriff's Department's 2011 Labor and Small Equipment Accounts to its
35 2011 Small Equipment Account for the purpose of purchasing weapons racks and courtroom security wands (9) to
36 enhance courtroom security.

39 **BE IT FURTHER RESOLVED** by the Winnebago County Board of Supervisors that the funds will be
40 carried over to 2012 since approval and the purchases could not have occurred prior to the end of 2011.

43 **Fiscal Note:** This Resolution is cost neutral. We are merely shifting the use of the grant funds to another purpose.
